JANUARY 2005

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 615,252 in January 2005, decreasing by 6,212 (-1.0%) from the previous month. Related expenditures totaled \$150,725,212 in January 2005 decreasing approximately \$6.8 million (-4.3%) over December 2004.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,766,730 in January 2005, increasing by 7,380 (+0.4%) over December 2004. Food Stamps expenditures totaled \$179,158,036 in January 2005, decreasing approximately \$1.5 million (-0.8%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For January 2005, SSI recipients (including Mental Hygiene) totaled 629,130 increasing 287 (+0.0%) from the previous month. SSI expenditures in January totaled \$307,301,957 increasing approximately \$2.6 million (+0.8%) from December 2004.

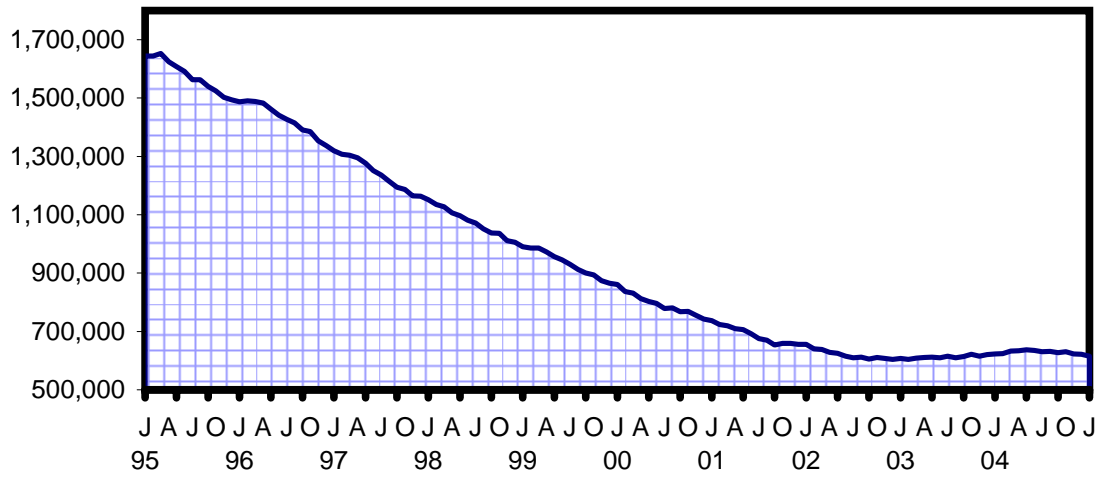

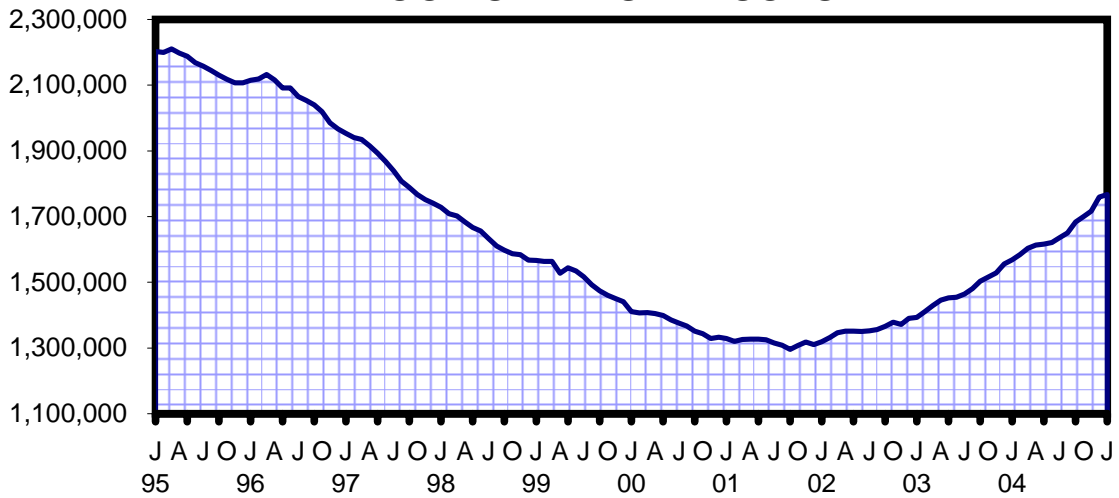

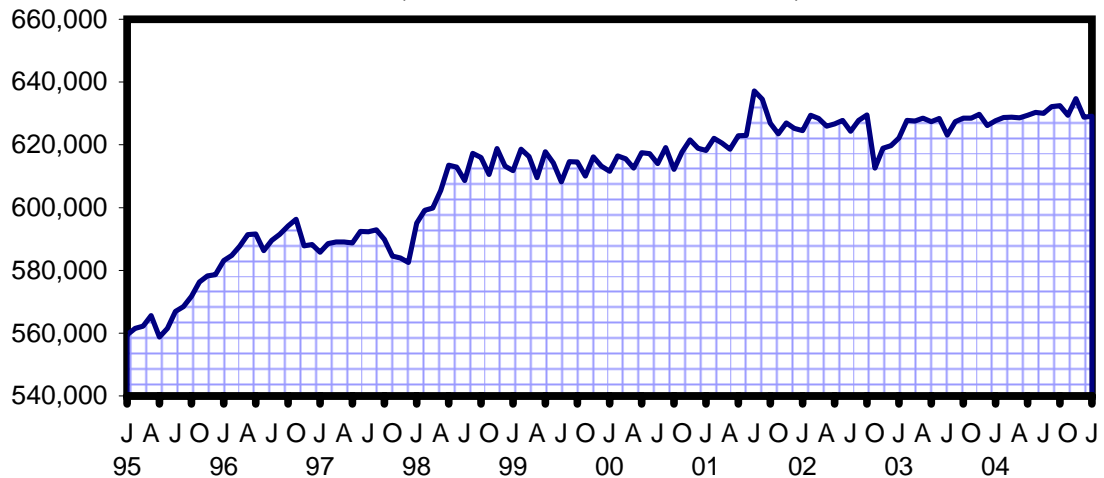
TEMPORARY ASSISTANCE RECIPIENTS
