# Temporary and Disability Assistance Statistics FEBRUARY 2008

---

## Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 515,311 in February 2008, decreasing by 864 (-0.2%) from the previous month. Related expenditures totaled \$158,713,579 in February 2008 decreasing by approximately \$1.9 million (-1.2%) over January 2008.

## Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,927,903 in February 2008, decreasing by 4,119 (-0.2%) over January 2008. Food Stamps expenditures totaled \$210,187,399 in February 2008, decreasing by approximately \$1.3 million (-0.6%) over the previous month.

## Supplemental Security Income

Supplemental Security Income: For February 2008, SSI recipients (including Mental Hygiene) totaled 654,252 increasing 3,699 (+0.6%) from the previous month. SSI expenditures in February totaled \$349,799,362 increasing by approximately \$1.8 million (+0.5%) from January 2008.

**Note: Food Stamp data in this report has been revised since its original publication to reflect retroactive adjustments to New York City, and thus statewide, figures that resulted from reporting changes (see Table 16 for details). New York City monthly average aggregate claims data on Table 23 has also been changed from the original.**

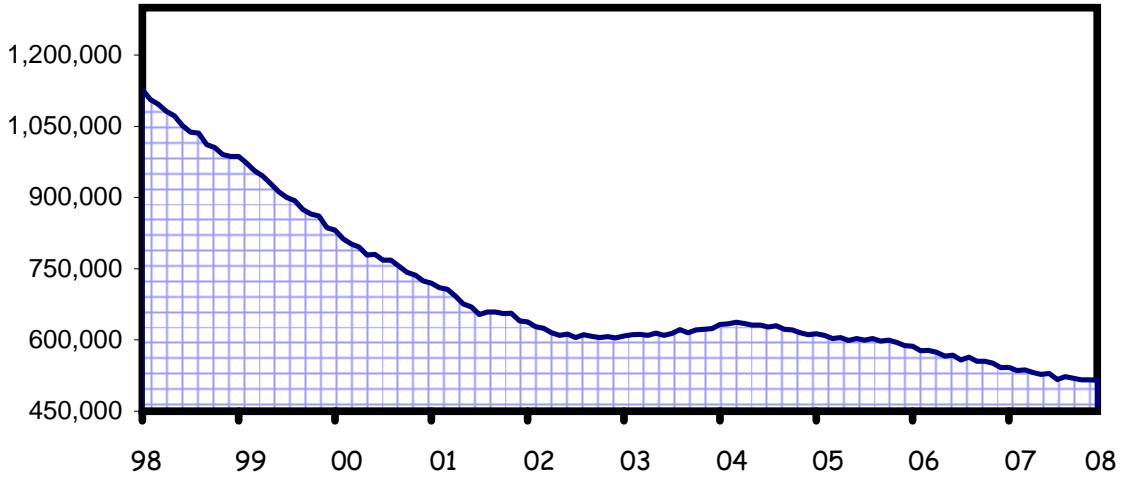

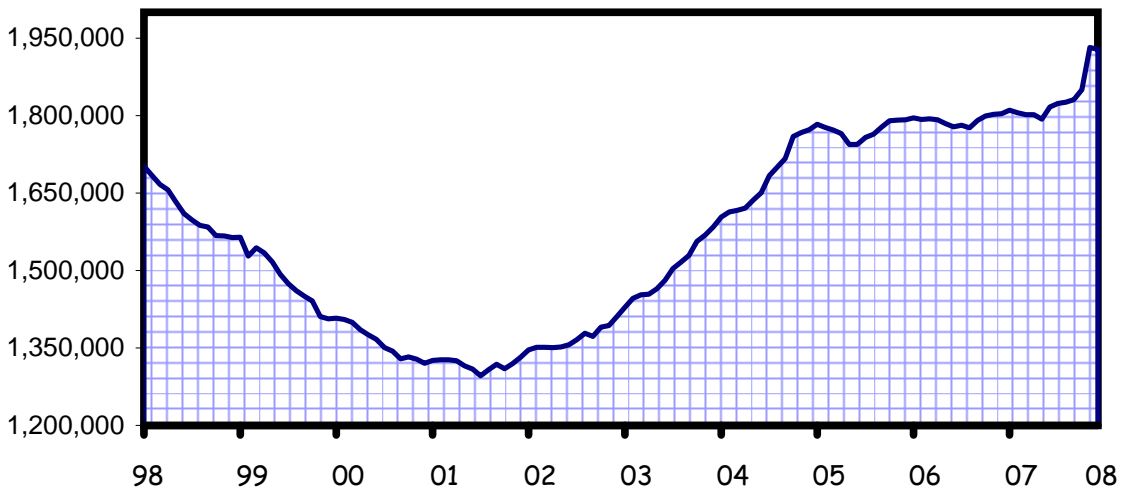

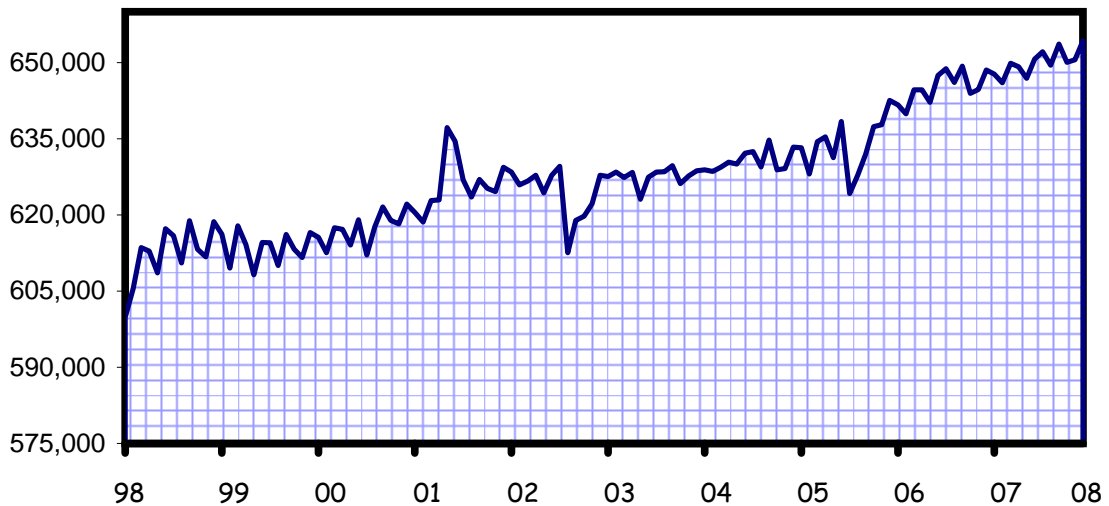
