Temporary and Disability Assistance Statistics August 2008

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 503,627 in August 2008, decreasing by 2,540 (-0.5%) from the previous month. Related expenditures totaled \$154,841,718 in August 2008, decreasing by approximately \$13.3 million (-7.9%) over July 2008.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,051,611 in August 2008, increasing by 20,943 (+1.0%) over July 2008. Food Stamps expenditures totaled \$223,824,233 in August 2008, increasing by approximately \$2.2 million (+1.0%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For August 2008, SSI recipients (including Mental Hygiene) totaled 658,602, increasing by 5,336 (+0.8%) from the previous month. SSI expenditures in August 2008, totaled \$352,934,803 increasing by approximately \$7.6 million (+2.2%) from July 2008.

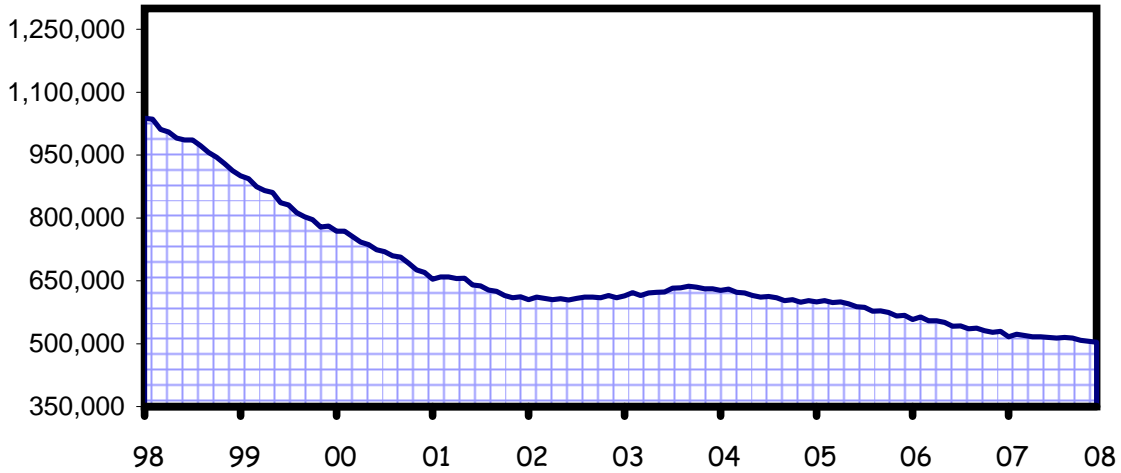

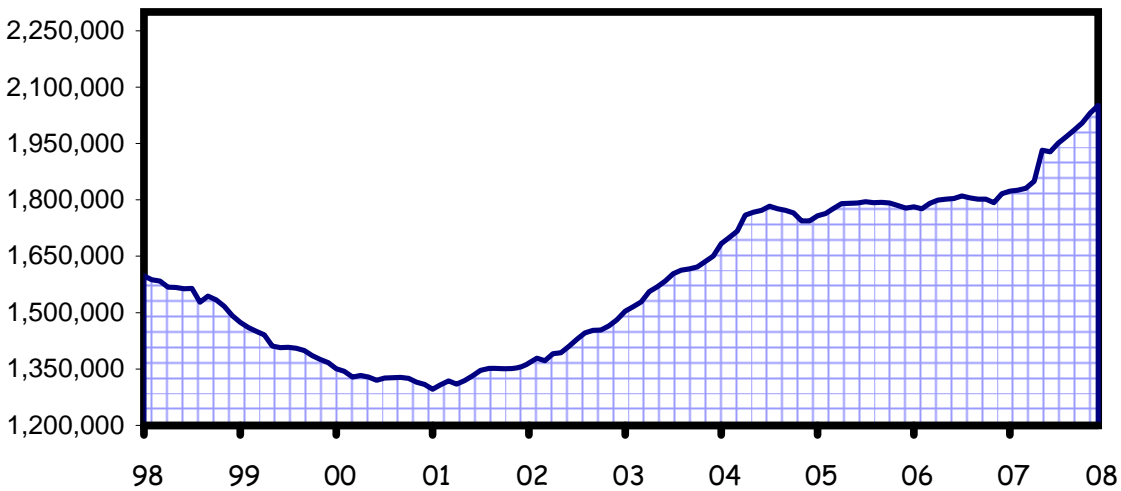

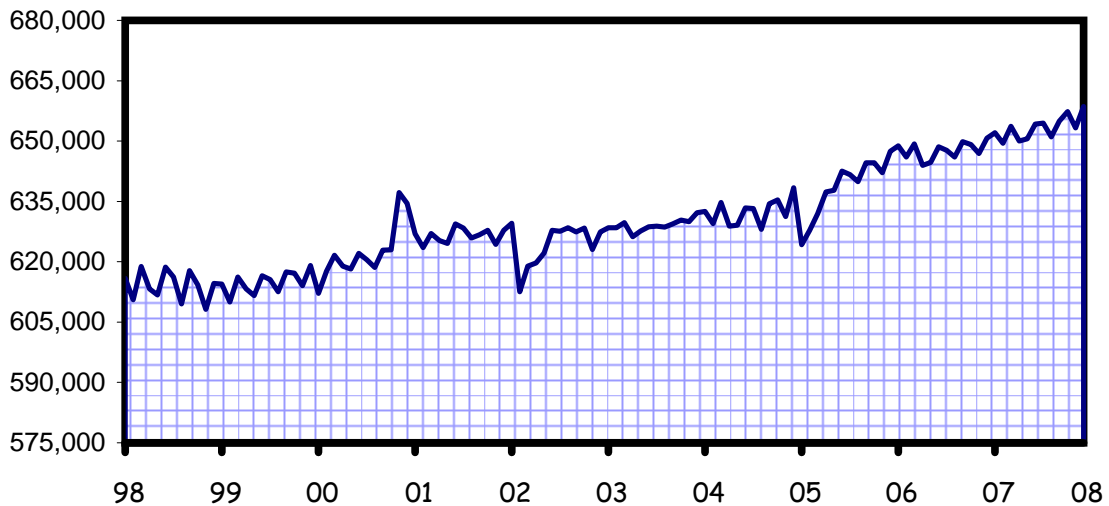
