Temporary and Disability Assistance Statistics

APRIL 2010

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 543,468 in April 2010, decreasing by 5,876 (-1.1%) from the previous month. Related expenditures totaled \$175,310,632 in April 2010, decreasing by approximately \$2.5 million (-1.4%) over March 2010.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,775,875 in April 2010, increasing by 21,243 (+0.8%) over March 2010. Food Stamps expenditures totaled \$420,602,033 in April 2010, increasing by approximately \$1.3 million (+0.3%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For April 2010, SSI recipients (including Mental Hygiene) totaled 672,041 increasing by 6,281 (+0.9 %) from the previous month. SSI expenditures in April 2010 totaled \$378,668,943 increasing by approximately \$3.1 million (+0.8%) from March 2010.

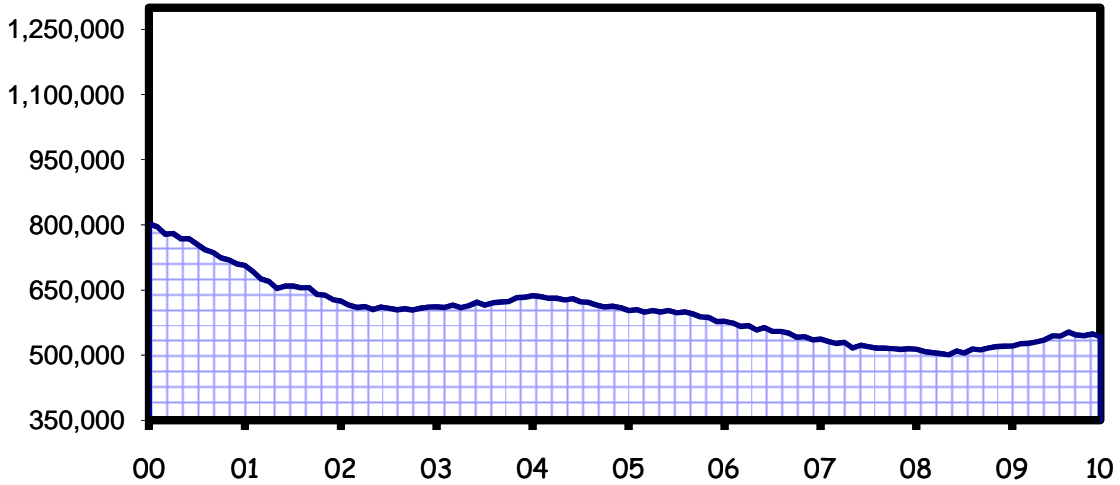

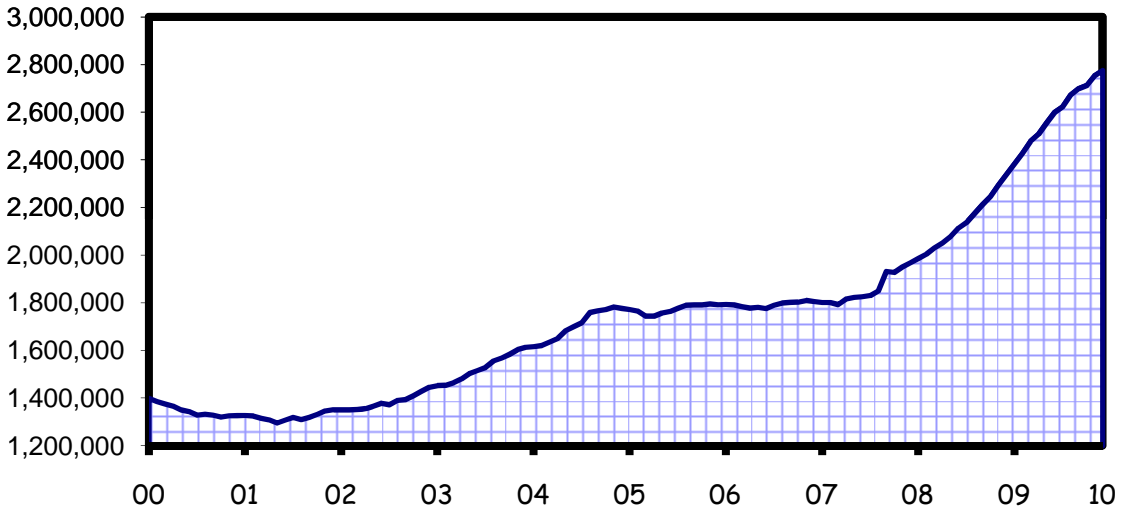

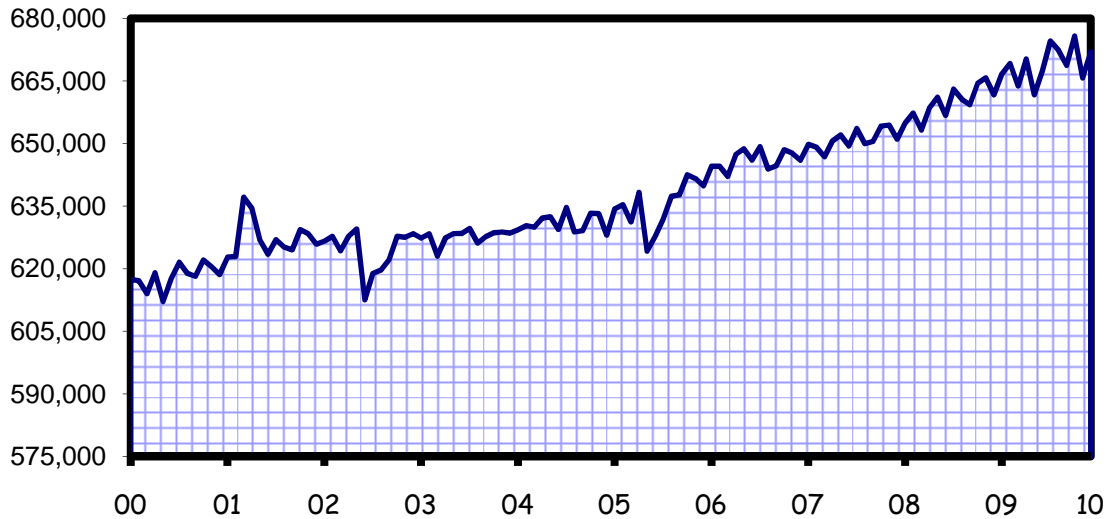
