Temporary and Disability Assistance Statistics **MARCH 2011**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 566,378 in March 2011, increasing by 6,735 (+1.2%) from the previous month. Related expenditures totaled \$186,738,488 in March 2011, increasing by approximately \$10.6 million (+6.0%) over February 2011.

Food Stamps

Food Stamps: Food Stamps recipients totaled 3,013,945 in March 2011, increasing by 38,501 (+1.3%) from the previous month. Food Stamps expenditures totaled \$457,105,553 in March 2011, increasing by approximately \$9.3 million (+2.1%) over February 2011.

Supplemental Security Income

Supplemental Security Income: For March 2011, SSI recipients (including Mental Hygiene) totaled 678,394 decreasing by 11,560 (-1.7%) from the previous month. SSI expenditures in March 2011 totaled \$380,262,427 decreasing by approximately \$13.4 million (-3.4%) over February 2011.

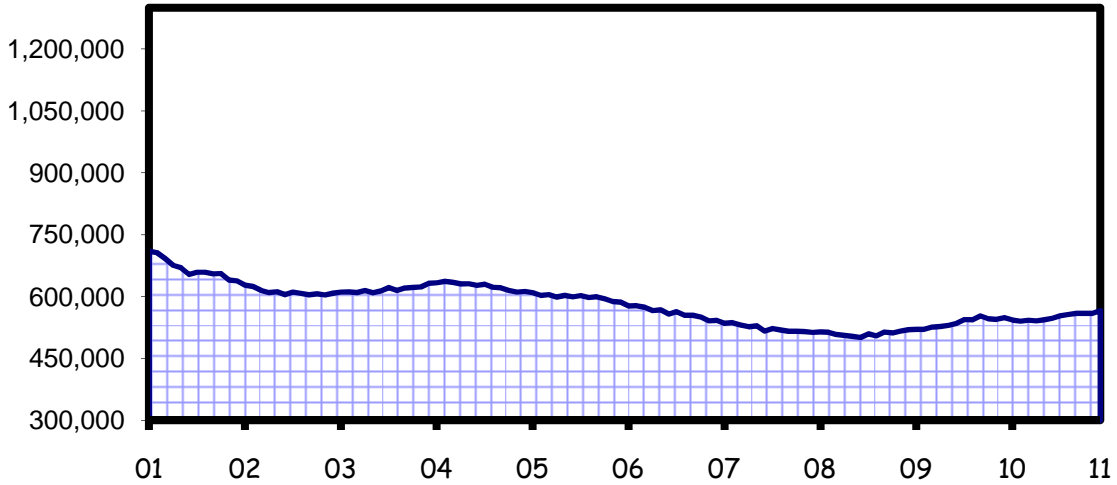

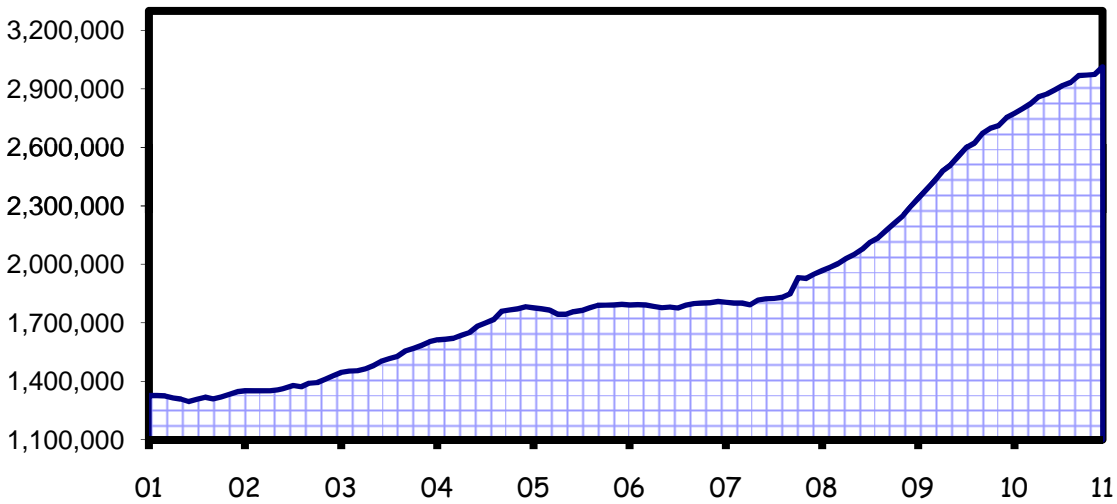

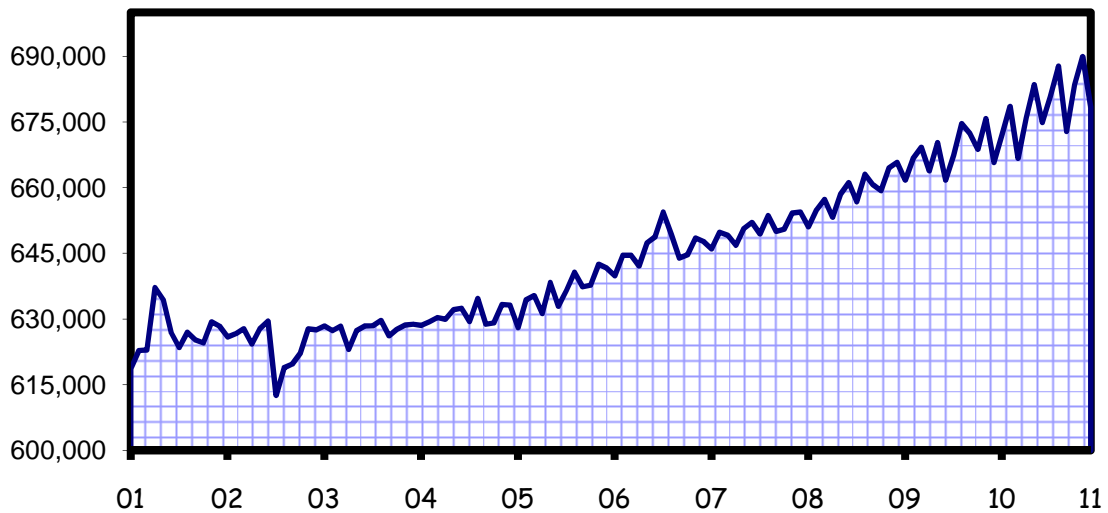
