Temporary and Disability Assistance Statistics

APRIL 2012

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 569,546 in April 2012, decreasing by 3,211 (-0.6%) from the previous month. Related expenditures totaled \$175,208,328 in April 2012, decreasing by approximately \$8.8 million (-4.8%) over March 2012.

Food Stamps

Food Stamps: Food Stamp recipients totaled 3,063,238 in April 2012, decreasing by 18,593 (-0.6%) from the previous month. Food Stamp expenditures totaled \$452,662,295 in April 2012, decreasing by approximately \$9.3 million (-2.02%) over March 2012.

Supplemental Security Income

Supplemental Security Income: For April 2012, SSI recipients (including Mental Hygiene) totaled 693,634 increasing by 8,642 (+1.3%) from the previous month. SSI expenditures in April 2012 totaled \$402,862,563 increasing by approximately \$9.5 million (+2.4%) over March 2012.

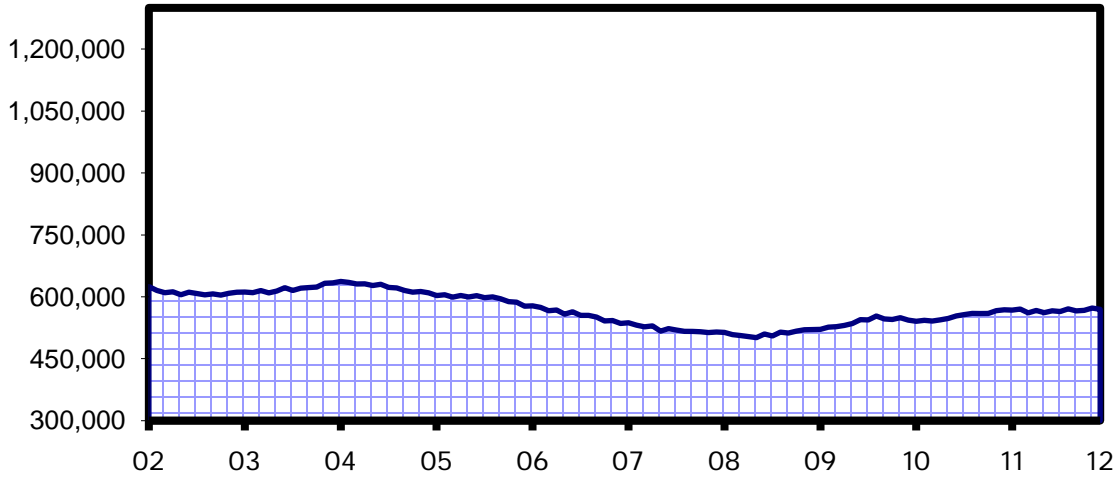

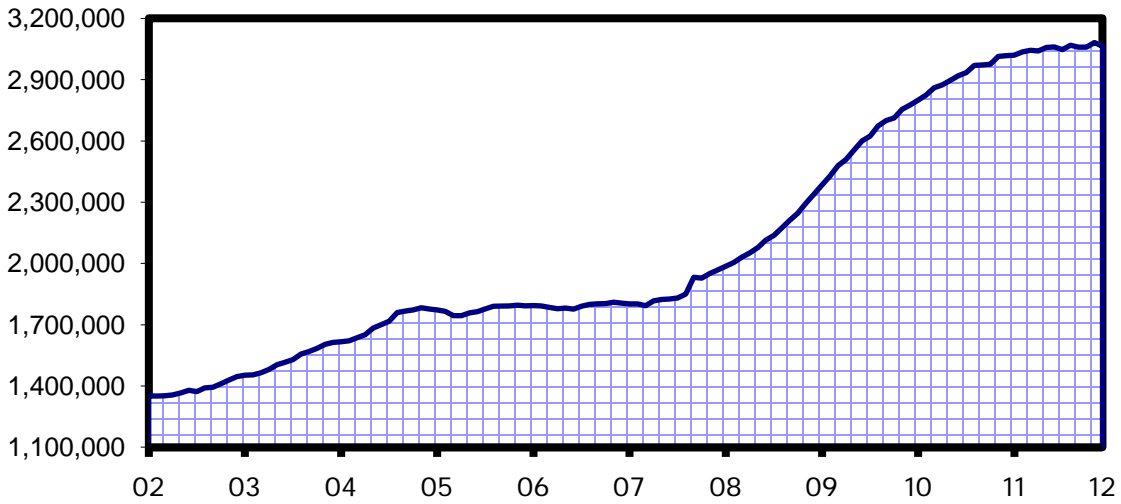

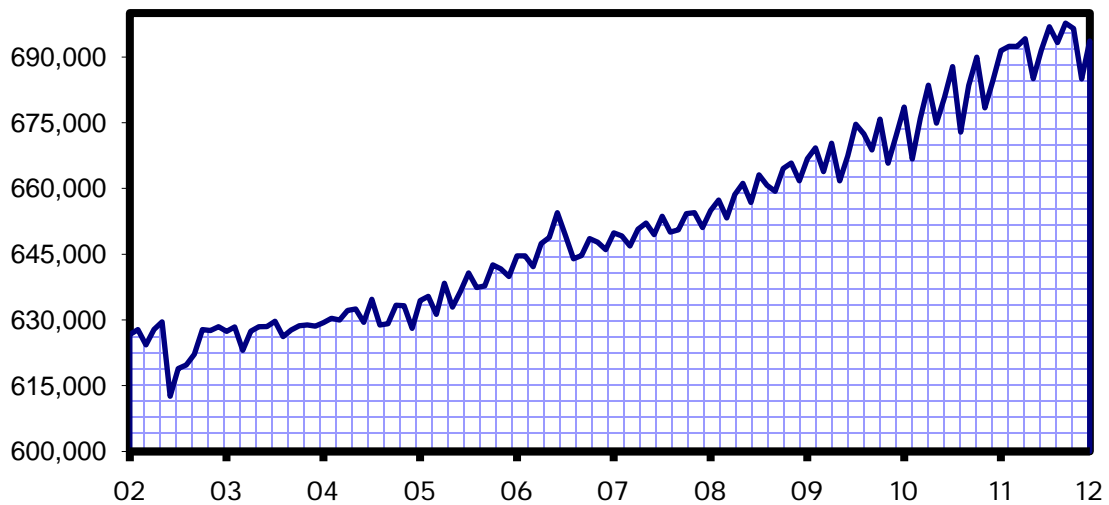
