Temporary and Disability Assistance Statistics **DECEMBER 2012**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 581,005 in December 2012, increasing by 9,701 (+1.7%) from the previous month. Related expenditures totaled \$188,195,856 in December 2012, increasing by approximately \$6.7 million (+3.7%) over November 2012.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program: Supplemental Nutrition Assistance Program recipients totaled 3,186,236 in December 2012, increasing by 34,114 (+1.1%) from the previous month. Related expenditures totaled \$485,025,573 in December 2012, decreasing by approximately \$61.5 million (-11.3%) over November 2012.

Supplemental Security Income

Supplemental Security Income: Supplemental Security Income recipients (including Mental Hygiene) totaled 699,678 in December 2012, decreasing by 2,385 (-0.3%) from the previous month. Related expenditures totaled \$400,859,283 in December 2012, decreasing by \$913,342 (-0.2%) over November 2012.

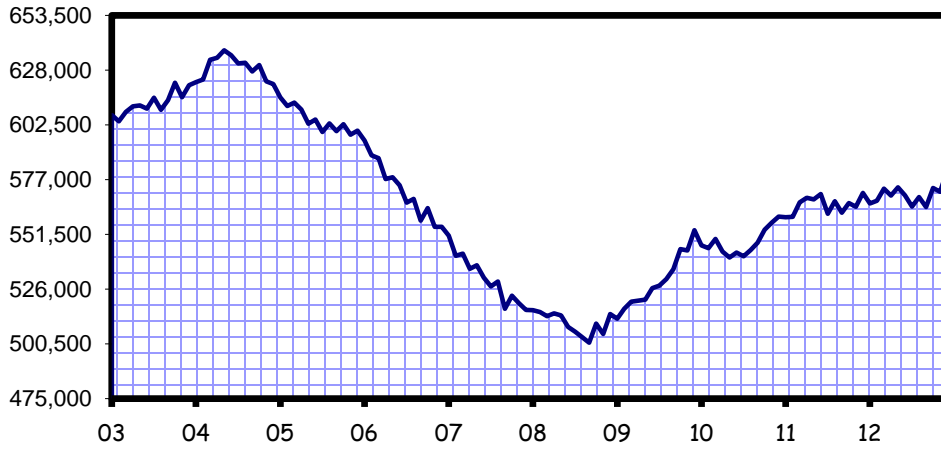

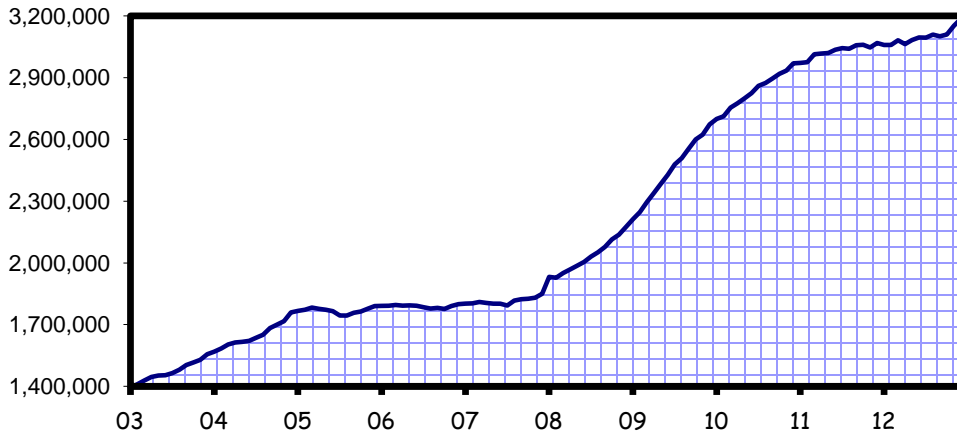

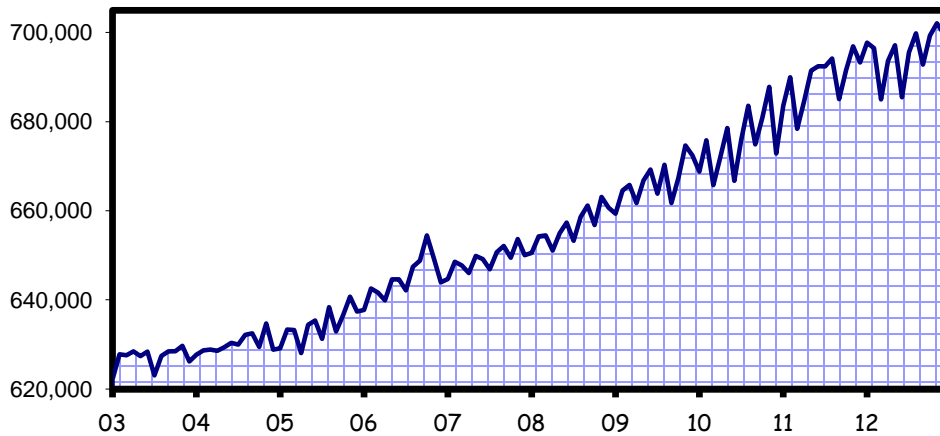
