# Temporary and Disability Assistance Statistics

## **JANUARY 2013**

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 585,685 in January 2013, increasing by 4,680 (+0.8%) from the previous month. Related expenditures totaled \$188,976,992 in January 2013, increasing by \$781,136 (+0.4%) over December 2012.

### Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program: Supplemental Nutrition Assistance Program recipients totaled 3,158,541 in January 2013, decreasing by 27,695 (-0.9%) from the previous month. Related expenditures totaled \$464,083,846 in January 2013, decreasing by approximately \$20.9 million (-4.3%) over December 2012.

### Supplemental Security Income

Supplemental Security Income: Supplemental Security Income recipients (including Mental Hygiene) totaled 703,967 in January 2013, increasing by 4,289 (+0.6%) from the previous month. Related expenditures totaled \$411,597,589 in January 2013, increasing by approximately \$10.7 million (+2.7%) over December 2012.

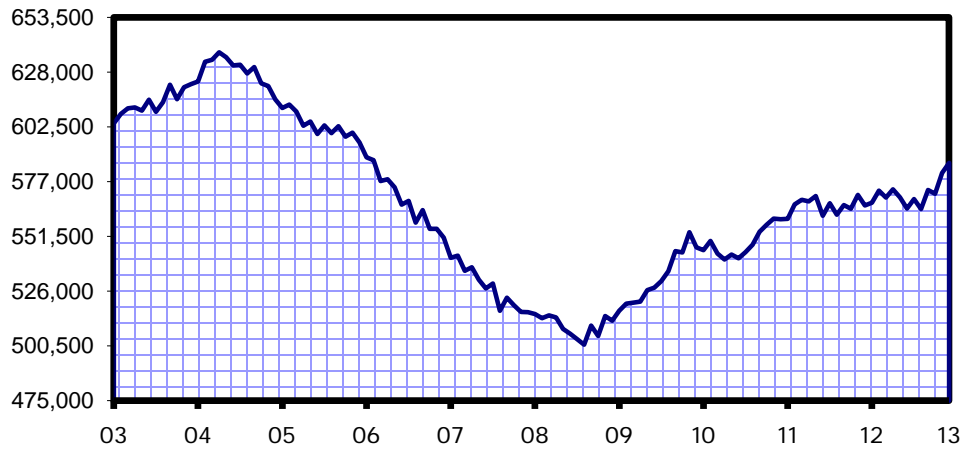

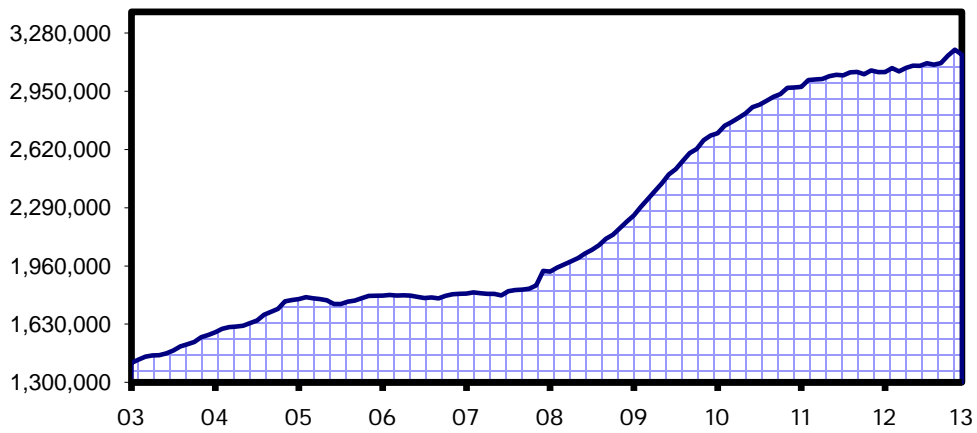

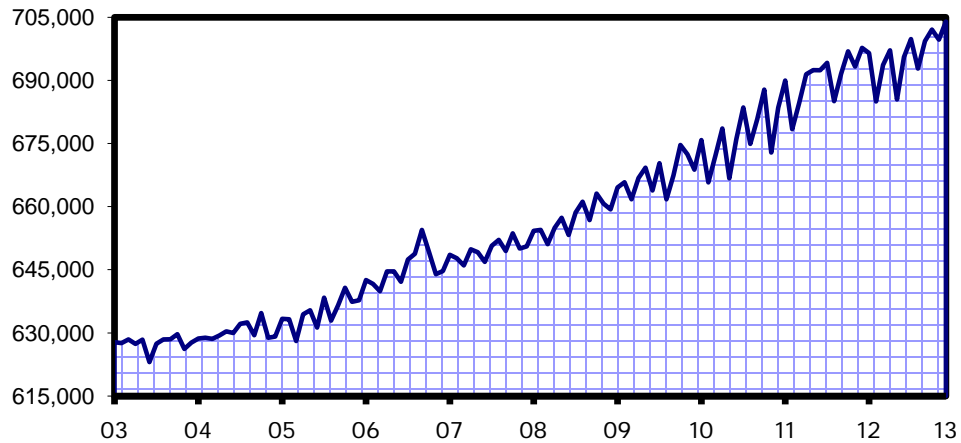
