AUGUST 2014

Temporary Assistance

Temporary Assistance recipients totaled 565,719 in August 2014, increasing by 3,043 (+0.5%) from the previous month. Related expenditures totaled \$184,204,119 in August 2014, increasing by \$869,267 (+0.5%) over July 2014.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program recipients totaled 3,075,125 in August 2014, decreasing by 13,173 (-0.4%) from the previous month. Related expenditures totaled \$422,304,270 in August 2014, decreasing by approximately \$3.4 million (-0.8%) over July 2014.

Supplemental Security Income

Supplemental Security Income recipients (including Mental Hygiene) totaled 701,678 in August 2014, increasing by 4,040 (+0.6%) from the previous month. Related expenditures totaled \$414,014,069 in August 2014, increasing by approximately \$5.4 million (+1.3%) over July 2014.

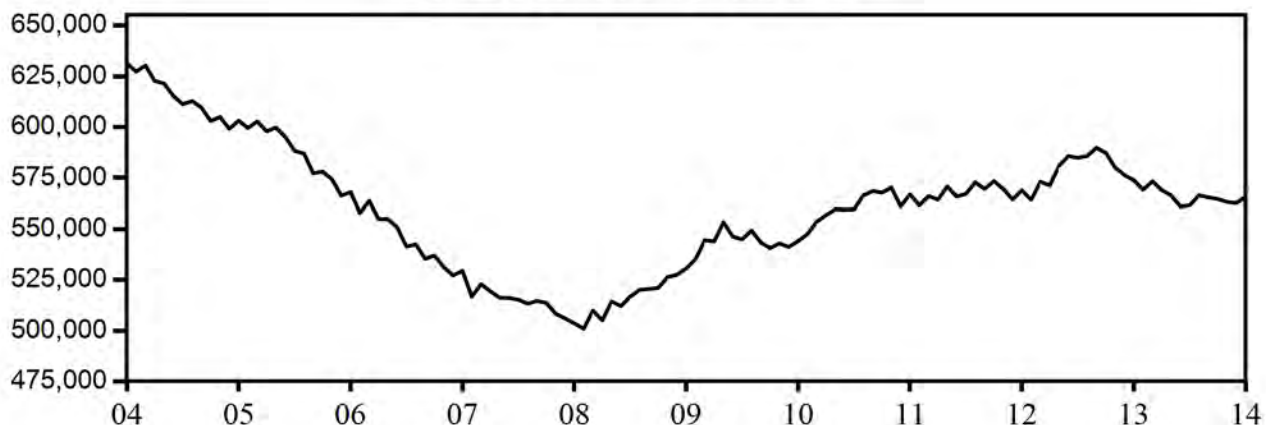

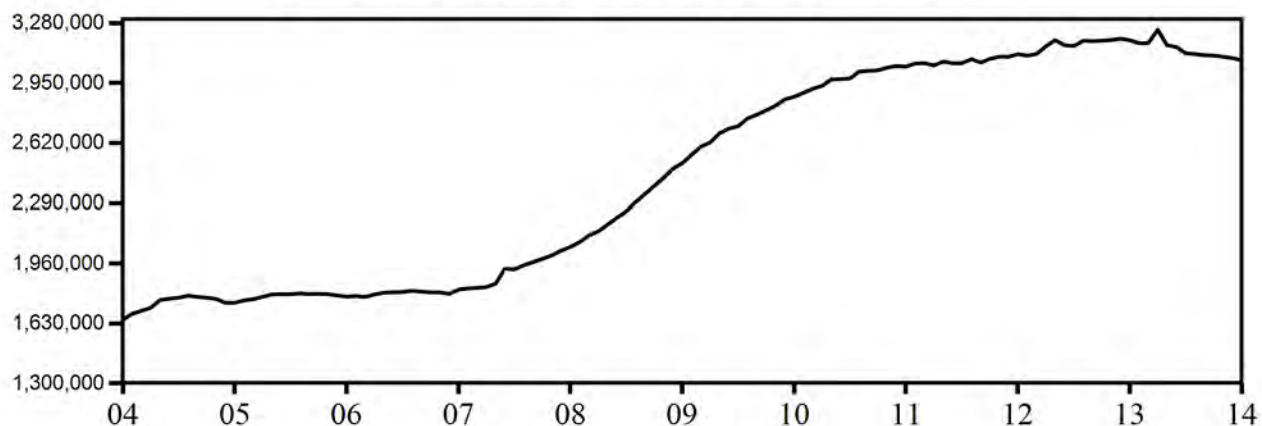

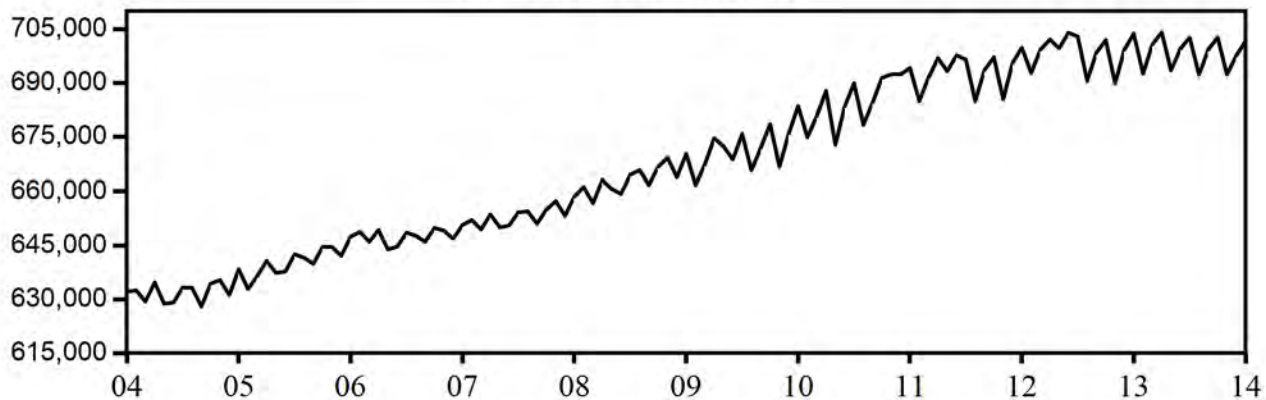
