# Temporary and Disability Assistance Statistics

## August 2006

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 567,983 in August 2006, increasing by 1,720 (+0.3%) from the previous month. Related expenditures totaled \$157,987,024 in August 2006, increasing by approximately \$8.7 million (+5.8%) over July 2006.

### Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,778,070 in August 2006, decreasing by 6,525 (-0.4%) over July 2006. Food Stamps expenditures totaled \$188,982,762 in August 2006, increasing by approximately \$1.6 million (+0.9%) over the previous month.

### Supplemental Security Income

Supplemental Security Income: For August 2006, SSI recipients (including Mental Hygiene) totaled 647,431 increasing 5,284 (+0.8%) from the previous month. SSI expenditures in August 2006 totaled \$326,823,722, increasing by approximately \$7.3 million (+2.3%) from July 2006.

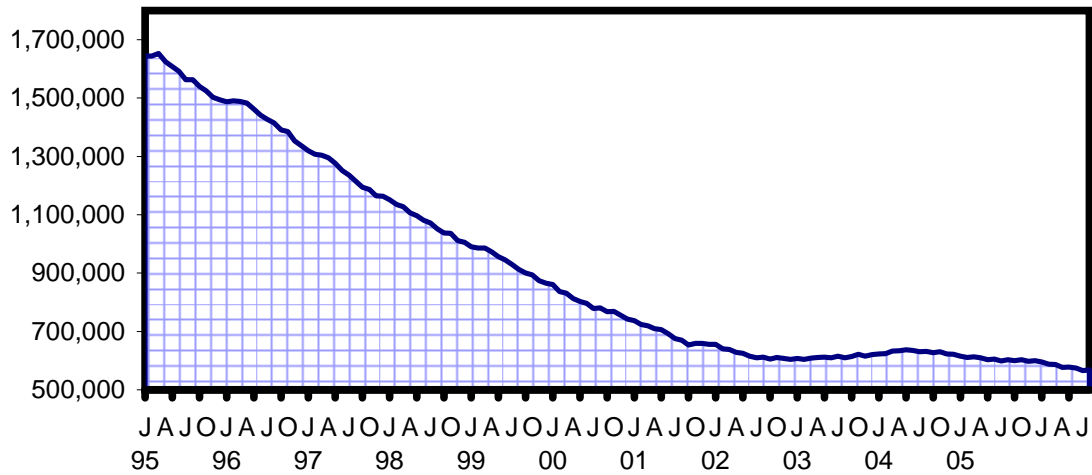

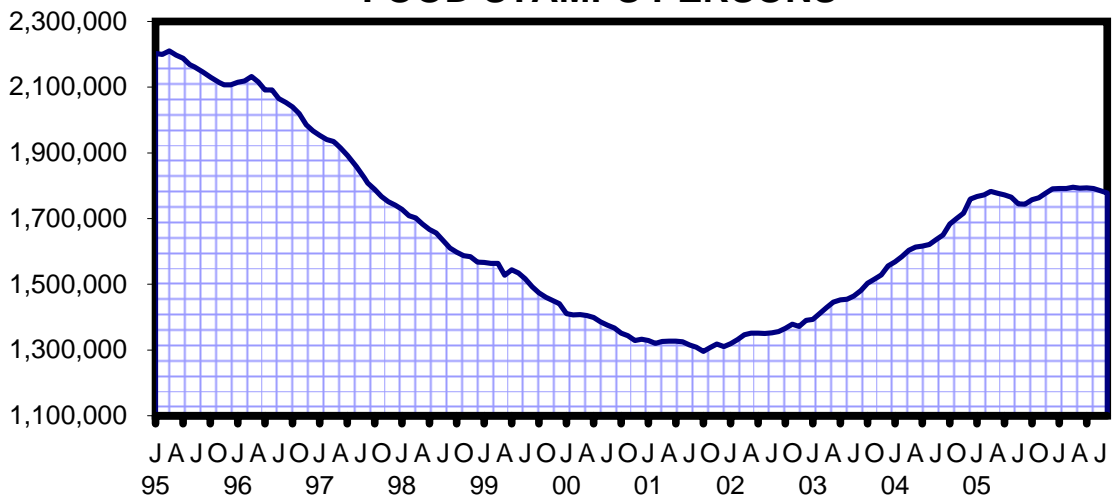

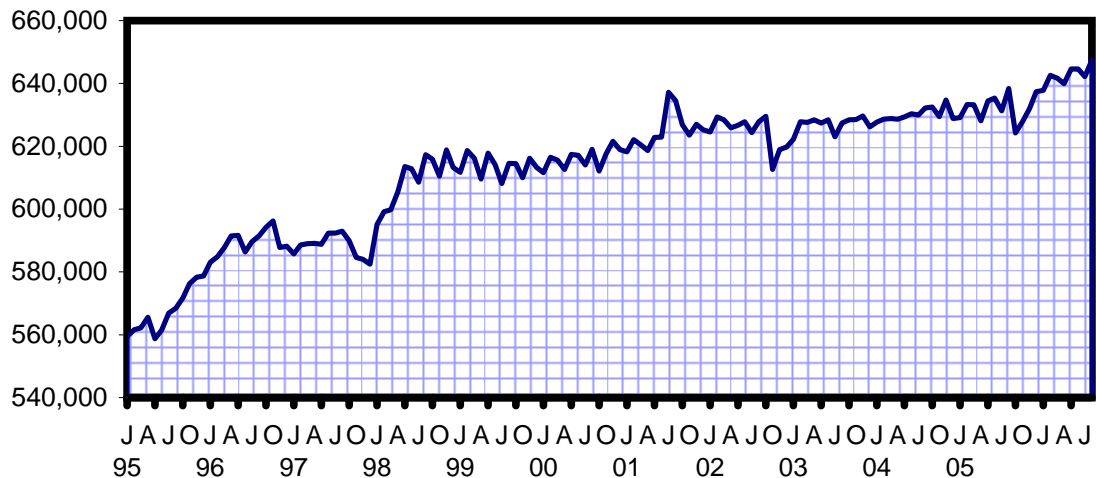
## TEMPORARY ASSISTANCE RECIPIENTS
