Temporary and Disability Assistance Statistics **NOVEMBER 2010**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 556,874 in November 2010, increasing by 3,240 (+0.6%) from the previous month. Related expenditures totaled \$176,177,083 in November 2010, decreasing by approximately \$2.0 million (-1.1%) over October 2010.

Food Stamps

Food Stamps: Food Stamps recipients totaled 2,934,493 in November 2010, increasing by 15,644 (+0.5%) over October 2010. Food Stamps expenditures totaled \$443,344,448 in November 2010, increasing by approximately \$1.8 million (+0.4%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For November 2010, SSI recipients (including Mental Hygiene) totaled 687,800 increasing by 7,002 (+1.0%) from the previous month. SSI expenditures in November 2010 totaled \$391,851,392 increasing by approximately \$9.9 million (+2.6%) from October 2010.

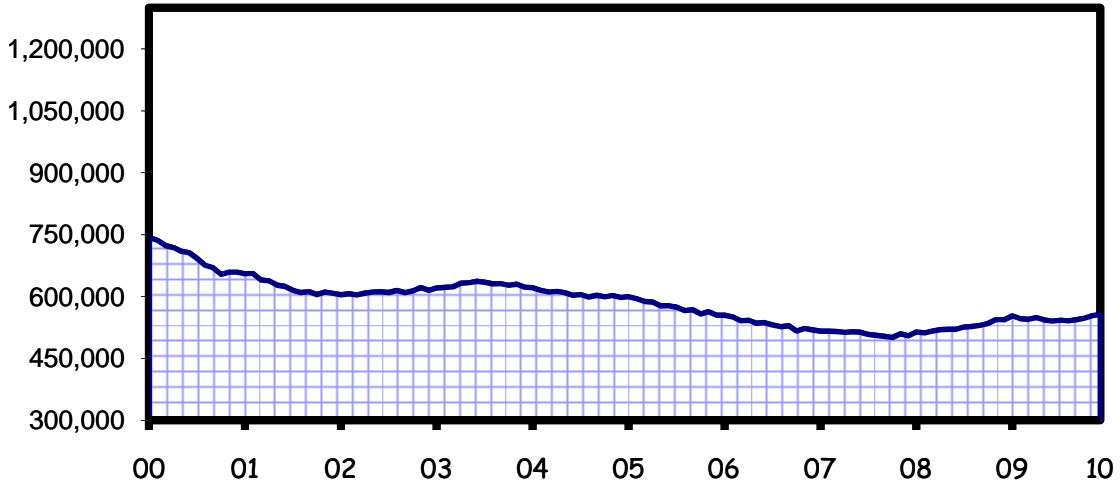

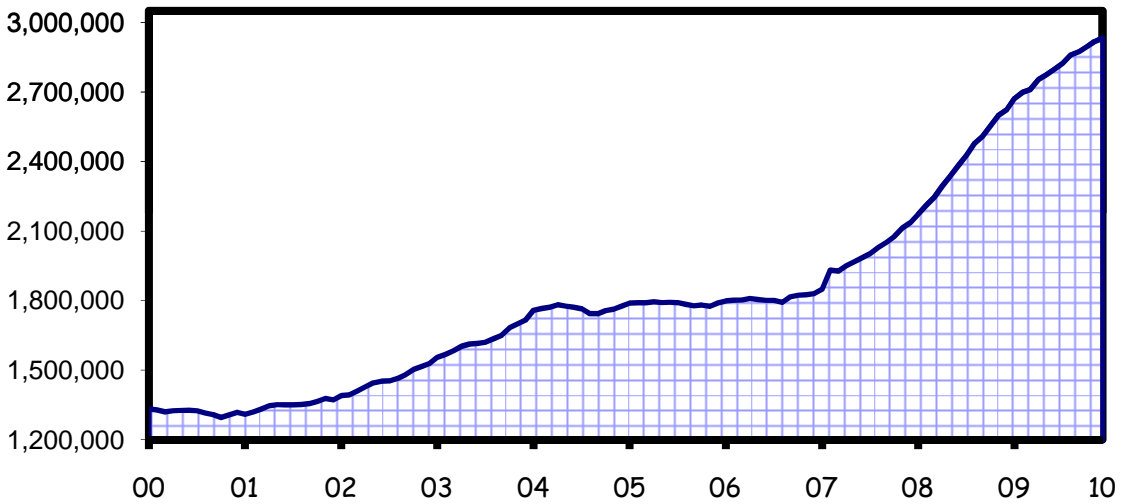

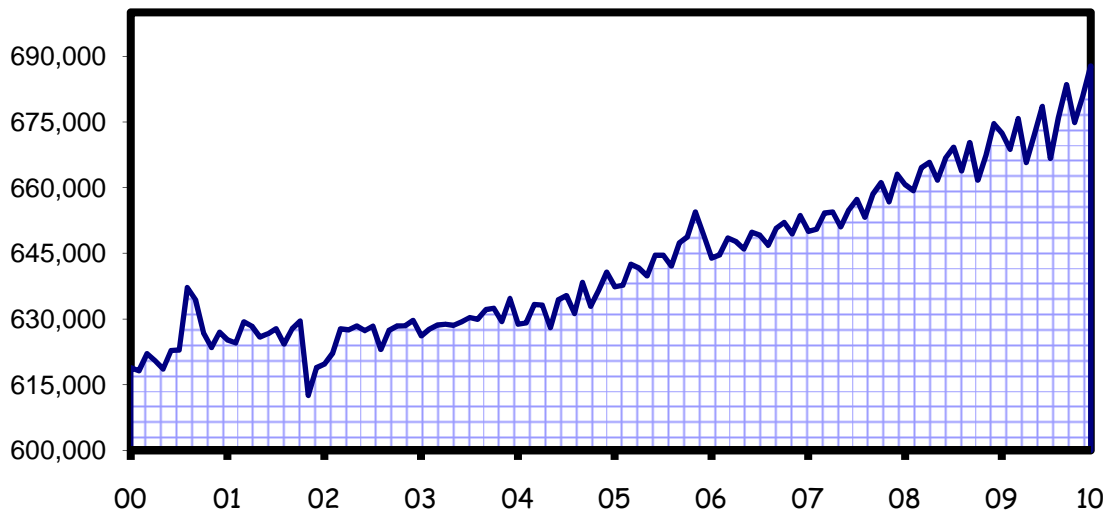
