Temporary and Disability Assistance Statistics **SEPTEMBER 2012**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 564,201 in September 2012, decreasing by 4,637 (-0.8%) from the previous month. Related expenditures totaled \$174,881,155 in September 2012, decreasing by approximately \$6.9 million (-3.8%) over August 2012.

Supplemental Nutrition Assistance Program

Supplemental Nutrition Assistance Program: Supplemental Nutrition Assistance Program recipients totaled 3,101,190 in September 2012, decreasing by 8,246 (-0.3%) from the previous month. Related expenditures totaled \$458,361,541 in September 2012, decreasing by approximately \$4.04 million (-0.9%) over August 2012.

Supplemental Security Income

Supplemental Security Income: Supplemental Security Income recipients (including Mental Hygiene) totaled 692,800 in September 2012, decreasing by 7,009 (-1.0%) from the previous month. Related expenditures totaled \$395,632,893 in September 2012, decreasing by approximately \$7.8 million (-1.9%) over August 2012.

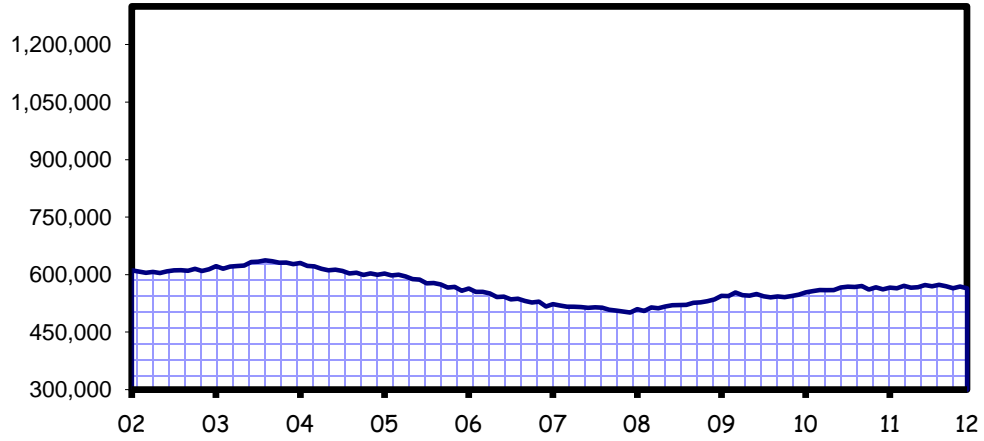

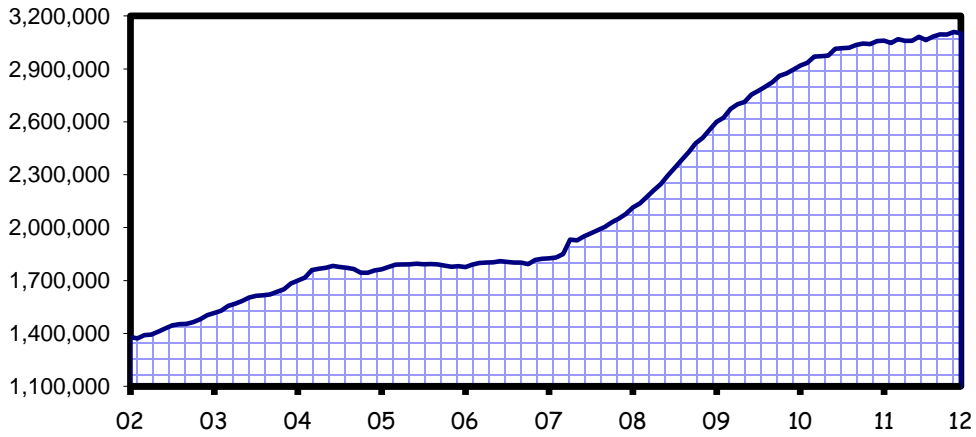

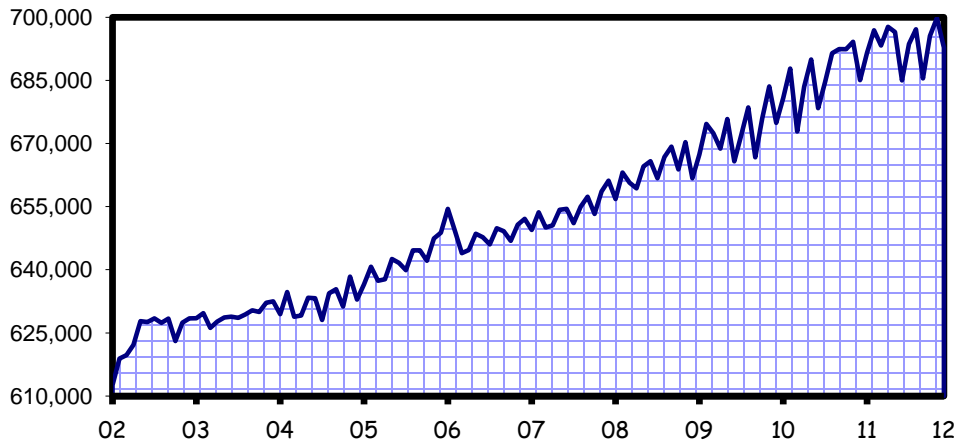
