The Department is currently negotiating an agreement with SUNY to develop a new program called COPE (College Opportunity to Prepare for Employment). SUNY funds will act as the match for federal JOBS funds, so that COPE will serve ADC JOBS participants in JOBS activities. COPE providers will include community colleges, schools of technology, and 4-year colleges which provide 2-year degree programs.

A specific program design for COPE has not yet been defined. We would like to take this opportunity to solicit your ideas, expertise and suggestions to guide the planning process. It is clear that a broad array of educational and job training programs already exist for ADC JOBS participants in most communities. The Department's objective is that COPE not become a duplication of those services already available.
