The purpose of this letter is to notify social services districts (SSDs) that the deadline for submitting negotiated performance goal plans under 98 ADM-13 has been extended, and to transmit to SSDs baseline performance data on job placements which may be used in developing goal plans.

On August 3, 1998 the Office of Temporary and Disability Assistance issued 98 ADM-13, which outlined procedures for negotiating local district performance awards based on district achievement of performance goals. In order to simplify award negotiations, the ADM presented some state-developed measures for use in setting performance goals. At the time the ADM was transmitted, the baseline data for one of these measures, job placements, was not available. That data is now complete, and is attached. Please be sure that it is made available to those within your district who are involved in developing negotiated goal plans under 98 ADM-13.

Because this data is only now available for your consideration in developing plans, the involved agencies are extending the deadline for plan submission from September 30, 1998 to October 16, 1998. This should provide sufficient time to integrate the new data into your decisions regarding what measures to utilize in your plans.
