## I. Purpose

The purpose of this release is to introduce the 11/05 revision of the LDSS-4398: "WMS Non-Services Code Cards".

### II. Background

The WMS Non-Services Code Cards are designed to assist **Upstate** local district staff in locating Welfare Management System (WMS) data-entered and system generated codes.

# **III. Program Implications**

The latest updates to the code cards reflect additions, deletions and changes in WMS codes, which have occurred since the last card stock update in November of 2004.

Most of the changes are as a result of Federal and State Welfare Reform Time Limits Tracking reporting requirements.

# **IV. Forms Ordering Information:**

We expect delivery of the revised WMS Non-Services Code Cards in early March 2006 and that they will be distributed shortly after that.

Your district **will** automatically receive supplies of the WMS Non-Services Code Cards based on previous ordering practices.

Card Stock code cards will continue to be issued on a periodic basis.

The 11/05 revision of the code cards is also accessible through the Intranet. See the 1/28/00 "Dear WMS /CNS Coordinator" letter for instructions on how to download the code cards through the Intranet.
