Section 2

I. Purpose

The purpose of this Information Letter is to introduce a newly revised LDSS-4579: "Alien Eligibility Desk Aid" (Rev. 6/06).

II. Background

The LDSS - 4579: "Alien Eligibility Desk Aid" was originally developed to assist local district staff in identifying satisfactory alien statuses as established under the federal Immigration and Nationality Act and relate specific statuses to an alien's eligibility for Temporary Assistance (TA), Food Stamps(FS) and/or Medical Assistance (MA).

The Desk Aid lists the benefit program eligibility for most common alien statuses as established under the Personal Responsibility and Work Opportunity Reconciliation Act (PRWORA) of 1996, the New York State

OTDA 06-INF-23 (Rev. 6/2006) Welfare Reform Act of 1997, the Agricultural Research, Extension, and Education Act (AREERA) of 1998, and the Food Stamp Reauthorization Act 2002. The attached desk aid will provide district staff with a ready reference on the common immigration documents an alien domestic violence victim will need, when a victim would have to agree to see the DVL, the relative date for eligibility and the specific benefits alien victims can receive. The desk guide is intended to supplement existing policy regarding the eligibility of aliens set forth in federal and state statute and OTDA regulations and policy issuances to local social services districts.

This June 2006 revision of the LDSS-4579 includes further clarification regarding the benefit eligibility of domestic violence victims that was explained in 06-INF-14, Battered Aliens Eligibility for Benefits. The revisions were made to the TA and FS programs only.

III. Program Implications

The Desk Aid should assist districts to administer the Temporary Assistance, Food Stamp and Medical Assistance Programs.

IV. Forms Information

As in previous printings, the revised desk aid will be printed on green cardstock. We expect that the revised desk aid should be delivered to the Albany Warehouse sometime in September, 2006.

Local districts will automatically receive initial supplies of this form.
