Section 2

I. Purpose

The purpose of this Information Letter (INF) is to introduce a newly revised LDSS-4579: "Alien Eligibility Desk Aid (Revised 10/07)".

II. Background

The LDSS-4579: "Alien Eligibility Desk Aid" was originally developed to assist local district staff in identifying satisfactory immigration statuses as established under the federal Immigration and Nationality Act and relate specific statuses to an alien's eligibility for Temporary Assistance (TA), Food Stamps (FS) and/or Medical Assistance (MA).

The *Desk Aid* lists the benefit program eligibility for most common immigration statuses that are recognized under the Personal Responsibility and Work Opportunity Reconciliation Act (PRWORA) of 1996; the New York State Welfare Reform Act of 1997; the Agricultural Research, Extension and Education Act (AREERA) of 1998; and, the Food Stamp Reauthorization Act of 2002. The attached *Desk Aid* provides local district staff with a ready reference on the common immigration documents an alien has to document his or her status. Included are the variety of immigration documents an alien domestic violence victim will need for a determination of qualified status and what immigration documents would require an alien domestic violence victim to have to agree to see the district's Domestic Violence Liaison (DVL) for a determination of qualified status to be made. The relative date for eligibility and the specific benefits alien domestic violence victims can receive is outlined for each immigration document. The *Desk Aid* is intended to supplement existing policy regarding the eligibility of aliens set forth in federal and state statue and OTDA regulations and policy issuances to local social services districts.

This October 2007 revision of the LDSS-4579 clarifies the Food Stamps eligibility for aliens who entered the U.S. before August 22, 1996. It notes that in New York City WMS ACI Code "R" is used for victims of human trafficking. ACI code "N" – PRUCOL (Permanently Residing under the Color of Law), which is no longer used for certain MA cases, has been deleted from the *Desk Aid*. The policy references for OTDA's and the Department of Health's interpretation of PRUCOL have also been updated.

III. Program Implications

The *Desk Aid* should assist local districts to administer the Temporary Assistance, Food Stamp and Medical Assistance Programs.
