#### **Section 2**

## I. Purpose

The purpose of this Informational Letter (INF) is to introduce the revised LDSS-4925: "Employability Code Desk Guide TANF and SN MOE" and LDSS-4926: "Employability Code Desk Guide SN non-MOE" and to apprise local districts that this form is now available on-line.

#### II. Background

The Personal Responsibility and Work Opportunity Reconciliation Act of 1996 (PRWORA) authorized the Temporary Assistance for Needy Families (TANF) Block Grant program. Under PRWORA, states were granted significant flexibility to design programs to meet families' basic needs and help individuals enter the workforce. In 2005, Congress passed the Deficit Reduction Act of 2005, reauthorizing the TANF program and giving the federal Department of Health and Human Services regulatory authority in certain areas.

### **III.** Program Implications

District staff should begin using the revised LDSS-4925: "Employability Code Desk Guide TANF and SN MOE" and LDSS-4926: "Employability Code Desk Guide SN non-MOE" immediately as the revised form enables district staff to properly monitor exemptions consistent with federal and State regulations.

## **IV.** Forms Ordering Information

- The revised English versions of the LDSS-4925: "Employability Code Desk Guide TANF and SN MOE" and the LDSS-4926: "Employability Code Desk Guide SN non-MOE" are **not** State printed but are available to local districts in PDF format or as master camera-ready copies. The procedures for ordering PDFs or master camera-ready copies are listed below.
