Section 2

I. Purpose

The purpose of this release is to inform local districts that the following publication is obsolete:

LDSS-4148D (Rev. 10/09): New Information About Temporary Assistance and Food Stamps

II. Background

Local districts were informed by 09-INF-17 Addendum to the Client Information Books – LDSS-4148D: "New Information About Temporary Assistance and Food Stamps", that effective October 1, 2009, they were to provide the LDSS-4148D when an application (LDSS- 2921) or recertification (LDSS-3174) of Temporary Assistance/Food Stamp benefits is submitted, with the LDSS-4148A, B, and C.

The information in the LDSS 4148D has now been incorporated into the revised versions of the LDSS 4148A - "New York State What You Should Know about your Rights and Responsibilities (When Applying For or Receiving Benefits)" (02/10) and the LDSS 4148B - "What You Should Know about Social Services Programs" (02/10). Local districts must ensure that they are distributing the most recent (02/10) versions of the LDSS 4148A and B. Those distribution of the LDSS 4148D. Those districts that have not yet began distribution of the revised LDSS 4148A and B must continue to distribute the LDSS 4148D until the time they begin distribution of the revised (02/10) versions of the LDSS 4148A and B.

The 4148D does not need to be provided as part of application packets for households applying or recertifying just for food stamp benefits using the LDSS-4826 "Food Stamp Benefits Application/Recertification" and LDSS-4826A "How to Complete The Food Stamp Benefit Application/Recertification" forms.

III. Program Implications

Districts should ensure that individuals receive the 2/10 revised LDSS-4148A and B at application, recertification and upon request. Any stock of the 4148D must be destroyed.

IV. Forms Ordering Information:
