### <u>Chapter 5 — Relates to Services for Inmates of State Correctional</u> **Facilities**

[S.1315/A.858]

Amends the Correction Law and provides for notice, by the Commissioner of Correctional Services, of availability of medical, educational, and other services, including alcohol and substance abuse treatment, to prisoners upon their releases from State prisons, and requires the Commissioner of Correctional Services to consult with the Commissioner of the Office of Temporary and Disability Assistance, among other commissioners, in the implementation of notice of transitional services for inmates released from correctional facilities, and, where appropriate, to assist an inmate in contacting a program or service provider prior to such inmate's release.

Amends the Social Services Law to amend notice requirements, conciliation procedures, and sanctions in cases when the recipient of public assistance programs refuses to comply with employment program requirements in New York City.

# <u>Chapter 584 — Relates to Victims of Domestic Violence and Their Service Animals or Therapy Dogs</u>

Authorizes service animals or therapy dogs to accompany victims of domestic violence at residential programs.

# <u>Chapter 29 — Extends the Drivers' License Suspension Process</u> [S.5750-A/A.7193-A]

Extends the provisions authorizing the administrative suspension of driving privileges as a result of the non-payment of support from June 30, 2015 to August 31, 2017.

new guidelines for temporary and post-divorce maintenance and spousal support.

# <u>Chapter 347 — Repeals and Reenacts the Uniform Interstate Family Support Act</u> (UIFSA)

[S.5685-B/A.7636-B]

Among other things, amends Article 5-B of the Family Court Act to adopt the UIFSA 2008 amendments and amends § 111-i of the Social Services Law to align the timing of the adjustment of the combined parental income amount with the adjustment of the poverty income guidelines amount for a single person ("poverty level") and the self-support reserve. Through adoption of the UIFSA 2008 amendments, Chapter 347 also integrates or enables appropriate provisions of the 2007 Family Maintenance Convention, clarifies issues regarding controlling order determinations, telephonic testimony, duration of support orders, redirection of payments, and choice of law considerations, and ensures compliance with federal requirements and the Title IV-D State Plan.

### <u>Chapter 387 — Relates to Spousal Maintenance and Child Support in Supreme and</u> Family Courts

Amends the Family Court Act and Domestic Relations Law by requiring that alimony or spousal maintenance actually paid to a spouse who is a party to an action must be added to the recipient spouse's income, provided that the court order contains an automatic adjustment to take effect upon the termination of the maintenance award, and clarifies that, where spousal maintenance payments are deducted from the payor's income, the court order must contain a specific provision adjusting the child support amount automatically upon the termination of the spousal maintenance award.

Authorizes the Commissioner of the Office of General Services to sell and convey certain lands in the borough of Manhattan, County of New York to be used for, among other things, social services programs.

# <u>Chapter 519 — Authorizes Broadcasting of Open Meetings of an Agency or Department</u>

Authorizes broadcasting of open meetings of an agency or department, and relates to realtime streaming on such agency's or department's website.

# <u>Chapter 548 — Relates to the Determination of Eligibility for Payment of Interest on Amounts Owed to Contractors</u>

[S.4929/A.7579]

Amends the State Finance Law by eliminating the exemption from the 30-day prompt contracting interest penalties due to an insufficient cash balance in the fund or sub-fund to finance a payment.

# <u>Chapter 566 — Authorizes Enterprise Fraud Prevention and Detection System by</u> <u>Comptroller to Develop and Implement Techniques and Technologies to Detect and Prevent Fraud</u>

[S.3757/A.5056]

Authorizes an enterprise approach to the fraud prevention and detection system by the State Comptroller to develop and implement techniques and technologies to detect and prevent fraud, waste, and abuse in State government and for the detection and prevention of improper payments of public monies.

# <u>Chapter 568 — Requires State Agencies to Pay Small Businesses Within 15 days of Receipt of an Invoice</u>

[S.5283-A/A.6902-B]

Amends State Finance Law to require payment to be made to small businesses within 15 calendar days, excluding legal holidays, of receipt of an invoice from a small business. Defines "small business" as "a business whose primary place of business is in New York [S]tate, has a significant business presence in the [S]tate, is independently owned and operated, not dominant in its field, and employs no more than [300] employees."

# <u>Chapter 273 — Relates to the Rehabilitation of Certain Multiple</u> <u>Dwellings Used for Single-Room Occupancy</u>

Amends the Real Property Tax Law to extend the date by which not-for-profit and for-profit owners rehabilitating single-room occupancy housing are eligible to receive tax benefits from December 31, 2015 to December 31, 2019.

Relates to prohibiting housing discrimination against victims of domestic violence, as well as creation of a task force to study the impact of income on housing as well as Section 8 and other housing policies.

# <u>Chapter 482 — Relates to Reporting on Efforts to Prevent, Identify, and Address Homelessness</u>

Requires the Commissioner of the Office of Temporary and Disability Assistance to submit a report detailing local social services districts' efforts to prevent, identify, and address homelessness.

# <u>Chapter 553 — Relates to Determining the Rent Increase Exemption Amount for</u> Individuals in New York City

Amends the Real Property Tax Law and the Administrative Code of the City of New York, in relation to the tax abatement and exemption of rental units occupied in part by certain persons aged 62 and older or persons with disabilities. The law references monthly shelter allowances pursuant to the Social Services Law.

Relates to, among other things: improving the State's response to human trafficking by increasing criminal accountability of buyers and traffickers; providing a civil remedy to human trafficking victims to recover damages and reasonable attorney's fees from their perpetrators; and increasing awareness among law enforcement regarding identifying human trafficking victims and referral of services to human trafficking victims through the development and dissemination to all members of the State Police — in consultation with the Office of Temporary and Disability Assistance and the Division of Criminal Justice Services — written policies and education materials relating to human trafficking victims and establishing and implementing written procedures in the event State Police encounter an apparent human trafficking victim.

# <u>Chapter 426 — Relates to Exempting Victims of Sex Trafficking from</u> <u>the DNA Databank Fee</u>

[S.4394-A/A.2469-A]

Amends the Criminal Procedure Law and exempts victims of sex trafficking from the DNA databank fee, in addition to the mandatory surcharge and crime victim assistance fee for persons convicted where the arresting charge is loitering for prostitution or prostitution or when the court finds the defendant is a victim of sex trafficking.
