SUBJECT: Transition of State Supplemental Personal Needs Allowance (SSPNA) Benefits to Direct Deposit

The purpose of this GIS is to advise local Social Services Districts (SSDs) that the Office of Temporary and Disability Assistance (OTDA) is changing the method of payment to most State Supplemental Personal Needs Allowance (SSPNA) recipients from paper check to direct deposit. Those SSPNA recipients who use direct deposit for their Supplemental Security Income (SSI) benefit will have their SSPNA directly deposited into the same bank account. Benefit amounts remain the same. SSPNA recipients will continue to receive a monthly benefit of either \$5 or \$25 from New York State. Recipients who receive their SSI benefits by check will continue to receive their SSPNA by check.

The transition began for a small number of SSPNA recipients in May 2014. The remaining SSPNA recipients, approximately 8,000, will be converted to direct deposit with the issuance of the August 2014 benefit.

A notice, in both English and Spanish, was mailed during the week of July 7 to those impacted by this change. A sample of the English version of notice is attached.

Any questions regarding SSPNA that SSDs receive from recipients or residential care facilities should be directed to the OTDA State Supplement Program Bureau at 1-855-488-0541.

There is no impact or required action for local SSDs.

Dear SSPNA Recipient:

Beginning in August, instead of sending you a paper check for your State Supplemental Personal Needs Allowance (SSPNA), we will directly deposit your monthly payment into the same bank account as your federal SSI payment. You will receive your SSPNA deposit on or before the first of each month. This will provide a safer and more convenient way to access your SSPNA benefit.

This will not change your eligibility for SSPNA or the amount of your SSPNA benefit.

Please note that we rely on information received from the federal Social Security Administration (SSA) to provide you with the correct SSPNA benefit. You should continue to report any changes in circumstances, such as a new address or new banking information, to SSA.
