### **Purpose**

The purpose of this GIS is to provide additional information to social service districts (SSDs) about changes in Federal and State law that prohibit specific types of businesses from allowing Electronic Benefit Transfer (EBT) transactions for withdrawal of cash benefits or for purchase of goods and services.

### Background

Under the Federal Middle Class Tax Relief and Job Creation Act of 2012 (P.L. 112-96), states are required to implement policies and practices to prevent Federal Temporary Assistance for Needy Families (TANF) benefits from being used in any EBT transaction at liquor stores, casinos, gambling casinos, gaming establishments, and establishments which provide adult-oriented entertainment in which performers disrobe or perform in an unclothed state. In New York, Part F of Chapter 58 of the Laws of 2014 explicitly sets forth the authority to impose financial and licensing penalties against establishments that accept an EBT card at a prohibited location. Venues determined to be in violation can be fined and/or may be subject to possible revocation, cancellation or suspension of their license(s). Part F of Chapter 58 of the Laws of 2014 extended the prohibitions to all public assistance accessed via a recipient's EBT card, not only TANF-funded assistance.

#### **Program Implications**

Social services districts do not need to take any direct action. The NYS Gaming Commission and the NYS Liquor Authority (SLA) have notified the entities they license about these prohibitions and the resultant penalties. These State licensing agencies will also monitor compliance and determine whether to impose penalties. OTDA will conduct periodic targeted reviews of EBT transactions to monitor retailer compliance with the requirements, and will provide the licensing agencies with data on suspect transactions. OTDA identified establishments that potentially provide adult-oriented entertainment in which performers disrobe or perform in an unclothed state, and has sent such venues a

notice of the requirements and the penalties for non-compliance. OTDA's letter also afforded these entities the opportunity to inform New York State if OTDA has incorrectly identified their business.

OTDA is in the process of issuing the attached notice to all current public assistance recipients explaining that prohibited venues are not allowed to accept EBT cards on their premises. OTDA is also in the process of revising client handbooks to inform public assistance applicants and recipients of these restrictions.

Please be advised that certain types of businesses in New York State are not allowed to let you use your cash assistance on your Electronic Benefit Transfer (EBT) card to purchase items or to withdraw cash on their premises.

Businesses are not allowed to let you use your EBT card at:

- Liquor stores;
- Wine stores;
- Beer/beverage centers;
- Racetracks:
- Casinos;
- Video lottery facilities;
- Off-track betting facilities;
- Commercial bingo facilities; and
- Places that provide adult oriented entertainment in which performers take off their clothes or perform without clothes.

Businesses that allow you to use your EBT card to purchase items or to withdraw cash at these locations may lose their license or have to pay a fine.
