The following forms are now available for printing and distribution.

**LDSS-5066** has been designed as a guide for EBT customers to navigate the features using the EBT customer website at <a href="https://www.ebt.acs-inc.com/">https://www.ebt.acs-inc.com/</a>. EBT customers will be required to register to the website to access their account information.

**LDSS-5004** has been revised to include a sentence on Page 4. The guide is designed to provide EBT customers with information on the use of the EBT card and Personal Identification Number (PIN) for their SNAP and cash benefits at authorized retail stores and cash access locations. Please be advised that certain types of businesses in New York are not allowed to let customers use cash benefits on EBT for purchases or withdrawals.
