The purpose of this message is to inform local social services districts that the **October 2015 State Supplement Program (SSP) benefit payments** will be made on **September 23, 2015**, rather than on October 1, 2015. This payment change applies both to benefits that are directly deposited and to benefits paid by paper check.

This one-time payment schedule change is being made in order to accommodate State Fiscal System updates. This change does not affect the payment schedule for Supplemental Security Income (SSI) or any other benefits issued by the Social Security Administration.

Attached are reminder notices (English and Spanish) that districts may choose to post in waiting rooms or other appropriate spaces.

IMPORTANT BENEFIT INFORMATION FOR NEW YORK STATE SUPPLEMENT PROGRAM (SSP) RECIPIENTS

Payment Date Change for October Benefits

The direct deposit date for SSP benefits for October will be **September 23, 2015**, not October 1. If your SSP benefit is paid by check, you will receive your check on or about September 23, 2015.

This payment schedule change is for SSP benefits only. Federal SSI or other SSA issued benefits will be paid on SSA's regular schedule.

Cambio de fecha para el pago del subsidio de octubre

La fecha para el depósito directo del subsidio del mes de octubre será el **23 de septiembre de 2015** y no el 1º de octubre. Si le pagan el subsidio del SSP con cheque, usted recibirá su cheque alrededor del 23 de septiembre de 2015.

Este cambio en el calendario de pagos es únicamente para el subsidio del SSP (Programa de Suplemento del Estado de Nueva York). El subsidio federal SSI u otros subsidios de la Administración del Seguro Social (SSA) se pagarán de acuerdo al calendario programado de la Administración del Seguro Social.
