The purpose of this GIS message is to inform social services districts (districts) that Friday, November 2, 2018 is the closing date for the 2017-2018 Home Energy Assistance Program (HEAP) Heating Equipment Repair and Replacement (HERR) component, and the extension of the 2017-2018 HEAP Heating Equipment Clean and Tune (C&T) component.

## 2017-2018 HERR

Districts must continue to accept applications for HERR benefits through the close of business (COB) November 2, 2018. Applications for HERR benefits submitted on or before COB November 2, 2018 must be honored and processed in accordance with instructions found in the New York State HEAP Manual.

In order to claim against the proper program year, when processing HERR payments for 2017-2018, districts must use the authorization period of 10/01/18 to 09/30/19 on Screen One of WMS. On Screen Six of WMS, districts must enter a "to date" equal to 09/30/18 for the payment line.

Districts must include 2017-2018 HERR applications on their weekly HEAP Pending Case Reports until **11/2/18**. The 2018-2019 HEAP HERR component will open on 11/5/18, and therefore, beginning **11/9/18 districts must only report pending 2018-2019 HERR** applications received on or after **11/5/18** on their weekly HEAP Pending Case Reports.

Individuals seeking help with heating equipment repair or replacement needs when HEAP HERR is not available may have their needs met under Family Assistance (FA), Safety Net Assistance (SNA), Emergency Assistance to Families (EAF) or Emergency Assistance for Adults (EAA) if they apply and are found eligible. Department Regulations 18 NYCRR 352.4, 352.6(e), 352.7(b), 372.4(b) and 397.5(h) provide districts the ability to meet the costs necessary for the repair or replacement of essential heating equipment if the repair or



replacement is essential to the health and safety of the household. For more information, see the Temporary Assistance Source Book, Chapter 16, Section C.

## 2017-2018 C&T

Districts must continue to accept HEAP C&T applications for the 2017-2018 program year until notified of the component closing via GIS messaging. All C&T applications must be processed in accordance with instructions found in <u>18-LCM-06</u>.

In order to claim against the proper program year, when processing C&T payments for 2016-2017, districts must use the authorization period of 10/01/18 to 09/30/19 on Screen One of WMS and on Screen Six of WMS, districts must enter a "to date" equal to 09/30/18 for the payment line.

Districts must continue to report pending 2017-2018 C&T applications on the HEAP Pending Case Report. If the district has no pending C&T applications, a "0" must be entered for that week.
