Adult Without Dependents (ABAWD) Requirements" and LDSS-5127 "ABAWD

The purpose of this message is to inform social services districts (districts) that the <u>LDSS-5072</u> "Informational Letter Regarding Able Bodied Adult Without Dependents (ABAWD) Requirements" and the <u>LDSS-5127</u> "ABAWD Work Activity Letter" have been revised (Rev. 1/20).

The revisions to the LDSS-5072 "Information Letter Regarding ABAWD Requirements" include the following:

- Under the heading, "What is an ABAWD required to do?" the list of ABAWD qualifying work
 activities was revised to add participation in an employment and training program for
 veterans operated by the Department of Labor or the Department of Veteran's Affairs as an
 ABAWD qualifying work program.
- Under the heading, "Do you think any of the adults in your SNAP household are exempt from ABAWD requirements?" the language in the sixth bullet was changed from "determined to be unable to work due to substance abuse" to "a regular participant in an alcohol or drug treatment program". Additionally, the language in the eighth bullet was revised to include receipt of "workers compensation".

The LDSS-5127 "ABAWD Work Activity Letter" was revised to add participation in an employment and training program for veterans operated by the Department of Labor or the Department of Veteran's Affairs as an ABAWD qualifying work program.
