Temporary and Disability Assistance Statistics **DECEMBER 2004**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 621,464 in December 2004, decreasing by 1,264 (-0.2%) from the previous month. Related expenditures totaled \$157,570,722 in December 2004 increasing approximately \$3.7 million (+2.4%) over November 2004.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,759,350 in December 2004, increasing by 42,651 (+2.5%) over November 2004. Food Stamps expenditures totaled \$180,642,469 in December 2004, increasing approximately \$3.6 million (+2.0%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For December 2004, SSI recipients (including Mental Hygiene) totaled 628,843 decreasing 5,866 (-0.9%) from the previous month. SSI expenditures in December totaled \$304,718,330 decreasing approximately \$5.9 million (-1.9%) from November 2004.

Aggregate Claims

Aggregate Claims: This month's *Temporary and Disability Statistics* contains updated data on aggregate local district claims for Temporary Assistance costs. These data are included pursuant to legislative mandate, and are described in notes accompanying the data tables.

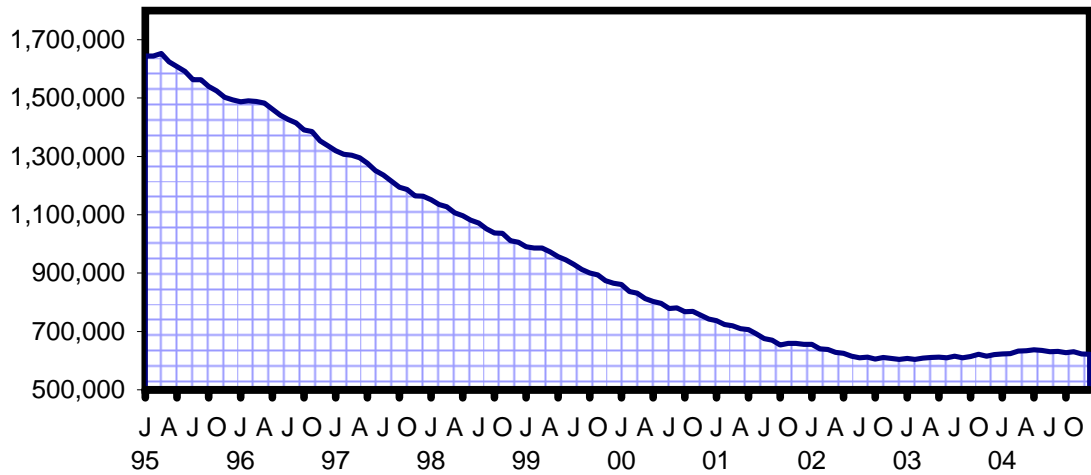

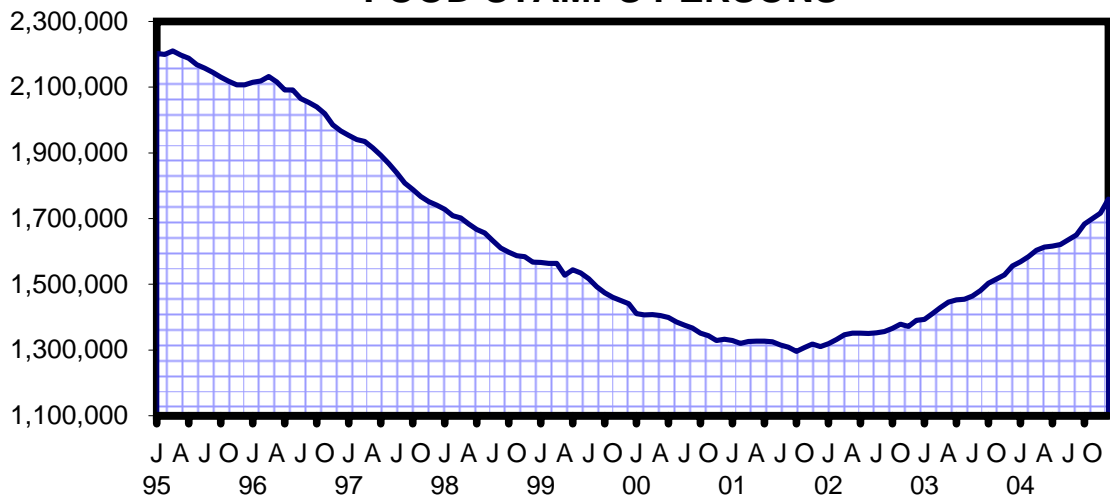

TEMPORARY ASSISTANCE RECIPIENTS

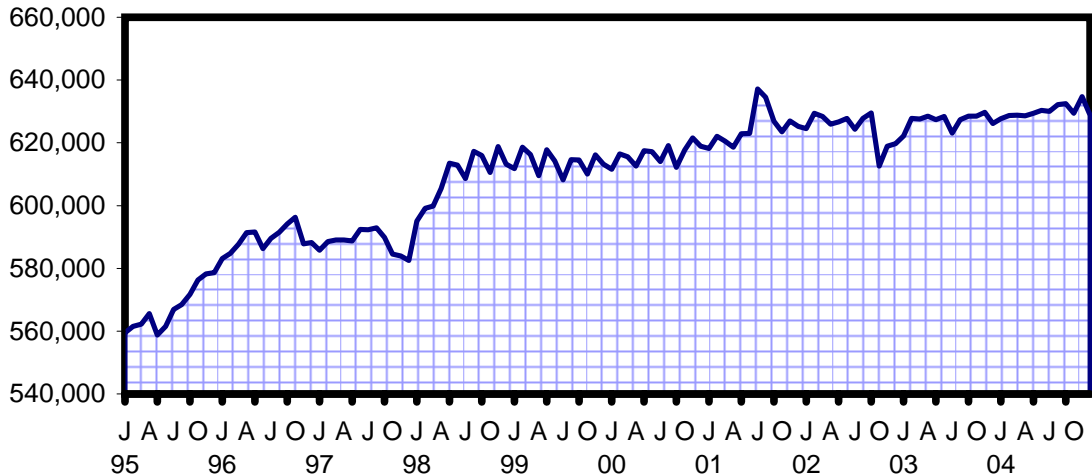


FOOD STAMPS PERSONS
