# Temporary and Disability Assistance Statistics

## APRIL 2005

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 609,581 in April 2005, decreasing by 3,245 (-0.5%) from the previous month. Related expenditures totaled \$155,547,292 in April 2005 decreasing approximately \$6.2 million (-3.8%) over March 2005.

### Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,776,762 in April 2005, decreasing by 6,168 (-0.3%) over March 2005. Food Stamps expenditures totaled \$180,272,106 in April 2005, decreasing approximately \$1.3 million (-0.7%) over the previous month.

### Supplemental Security Income

Supplemental Security Income: For April 2005, SSI recipients (including Mental Hygiene) totaled 628,070 decreasing 5,166 (-0.8%) from the previous month. SSI expenditures in April totaled \$311,020,184 decreasing \$767,807 (-0.2%) from March 2005.

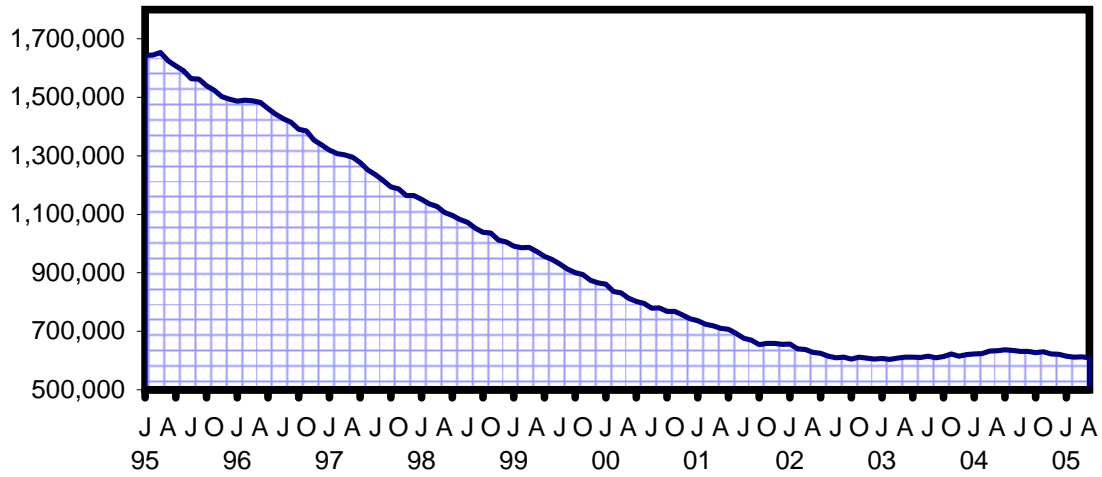

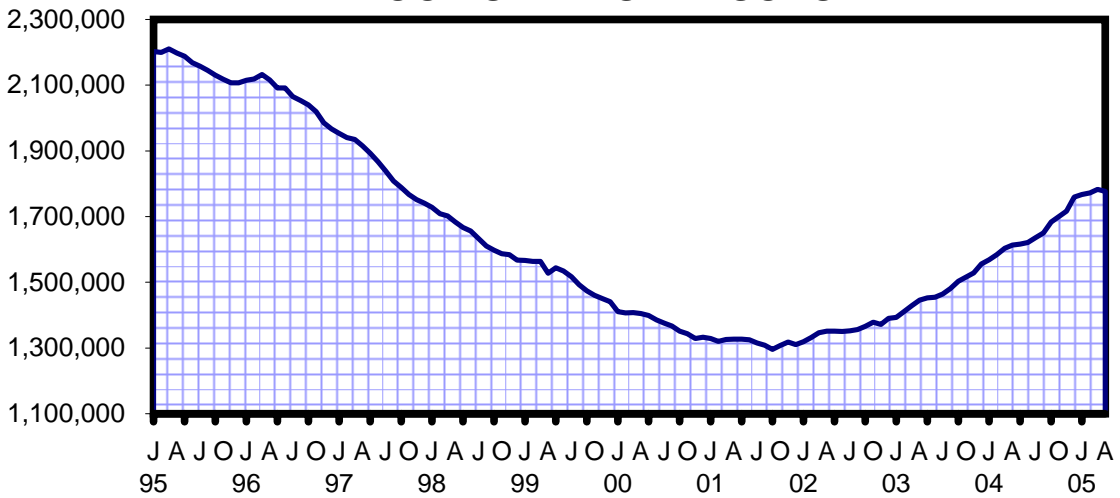

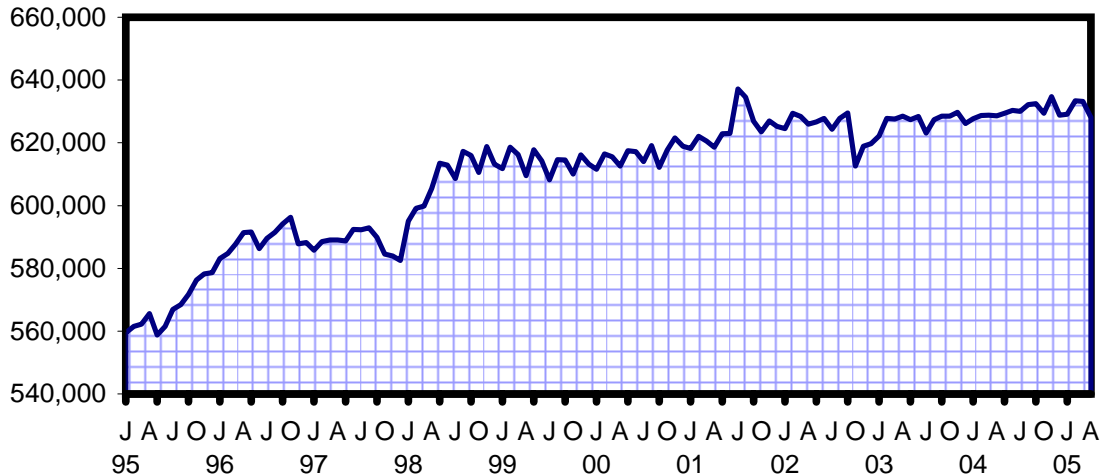
## TEMPORARY ASSISTANCE RECIPIENTS
