# Temporary and Disability Assistance Statistics

## JUNE 2005

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 604,935 in June 2005, increasing by 1,942 (+0.3%) from the previous month. Related expenditures totaled \$156,717,287 in June 2005 increasing approximately \$3.4 million (+2.2%) over May 2005.

### Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,765,359 in June 2005, decreasing by 6,883 (-0.4%) over May 2005. Food Stamps expenditures totaled \$180,415,155 in June 2005, increasing \$568,388 (+0.3%) over the previous month.

### Supplemental Security Income

Supplemental Security Income: For June 2005, SSI recipients (including Mental Hygiene) totaled 635,372 increasing 957 (+0.2%) from the previous month. SSI expenditures in June totaled \$312,736,544 decreasing approximately \$2.4 million (+0.8%) from May 2005.

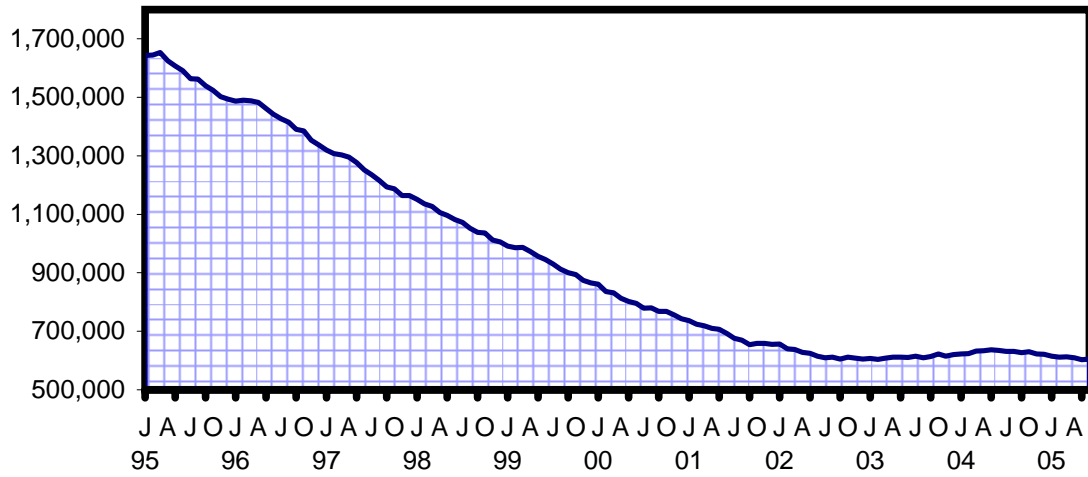

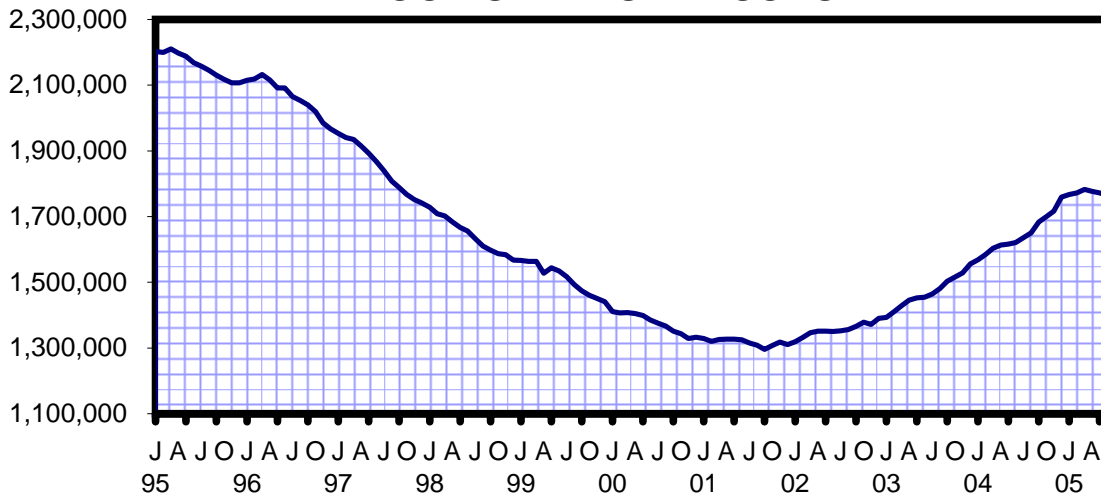

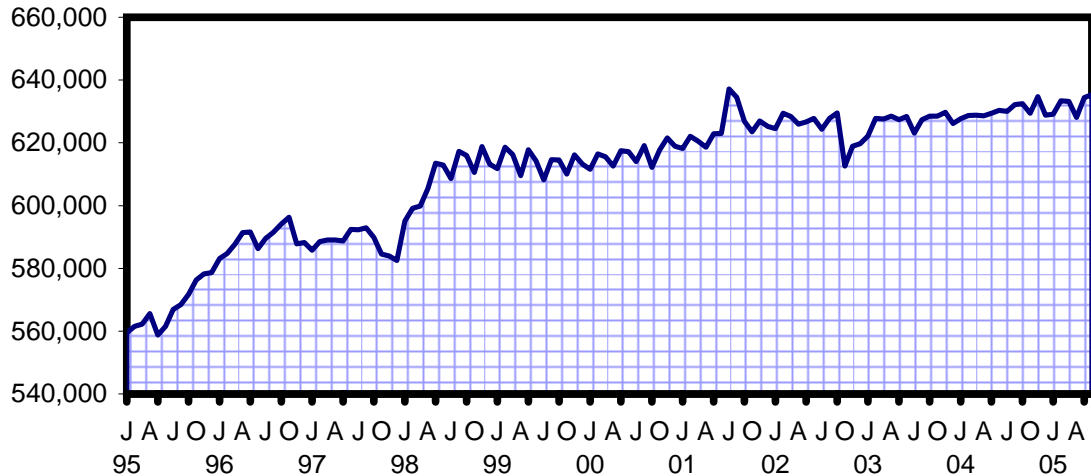
## TEMPORARY ASSISTANCE RECIPIENTS
