# Temporary and Disability Assistance Statistics October 2006

---

## Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 563,696 in October 2006, increasing by 5,810 (+1.0%) from the previous month. Related expenditures totaled \$155,001,867 in October 2006, increasing by approximately \$4.6 million (+3.0%) over September 2006.

## Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,776,176 in October 2006, decreasing by 5,211 (-0.3%) over September 2006. Food Stamps expenditures totaled \$200,913,772 in October 2006, increasing by approximately \$12.3 million (+6.5%) over the previous month.

## Supplemental Security Income

Supplemental Security Income: For October 2006, SSI recipients (including Mental Hygiene) totaled 646,053 decreasing 2,750 (-0.4%) from the previous month. SSI expenditures in October 2006 totaled \$323,375,421, decreasing by \$977,242 (-0.3%) from September 2006.

**Note:** It was recently determined that the number of Temporary Assistance Cases, Recipients and Expenditures for the Rest of State Districts of Fulton, Livingston, St. Lawrence and Schuyler was understated on prior publications of the October 2006 Temporary and Disability Statistics. The proper caseload data contained in this revision affects data for these four individual Districts and cumulative Rest of State data displayed on Tables 1 thru 11 and also on Tables 21 thru 23.

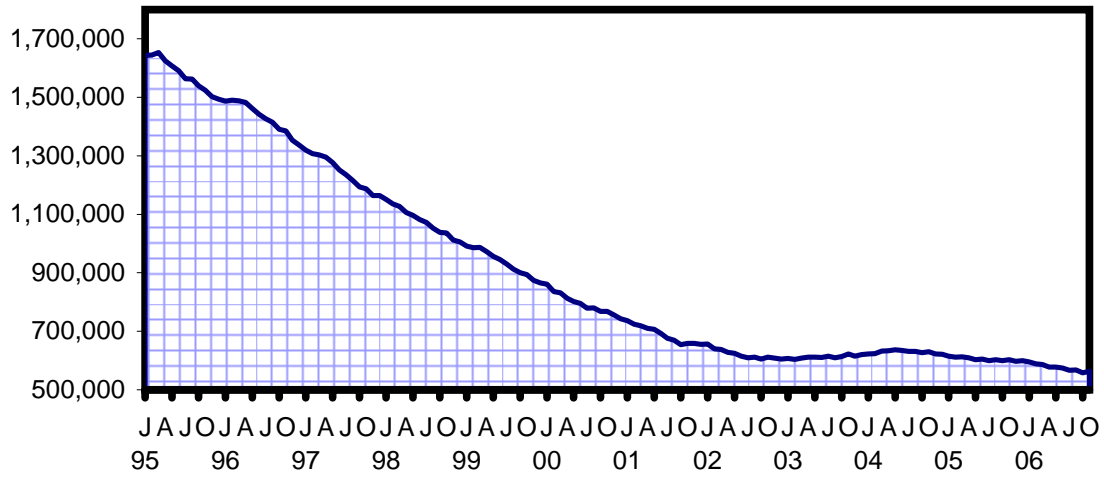

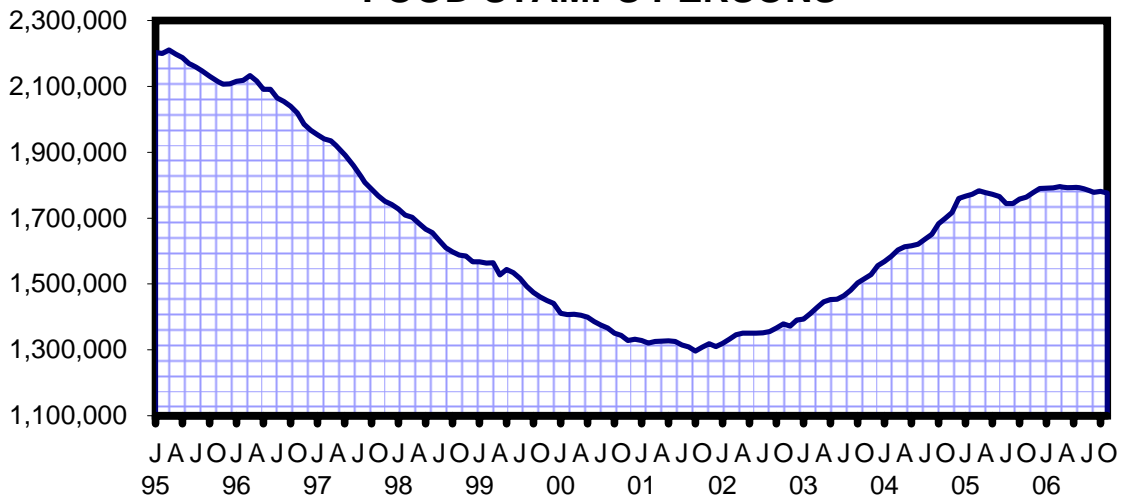

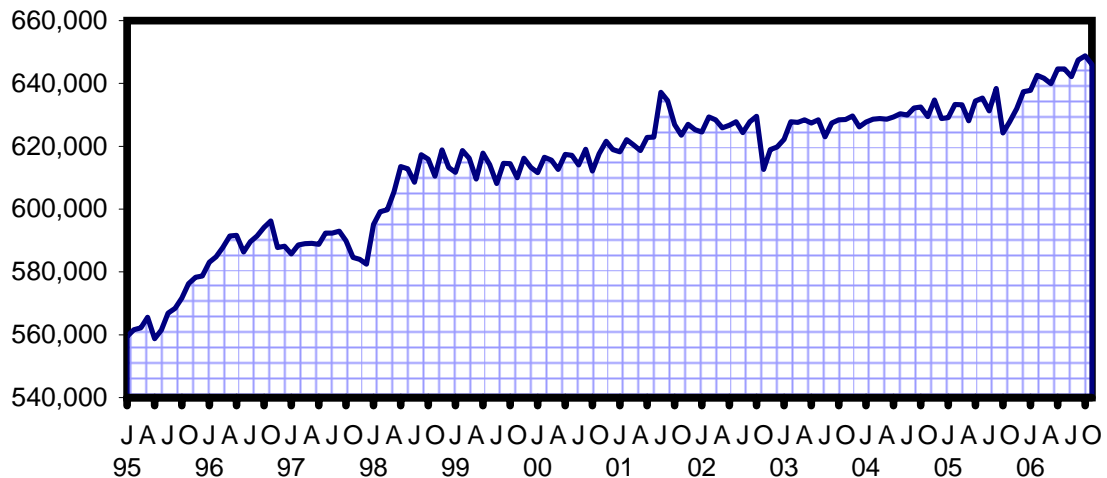
## TEMPORARY ASSISTANCE RECIPIENTS
