## Temporary and Disability Assistance Statistics November 2006

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 554,983 in November 2006, decreasing by 8,713 (-1.5%) from the previous month. Related expenditures totaled \$150,581,451 in November 2006, decreasing by approximately \$4.4 million (-2.8%) over October 2006.

### Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,790,452 in November 2006, increasing by 14,276 (+0.8%) over October 2006. Food Stamps expenditures totaled \$194,710,209 in November 2006, decreasing by approximately \$6.2 million (-3.1%) over the previous month.

### Supplemental Security Income

Supplemental Security Income: For November 2006, SSI recipients (including Mental Hygiene) totaled 649,295 increasing 3,242 (+0.5%) from the previous month. SSI expenditures in November 2006 totaled \$324,501,076, increasing by approximately \$1.1 million (+0.3%) from October 2006.

**Note:** It was recently determined that the number of Temporary Assistance Cases, Recipients and Expenditures for the Rest of State Districts of Fulton, Livingston, St. Lawrence and Schuyler was understated on prior publications of the October 2006 Temporary and Disability Statistics. The proper caseload data contained in this revision of November 2006 affects October 2006 Rest of State recipient data displayed on Tables 21 thru 23.

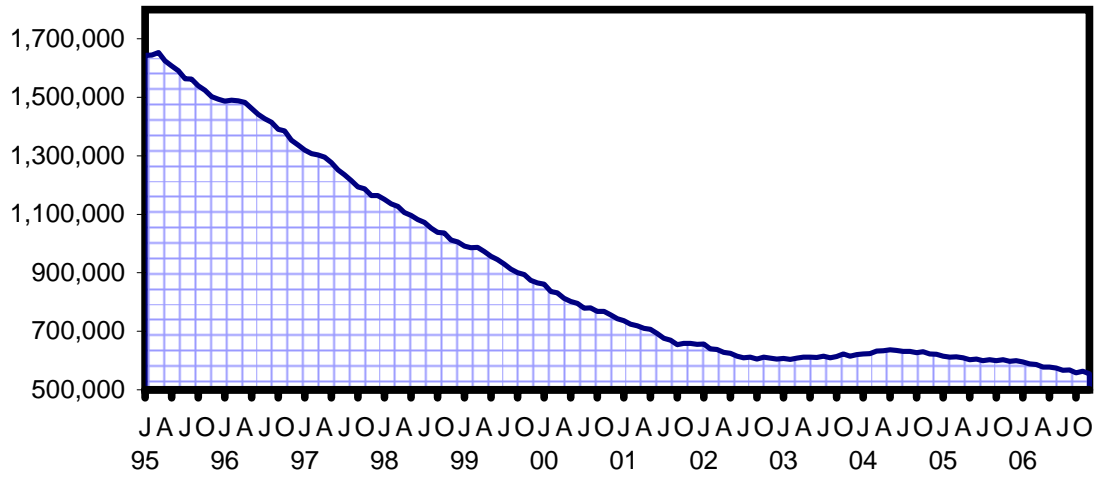

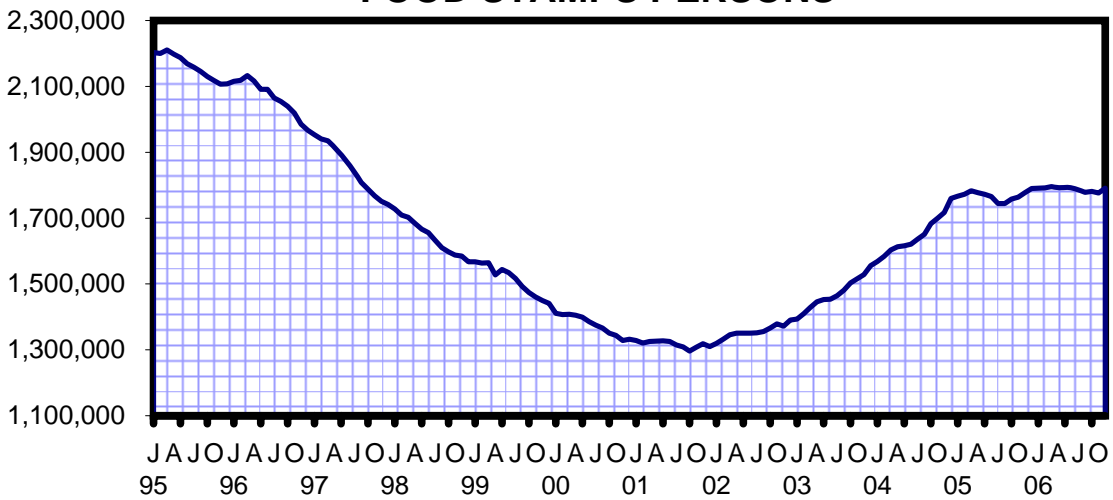

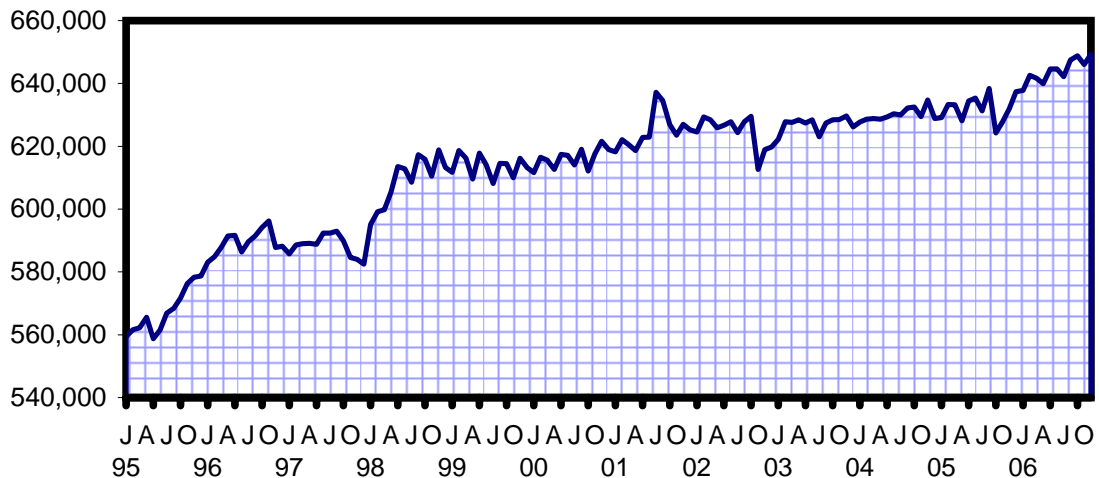
## TEMPORARY ASSISTANCE RECIPIENTS
