Temporary and Disability Assistance Statistics

DECEMBER 2006

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 554,998 in December 2006, increasing by 15 (+0.0%) from the previous month. Related expenditures totaled \$154,847,028 in December 2006 increasing by approximately \$4.3 million (+2.8%) over November 2006.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,799,460 in December 2006, increasing by 9,008 (+0.5%) over November 2006. Food Stamps expenditures totaled \$197,163,513 in December 2006, increasing approximately \$2.5 million (+1.3%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For December 2006, SSI recipients (including Mental Hygiene) totaled 643,951 decreasing 5,344 (-0.8%) from the previous month. SSI expenditures in December totaled \$321,262,427 decreasing approximately \$3.2 million (-1.0%) from November 2006.

The Calendar Year 2006 Annual Summary begins on page 32 of this issue.

Note: It was recently determined that the number of Temporary Assistance Cases, Recipients and Expenditures for the Rest of State Districts of Fulton, Livingston, St. Lawrence and Schuyler was understated on prior publications of the October 2006 Temporary and Disability Statistics. The proper caseload data contained in this revision of December 2006 affects October 2006 Rest of State recipient data displayed on Tables 21 thru 23.

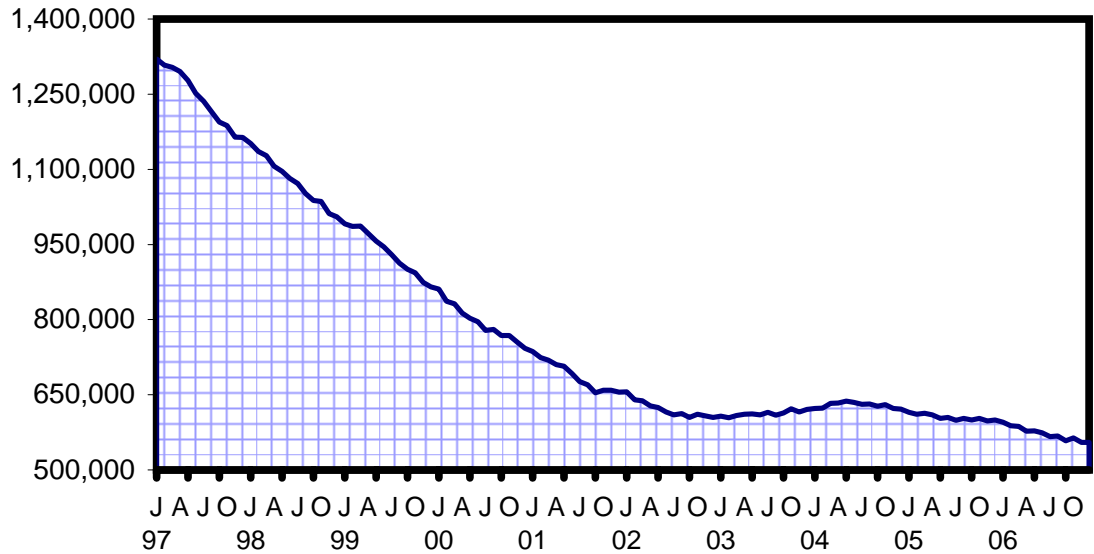

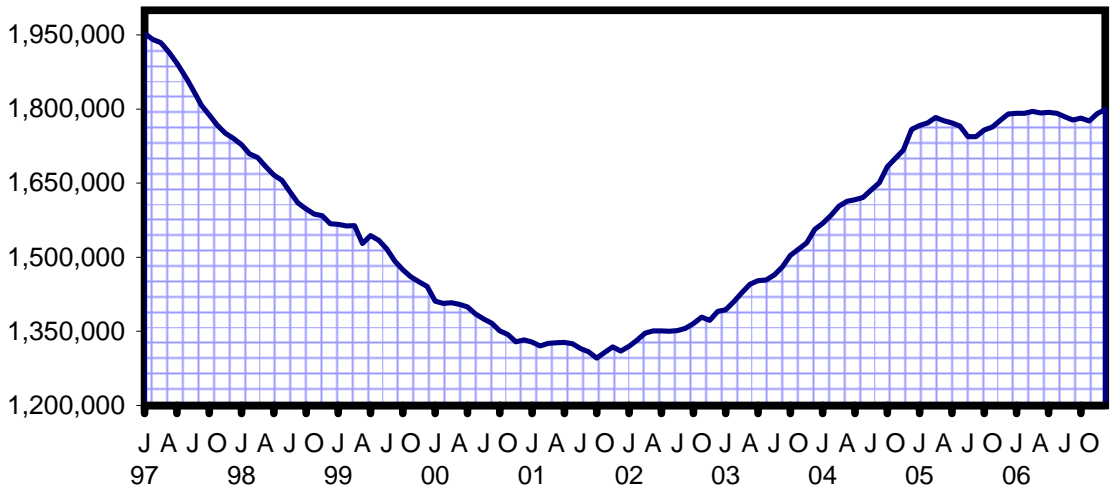

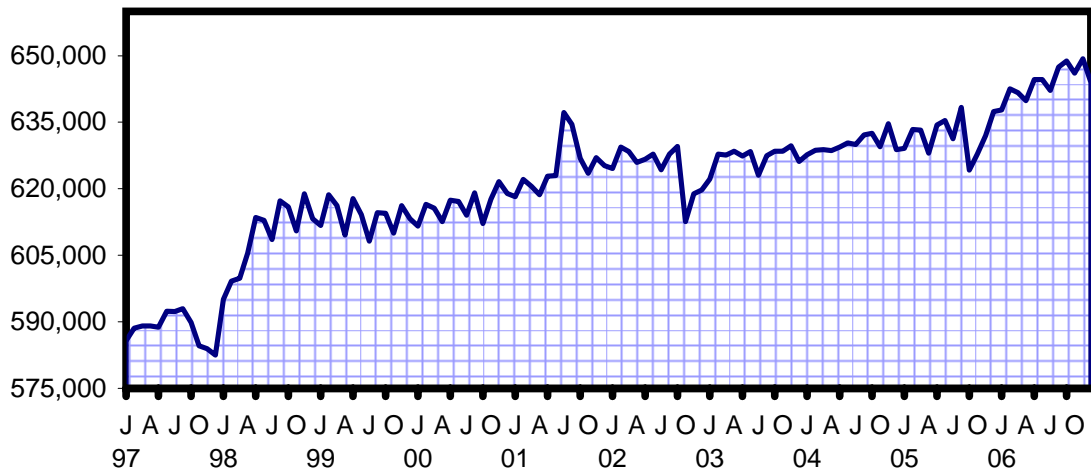
