Temporary and Disability Assistance Statistics June 2006

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 574,327 in June 2006, decreasing by 3,729 (-0.6%) from the previous month. Related expenditures totaled \$156,863,101 in June 2006, decreasing by approximately \$2.8 million (-1.8%) over May 2006.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,791,725 in June 2006, decreasing by 1,793 (-0.1%) over May 2006. Food Stamps expenditures totaled \$187,685,042 in June 2006, increasing by \$525,167 (+0.3%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For June 2006, SSI recipients (including Mental Hygiene) totaled 644,612 increasing 2 (+0.0%) from the previous month. SSI expenditures in June 2006 totaled \$322,621,330, decreasing by approximately \$6.9 million (-2.1%) from May 2006.

Note: This month's report contains new tables pertaining to the Home Energy Assistance Program and data related to the work activities of Temporary Assistance recipients. The Notice section on the following page provides a description of these tables and the reason for their inclusion.

Description of New Statistical Tables

Background

As part of the recent budget process, Section 133-aa of Social Services law was amended to require the Commissioner of the Office of Temporary and Disability Assistance to report additional data in *Temporary and Disability Assistance Statistics* pertaining to federal work participation rates and sanctions, earned income received by Temporary Assistance recipients, and the Home Energy Assistance Program (HEAP). What follows is a listing of the new tables containing these data, and a brief description of the contents of each. Like the other tables in this publication, the new tables present data at the local district level, as well as totals for New York State as a whole and for districts outside of New York City.

Table 25 provides summary data on HEAP from the beginning of the current Federal Fiscal Year (FFY) through June 2006, including the total number and dollar amount of benefits issued, and the local district administrative allocations for the program. Table 26 and Table 27 divide the total benefit counts and dollar amounts into specific categories. Table 26 covers the non-emergency benefit categories: regular autopay and regular non-emergency (application) benefits. Table 27 covers the emergency HEAP benefit categories: heat or heat related emergencies, furnace replacement, and furnace repair and replacement estimate benefits. Figures for pending applications for both regular and emergency benefits are not included in these tables, but will be added in subsequent months as counties authorize benefits.

Table 28: All Families Federal Work Participation Rates

Under the Temporary Assistance to Needy Families (TANF) program, states are required to have 50% of their adult headed TANF cases participating in work activities.¹ This table presents data on the federally required all families work participation rate, specifically the rates themselves and the numerators and denominators used to calculate the rates. While at this time only TANF cases are subject to the federal rate calculation, we have also included separate rates, numerators and denominators for Safety Net Maintenance of Effort (MOE) cases, as well as the combined TANF and Safety Net MOE

¹ This nominal 50% requirement can be reduced by the percentage point decrease in a state's TANF caseload since FFY 1994, net of eligibility changes made since that time. Because of the large TANF caseload decreases we have experienced over this period, this "caseload reduction credit" has effectively reduced our participation rate requirement to 0%. However, as part of the Deficit Reduction Act of 2005, which takes effect in FFY 2007, the base year for calculation of the caseload reduction credit was changed to FFY 2005, so the State will be subject to substantially increased rate targets in that year.

totals. We have done this for two reasons. First, beginning in FFY 2007 Safety Net MOE cases will be included in the federal calculation along with the TANF cases. Second, districts are eligible for financial incentives for meeting separate TANF and Safety Net MOE participation rate goals. Including both sets of rates allows monitoring of progress for both of these purposes.

It is important to note that the source of participation data in Table 28 and sanction data in Table 29 varies by geography. Federal work participation rates are calculated from statistical samples submitted to the U.S. Department of Health and Human Services on a quarterly basis, usually 90 days following the target quarter. Because these samples are designed to produce reliable estimates on a statewide basis, there is insufficient sample to produce reliable local district estimates for all jurisdictions. As a result, only the New York State and New York City rates and related data are based on the official sample data, while data for the other districts are derived directly from automated systems. Because of delays in compiling sample data, the most recently available New York State and New York City data for this month's report are derived from the first calendar quarter of 2006. The data for the other local districts pertain to the same month as the preexisting tables in the report, June 2006. Please note that because of these geographical differences in data sources and timing, local district data will not add to the New York State total.

Table 29: Work Sanction Status by Presence in Federal All Families Work Participation Calculation

Under federal work participation rules, states can remove a case from the work participation rate calculation if the adult or adults in the case are in sanction status for failure to comply with employment rules, for up to three months in any 12 month period. Table 29 provides data on the number of work sanctioned cases removed from the participation denominator due to this provision, and the number of work related sanctioned cases *in* the denominator (work sanctioned persons can be in the denominator if their sanction has exceeded the three month limit and/or if they are satisfactorily participating in work activities). As was the case with Table 28, we have included data for TANF, Safety Net MOE and the combined total, although such rules do not technically apply to the Safety Net MOE group until FFY 2007.

As was mentioned above, Table 29, like Table 28, employs the federal reporting samples to derive New York State and New York City counts, while data for the remainder of the districts are derived from automated systems.² Again, district counts will not total to the statewide count.

Table 30: Temporary Assistance Cases with Earned Income

Table 30 reports the number of Temporary Assistance cases with earned income, the average gross earned income amount, and the average net earned income amount after

² For New York City and New York State calculations it was necessary to combine some systems data with the sample data to determine sanction status.

the application of the relevant earned income disregards. In New York State a substantial portion of income earned by Temporary Assistance recipients is disregarded for the purposes of calculating their case's cash grant, including the first \$90 earned and 45% of remaining earnings up to the poverty level for their household size. These data are provided for the TANF, Safety Net MOE and Safety Net Non-MOE case classifications, and are derived from point in time end of month extracts from the New York City and rest of state Welfare Management Systems and Automated Budget Eligibility Logic Systems.

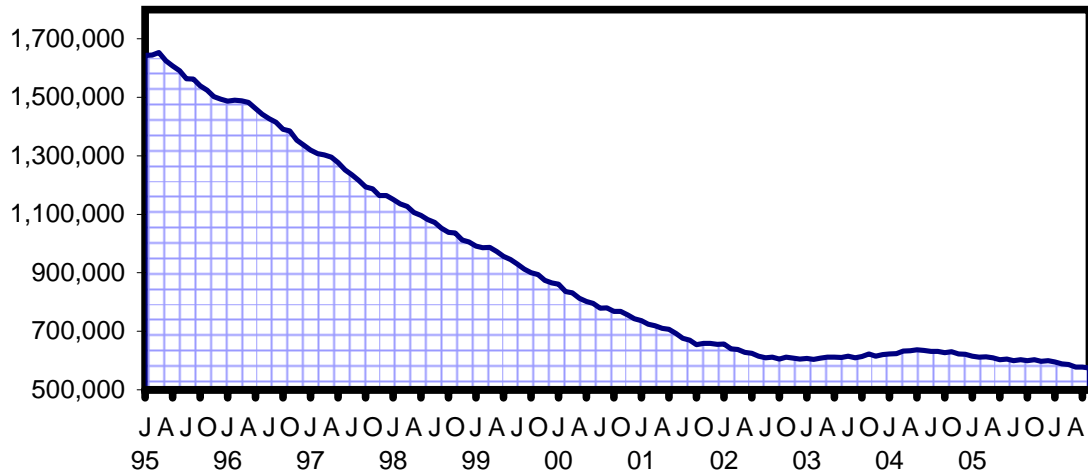

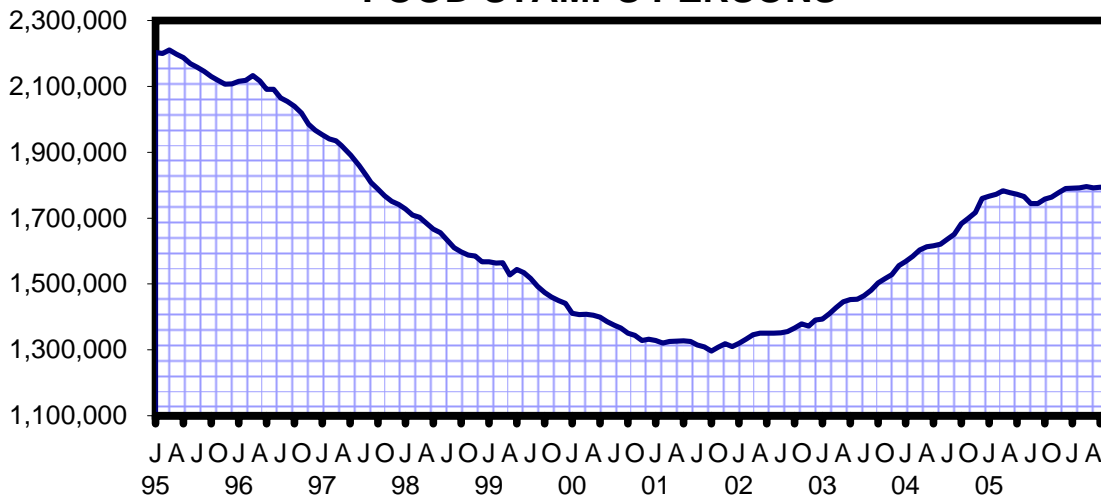

NEW YORK STATE JANUARY 1995 - JUNE 2006

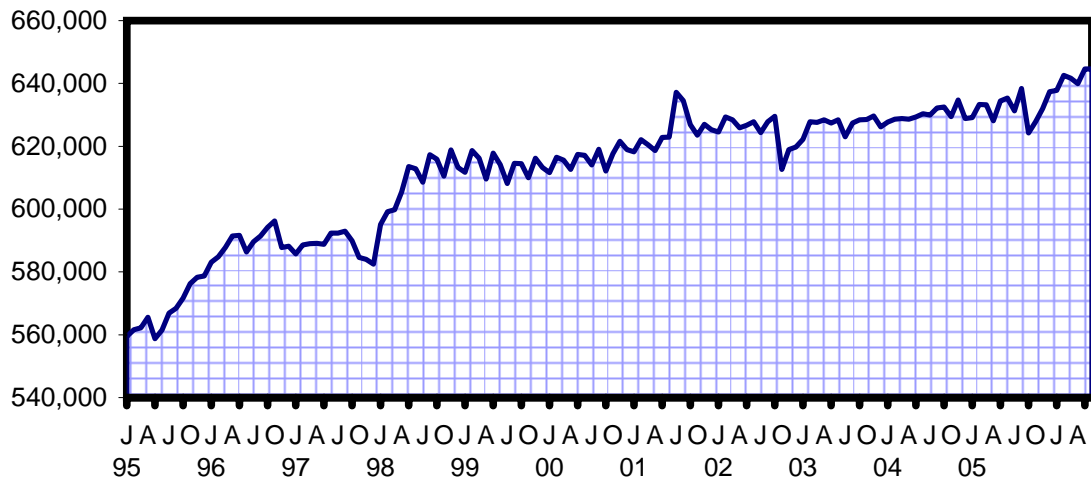
TEMPORARY ASSISTANCE RECIPIENTS
