Temporary and Disability Assistance Statistics MARCH 2006

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 586,948 in March 2006, decreasing by 1,324 (-0.2%) from the previous month. Related expenditures totaled \$164,241,445 in March 2006, increasing by approximately \$8.8 million (+5.6%) over February 2006.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,795,518 in March 2006, increasing by 3,779 (+0.2%) over February 2006. Food Stamps expenditures totaled \$189,430,431 in March 2006, increasing by approximately \$2.9 million (+1.6%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For March 2006, SSI recipients (including Mental Hygiene) totaled 641,638, decreasing 919 (-0.1%) from the previous month. SSI expenditures in March totaled \$328,786,639, increasing by \$5,514 (+1.9%) from February 2006.

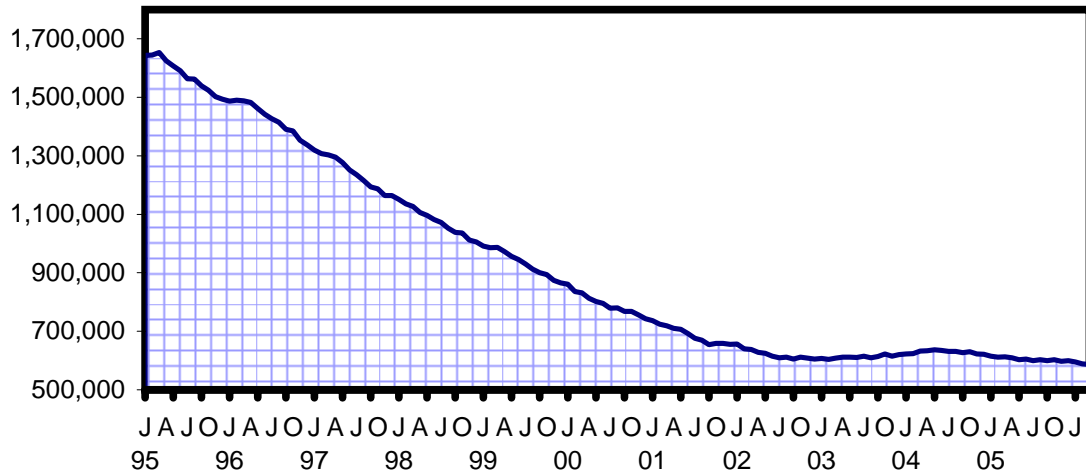

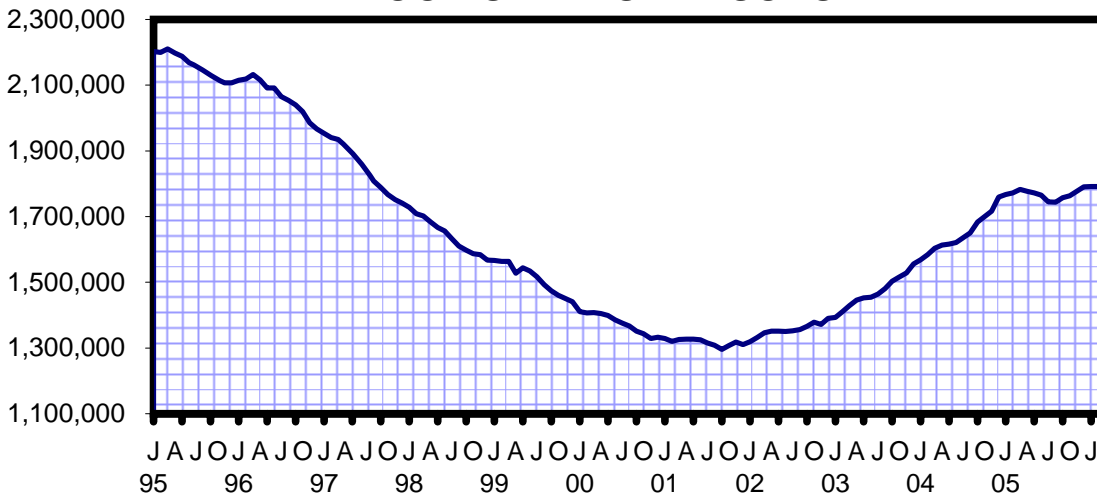

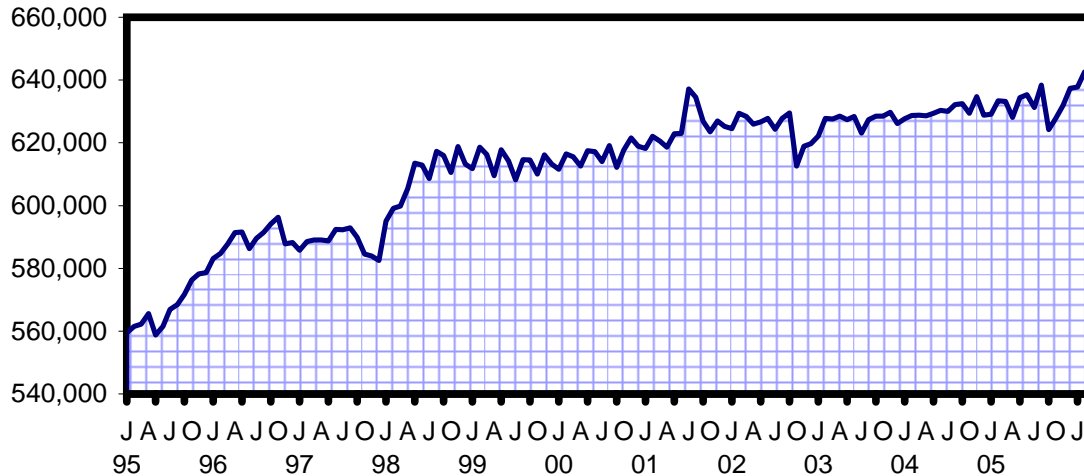
TEMPORARY ASSISTANCE RECIPIENTS
