Temporary and Disability Assistance Statistics MARCH 2007

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 542,506 in March 2007, increasing by 1,003 (+0.2%) from the previous month. Related expenditures totaled \$153,788,538 in March 2007 increasing by approximately \$4.7 million (+3.2%) over February 2007.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,810,094 in March 2007, increasing by 6,778 (+0.4%) over February 2007. Food Stamps expenditures totaled \$195,607,232 in March 2007, increasing approximately \$3.5 million (+1.8%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For March 2007, SSI recipients (including Mental Hygiene) totaled 647,729 decreasing 825 (-0.1%) from the previous month. SSI expenditures in March totaled \$336,991,837 decreasing by \$130,124 (-0.0%) from February 2007.

Note: It was recently determined that the number of Temporary Assistance Cases, Recipients and Expenditures for the Rest of State Districts of Fulton, Livingston, St. Lawrence and Schuyler was understated on prior publications of the October 2006 Temporary and Disability Statistics. The proper caseload data contained in this revision of March 2007 affects October 2006 Rest of State recipient data displayed on Tables 21 thru 23.

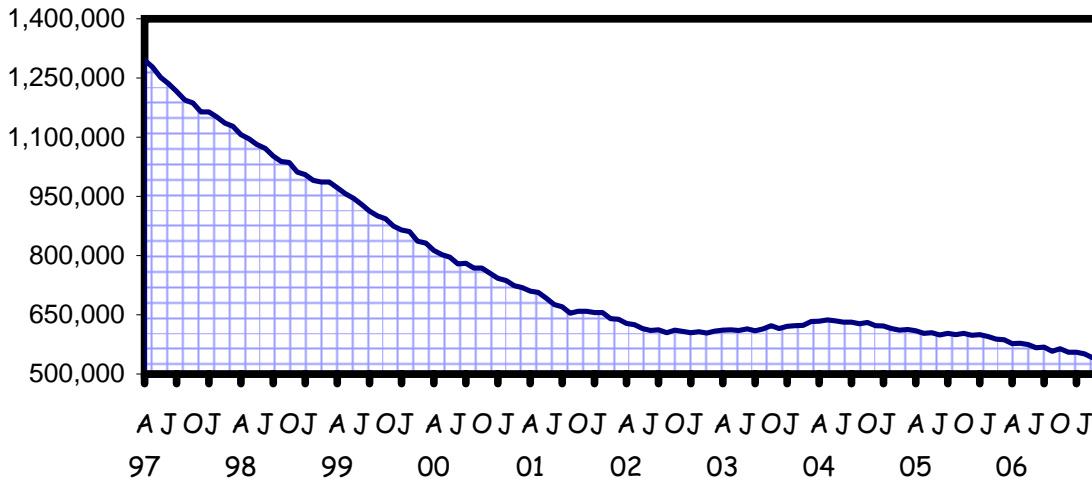

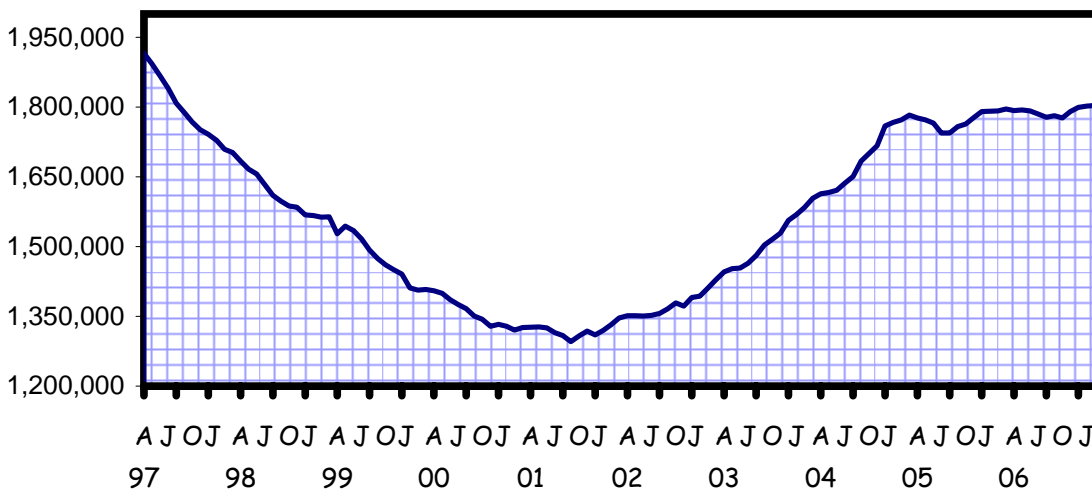

TEMPORARY ASSISTANCE RECIPIENTS

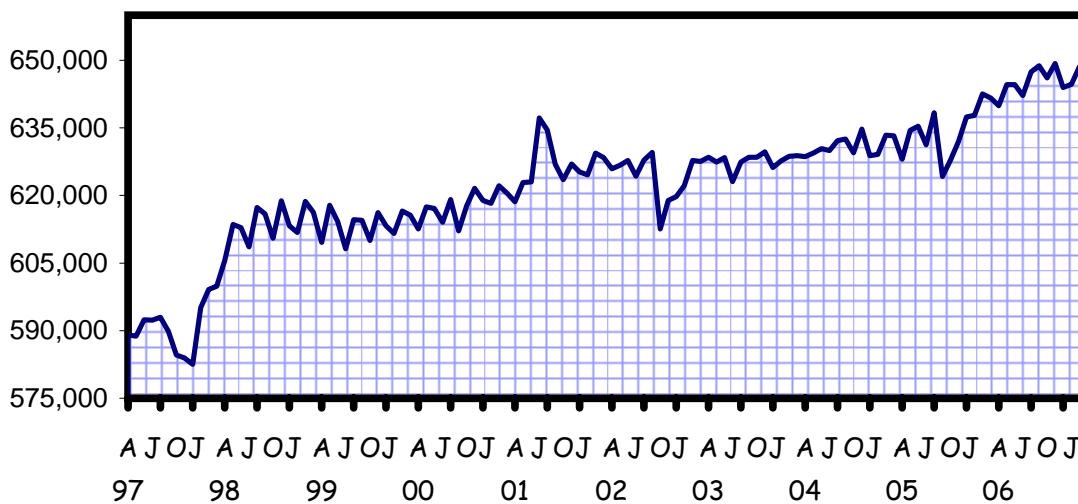


FOOD STAMPS PERSONS
