# Temporary and Disability Assistance Statistics

## SEPTEMBER 2007

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 516,826 in September 2007, decreasing by 12,695 (-2.4%) from the previous month. Related expenditures totaled \$142,370,771 in September 2007 decreasing by approximately \$10.3 million (-6.7%) over August 2007.

### Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,823,494 in September 2007, increasing by 6,689 (+0.4%) over August 2007. Food Stamps expenditures totaled \$196,385,743 in September 2007, decreasing by \$102,850 (-0.1%) over the previous month.

### Supplemental Security Income

Supplemental Security Income: For September 2007, SSI recipients (including Mental Hygiene) totaled 652,098 increasing 1,396 (+0.2%) from the previous month. SSI expenditures in September totaled \$340,331,795 increasing by \$856,537 (+0.3%) from August 2007.

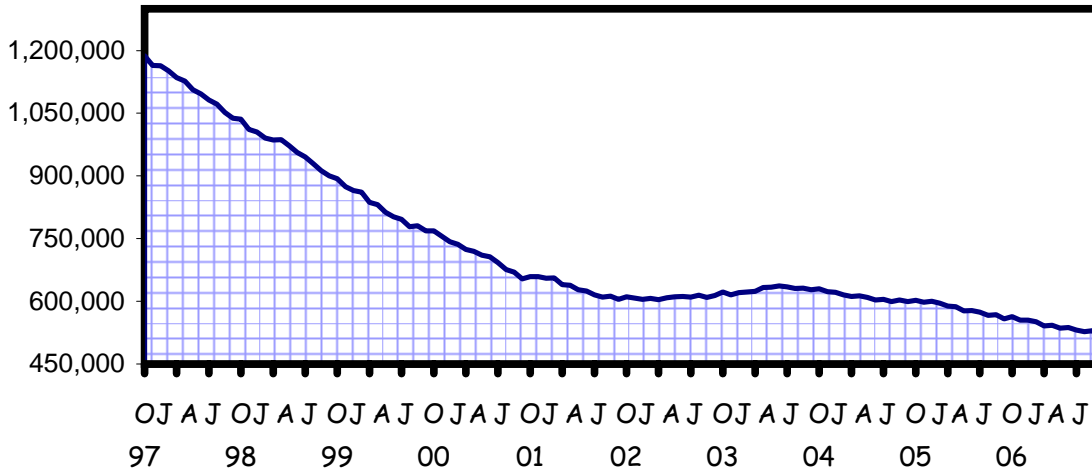

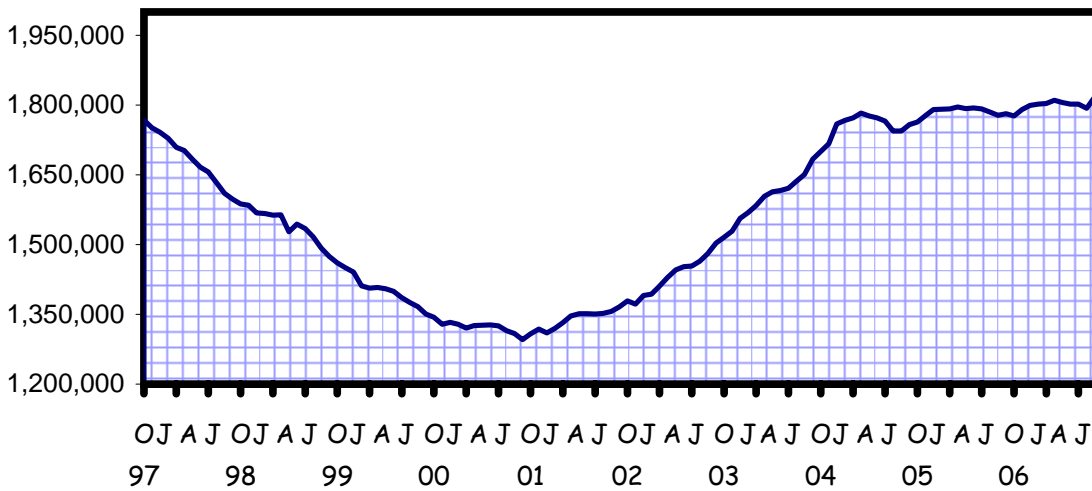

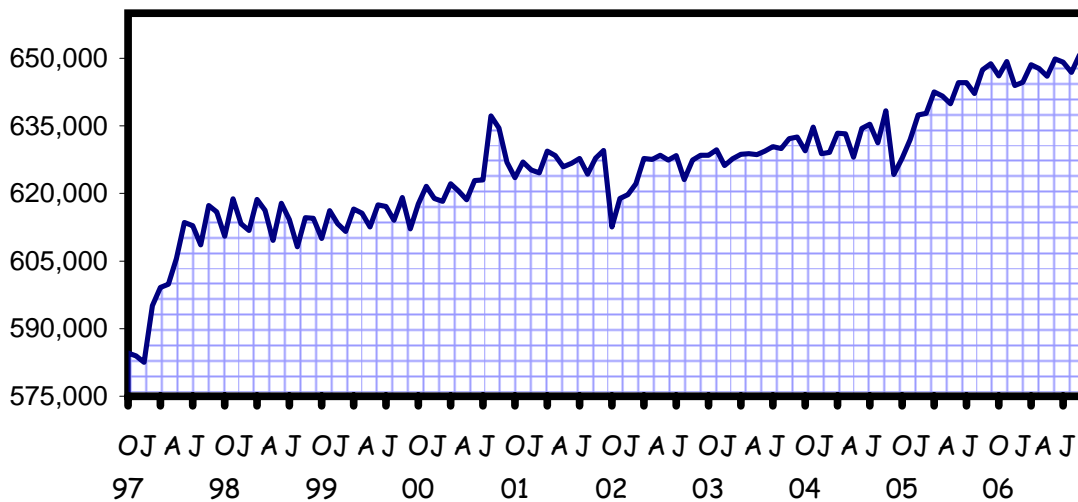


## FOOD STAMPS PERSONS
