# Temporary and Disability Assistance Statistics

## OCTOBER 2007

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 522,921 in October 2007, increasing by 6,095 (+1.2%) from the previous month. Related expenditures totaled \$151,274,693 in October 2007 increasing by approximately \$8.9 million (+6.3%) over September 2007.

### Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,825,759 in October 2007, increasing by 2,265 (+0.1%) over September 2007. Food Stamps expenditures totaled \$209,999,177 in October 2007, increasing by approximately \$13.6 million (+6.9%) over the previous month.

### Supplemental Security Income

Supplemental Security Income: For October 2007, SSI recipients (including Mental Hygiene) totaled 649,462 decreasing 2,636 (-0.4%) from the previous month. SSI expenditures in October totaled \$341,853,503 increasing by approximately \$1.5 million (+0.4%) from September 2007.

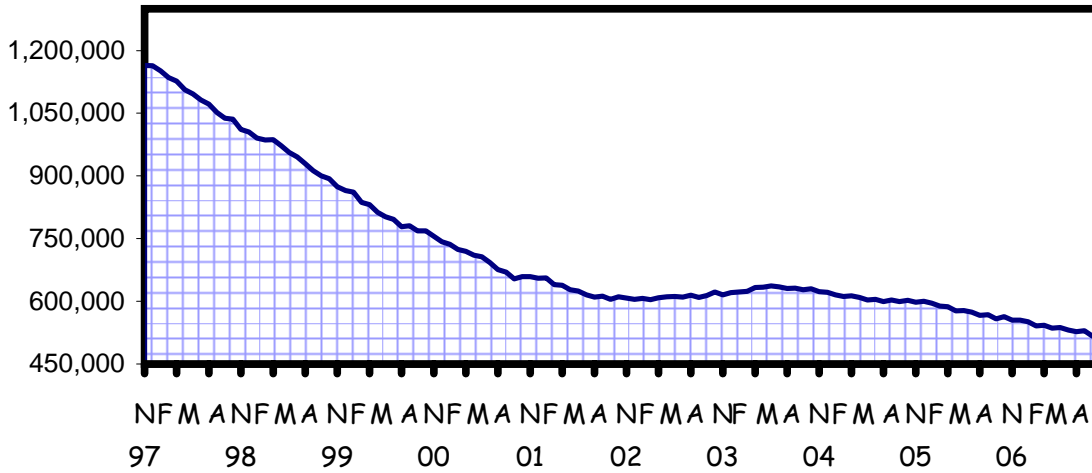

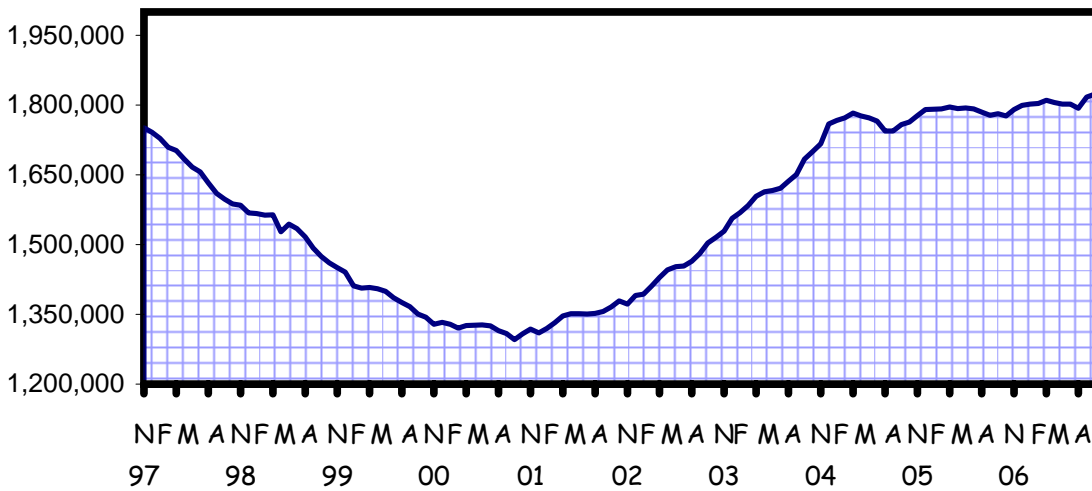

TEMPORARY ASSISTANCE RECIPIENTS**

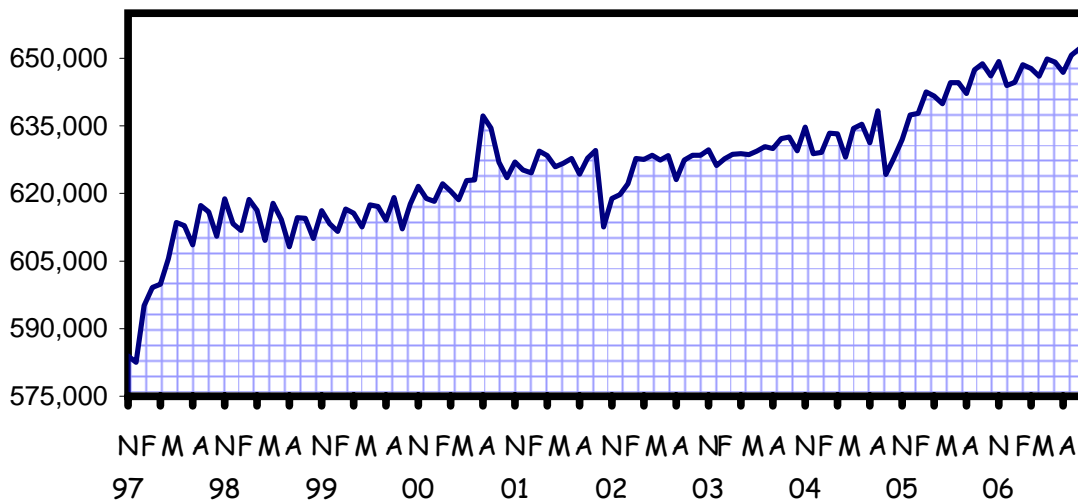


**FOOD STAMPS PERSONS**
