NOVEMBER 2007

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 519,414 in November 2007, decreasing by 3,507 (-0.7%) from the previous month. Related expenditures totaled \$156,619,763 in November 2007 increasing by approximately \$5.3 million (+3.5%) over October 2007.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,830,858 in November 2007, increasing by 5,099 (+0.3%) over October 2007. Food Stamps expenditures totaled \$209,645,391 in November 2007, decreasing by \$353,786 (-0.2%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For November 2007, SSI recipients (including Mental Hygiene) totaled 653,651 increasing 4,189 (+0.6%) from the previous month. SSI expenditures in November totaled \$342,065,983 increasing by \$212,480 (+0.1%) from October 2007.

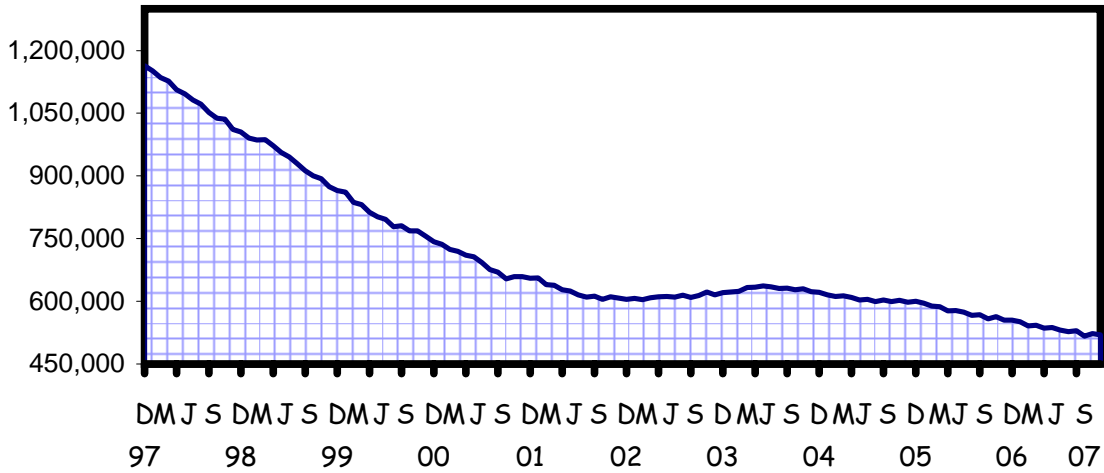

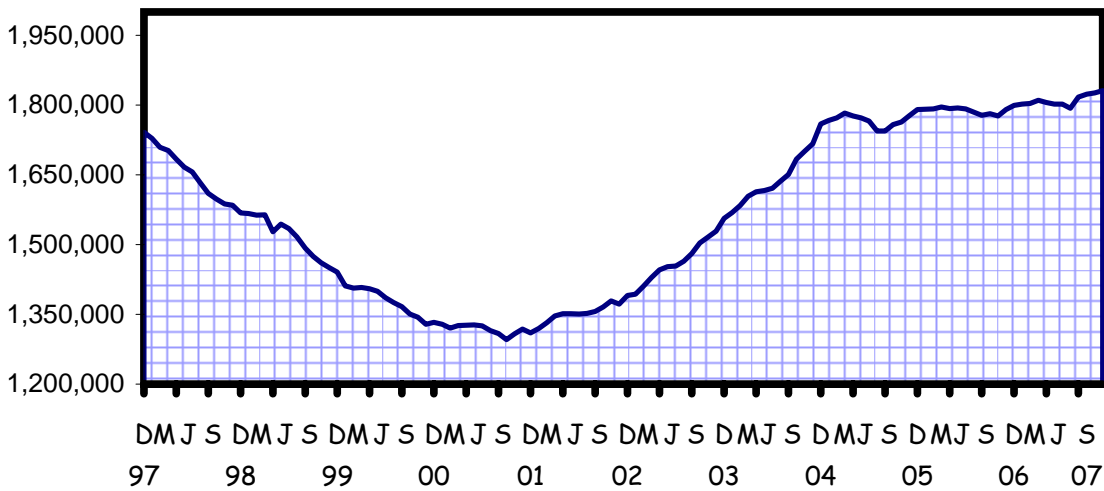

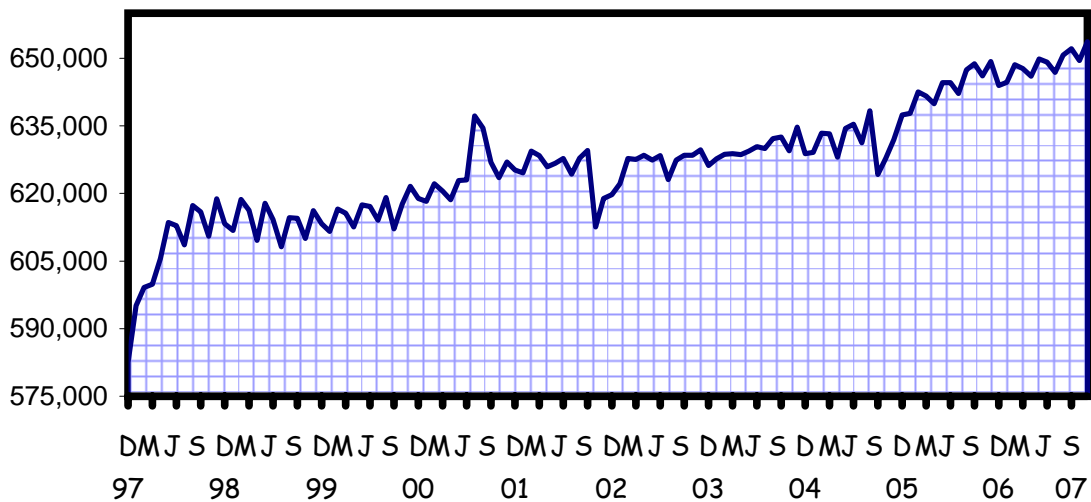


FOOD STAMPS PERSONS
