May 2008

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 513,736 in May 2008, decreasing by 955 (-0.2%) from the previous month. Related expenditures totaled \$158,294,971 in May 2008, decreasing by approximately \$37 million (-18.9%) over April 2008. This expenditure decrease is mostly due to the fact April expenditures were inflated by one-time payments associated with setting litigation related to the budgeting of Temporary Assistance households containing an SSI recipient.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 1,986,156 in May 2008, increasing by 90,560 (+4.8%) over April 2008. Food Stamps expenditures totaled \$217,064,764 in May 2008, increasing by approximately \$1.7 million (+0.8%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For May 2008, SSI recipients (including Mental Hygiene) totaled 654,955, increasing 3,877 (+0.6%) from the previous month. SSI expenditures in May 2008 totaled \$352,497,444, decreasing by \$175,861 (-0.1%) from April 2008.

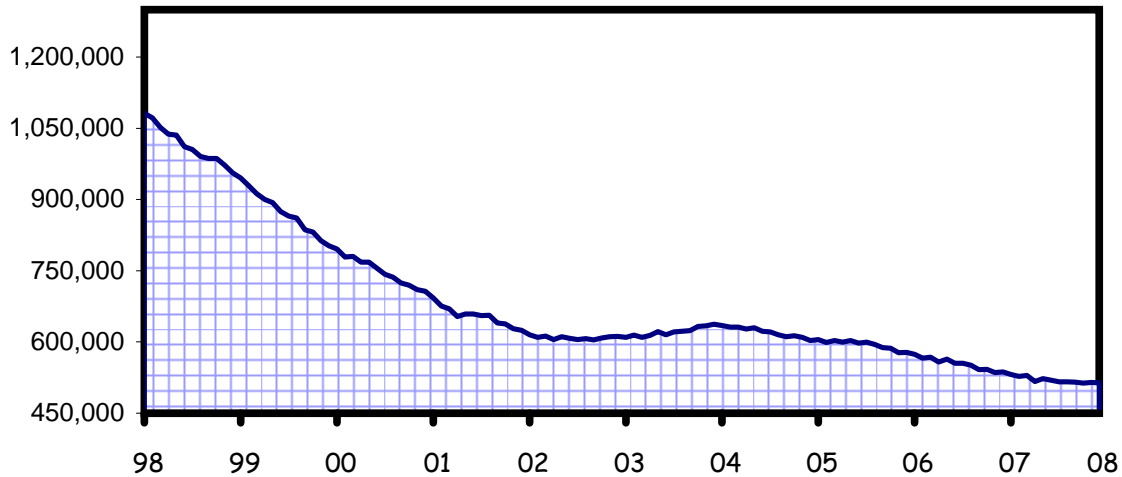

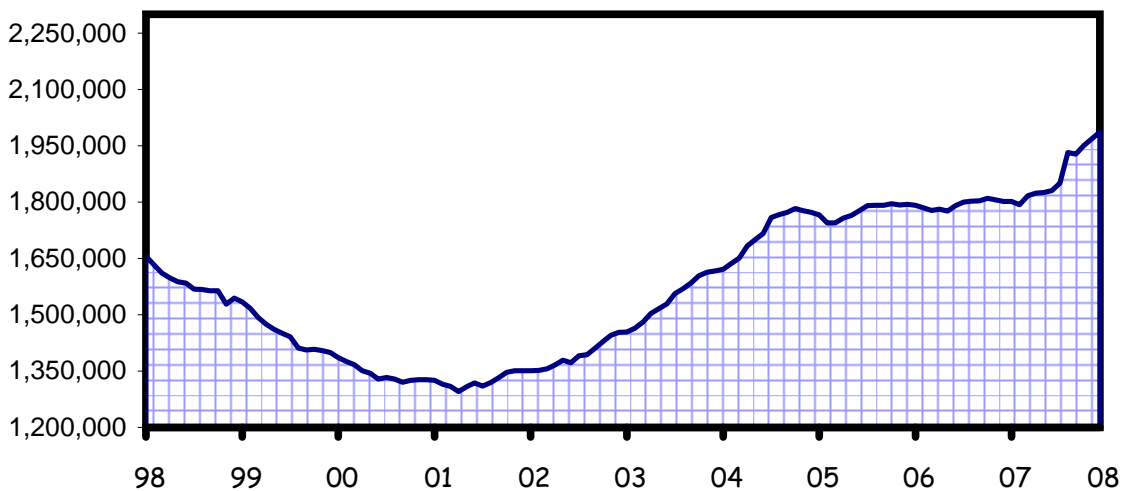

TEMPORARY ASSISTANCE RECIPIENTS

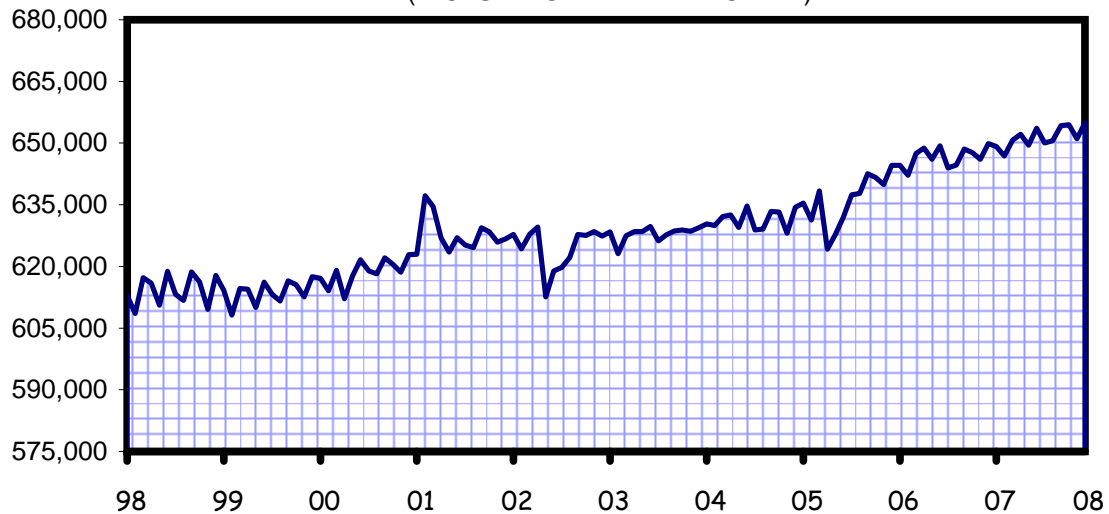


FOOD STAMPS RECIPIENTS
