Temporary and Disability Assistance Statistics

FEBRUARY 2009

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 516,840 in February 2009, increasing by 4,628 (+0.9%) from the previous month. Related expenditures totaled \$161,152,184 in February 2009, increasing by approximately \$4.1 million (+2.6%) over January 2009.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,246,664 in February 2009, increasing by 34,729 (+1.6 %) over January 2009. Food Stamps expenditures totaled \$299,977,023 in February 2009, increasing by approximately \$21.0 million (+7.5%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For February 2009, SSI recipients (including Mental Hygiene) totaled 664,552 increasing by 5,207 (+0.8%) from the previous month. SSI expenditures in February 2009, totaled \$376,303,985 increasing by approximately \$11.6 million (+3.2%) from January 2009.

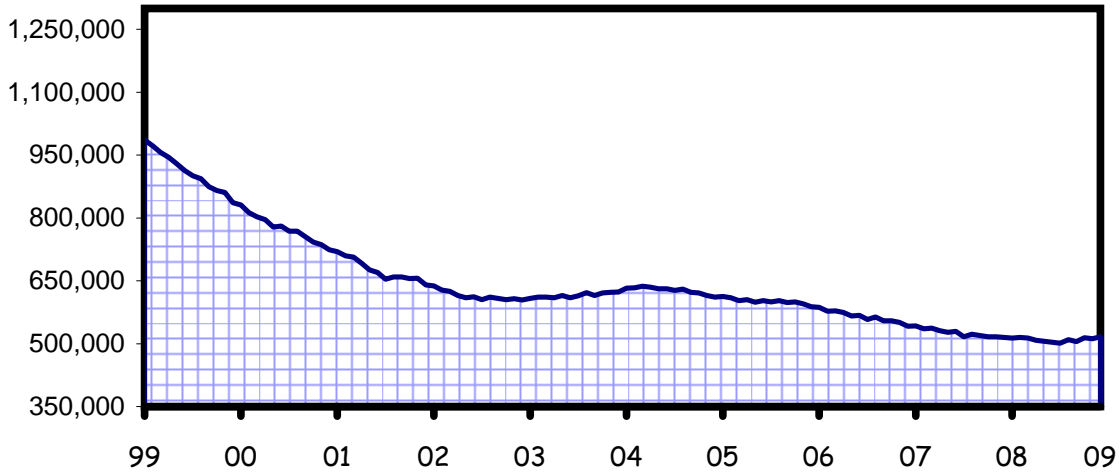

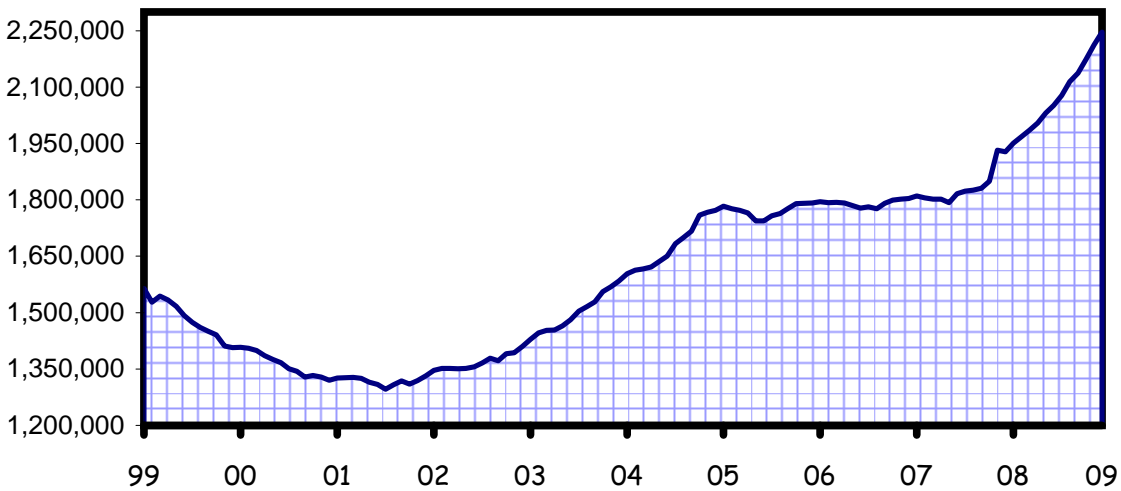

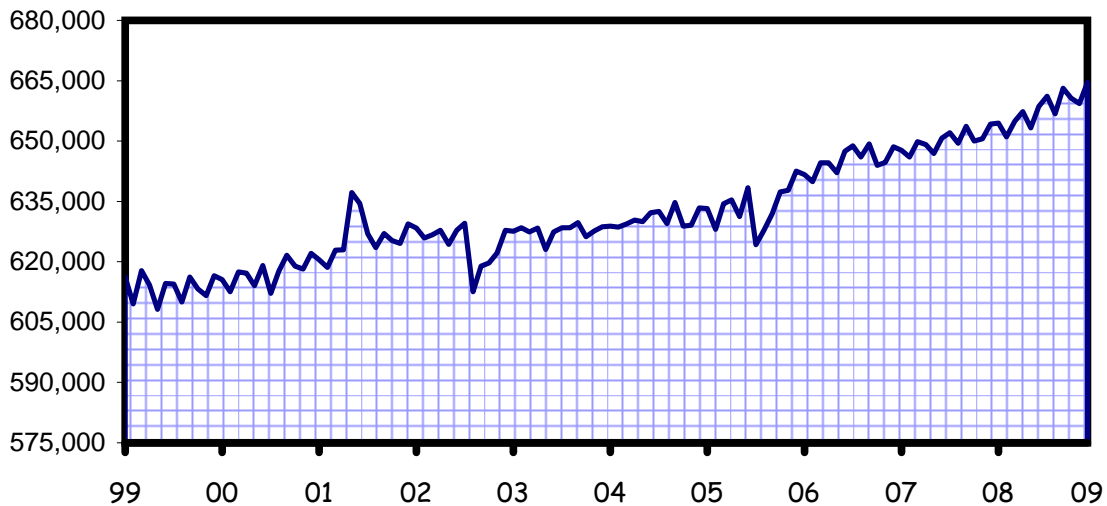
