# Temporary and Disability Assistance Statistics

## **APRIL 2009**

---

### Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 520,609 in April 2009, increasing by 467 (+0.1%) from the previous month. Related expenditures totaled \$164,469,180 in April 2009, increasing by \$703,791 (+0.4%) over March 2009.

### Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,339,118 in April 2009, increasing by 44,015 (+1.9 %) over March 2009. Food Stamps expenditures totaled \$359,548,386 in April 2009, increasing by approximately \$52 million (+16.9%) over the previous month.

### Supplemental Security Income

Supplemental Security Income: For April 2009, SSI recipients (including Mental Hygiene) totaled 661,742 decreasing by 4,049 (-0.6%) from the previous month. SSI expenditures in April 2009, totaled \$372,555,382 decreasing by approximately \$4.3 million (-1.1%) from March 2009.

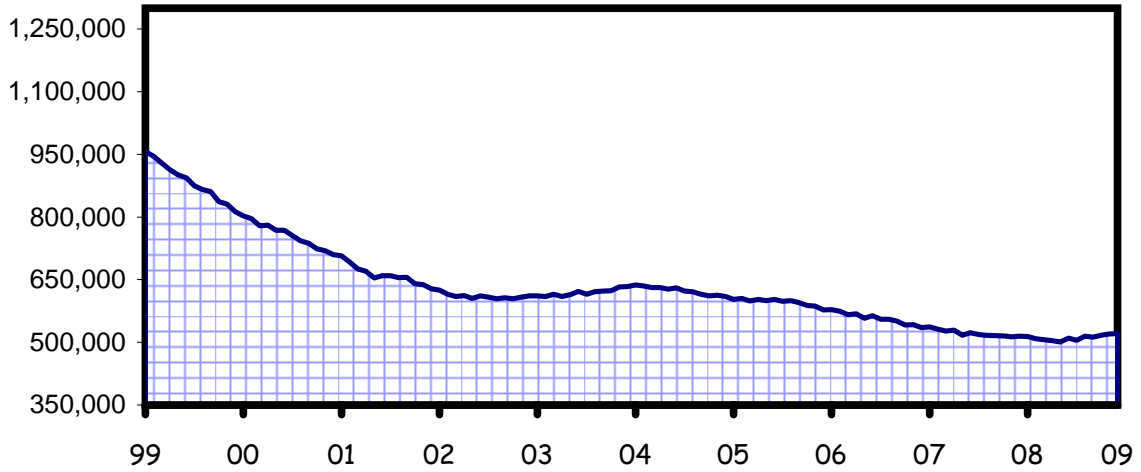

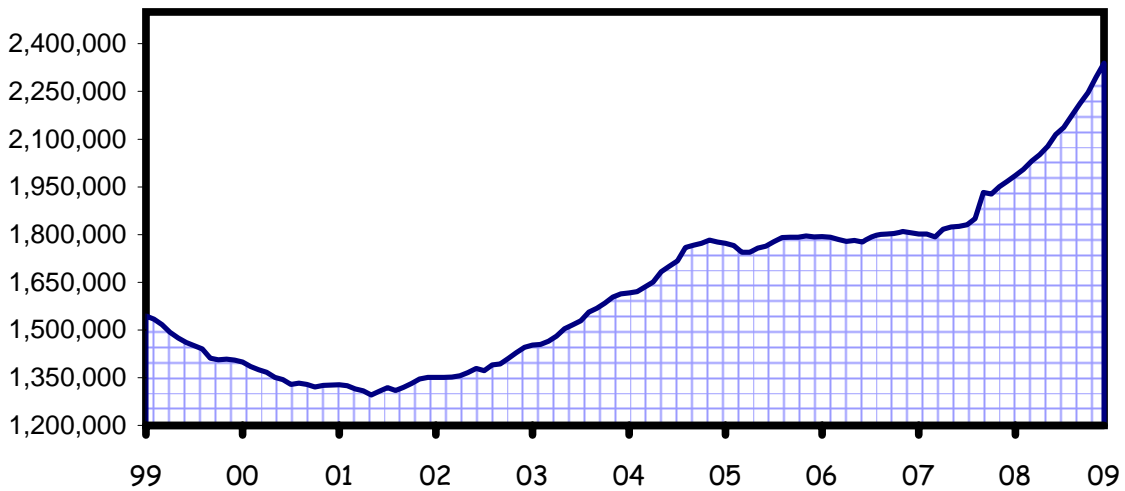

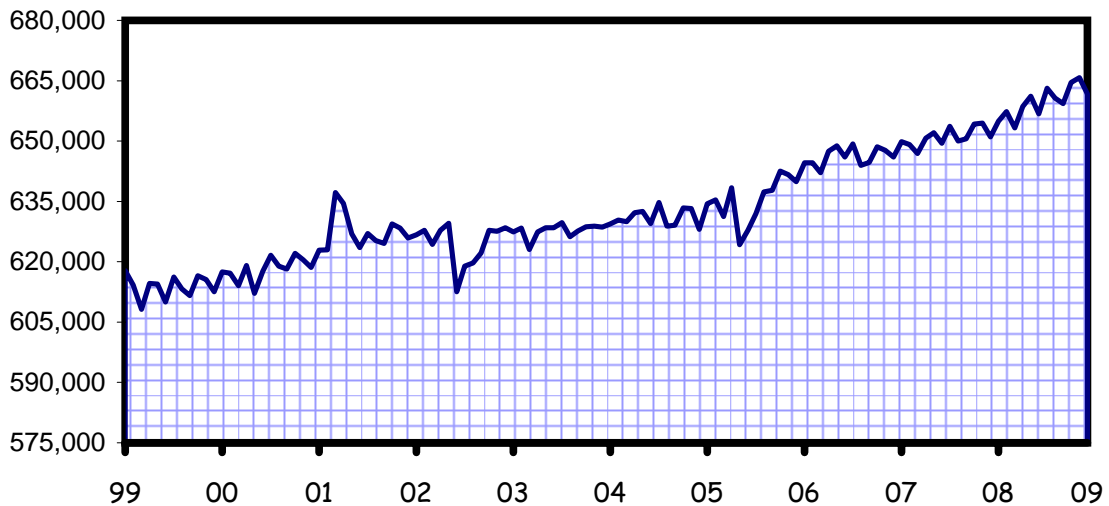
