Temporary and Disability Assistance Statistics

SEPTEMBER 2009

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 535,250 in September 2009, increasing by 4,587 (+0.9%) from the previous month. Related expenditures totaled \$169,578,116 in September 2009, increasing by approximately \$4.1 million (+2.5%) over August 2009.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,555,081 in September 2009, increasing by 46,197 (+1.8%) over August 2009. Food Stamps expenditures totaled \$390,776,412 in September 2009, increasing by approximately \$7.0 million (+1.8%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For September 2009, SSI recipients (including Mental Hygiene) totaled 661,734 decreasing by 8,583 (-1.3%) from the previous month. SSI expenditures in September 2009, totaled \$371,664,806 decreasing by approximately \$7.4 million (-2.0%) from August 2009.

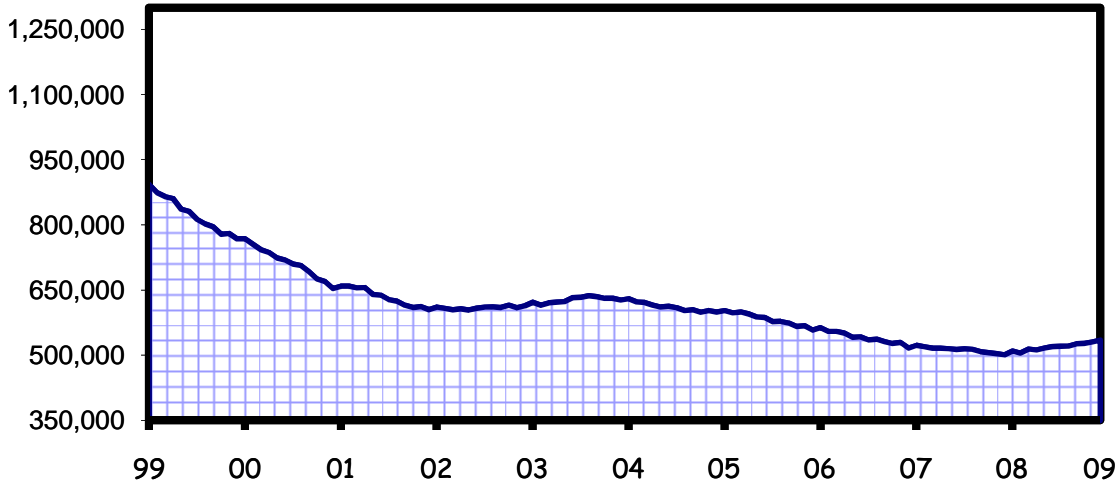

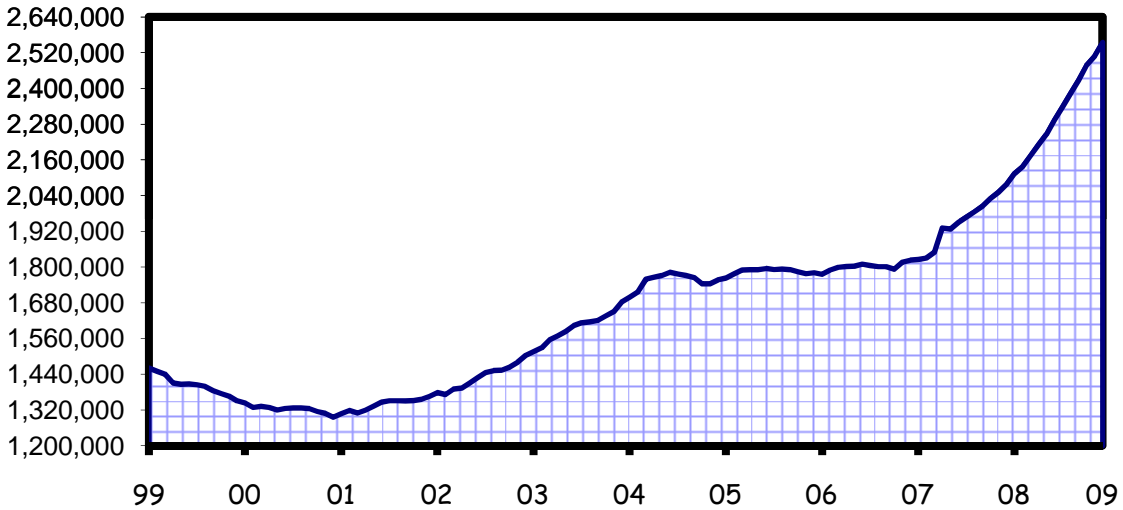

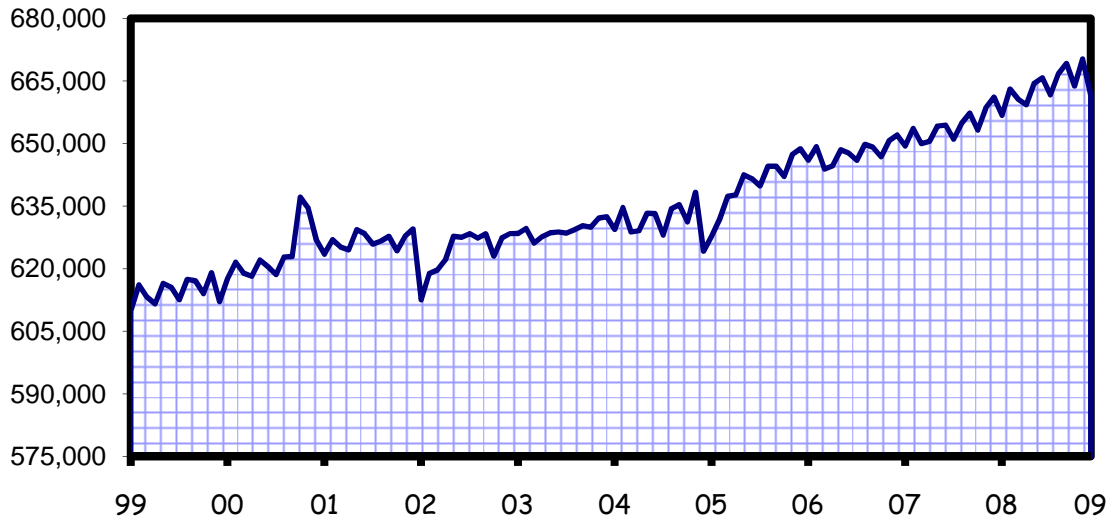
