Temporary and Disability Assistance Statistics **NOVEMBER 2009**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 543,992 in November 2009, decreasing by 620 (-0.1%) from the previous month. Related expenditures totaled \$166,980,907 in November 2009, decreasing by approximately \$6.7 million (-3.9%) over October 2009.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,623,264 in November 2009, increasing by 23,326 (+0.9%) over October 2009. Food Stamps expenditures totaled \$399,025,038 in November 2009, increasing by \$941,065 approximately (+0.2%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For November 2009, SSI recipients (including Mental Hygiene) totaled 674,646, increasing by 7,254 (+1.1%) from the previous month. SSI expenditures in November 2009 totaled \$384,573,376, increasing by approximately \$10.4 million (+2.8%) from October 2009.

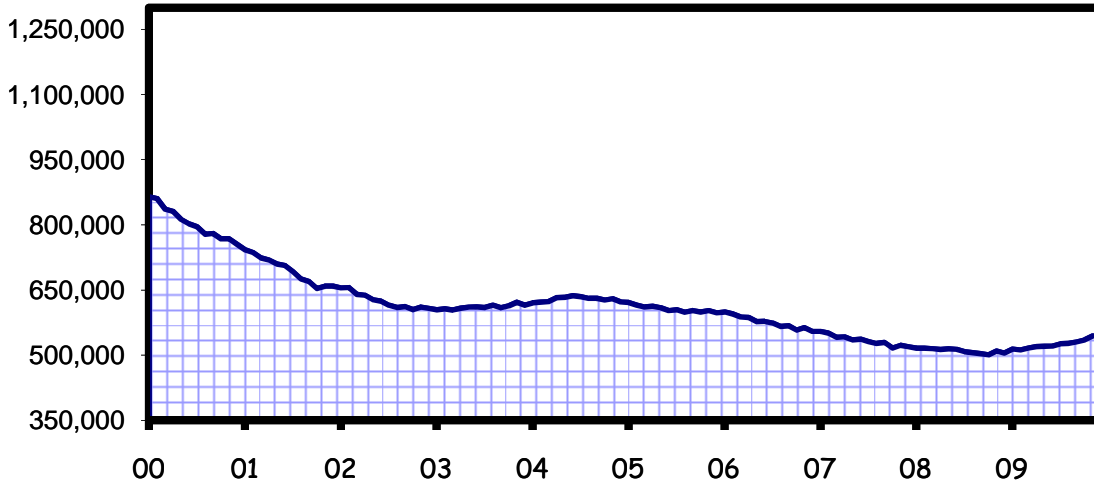

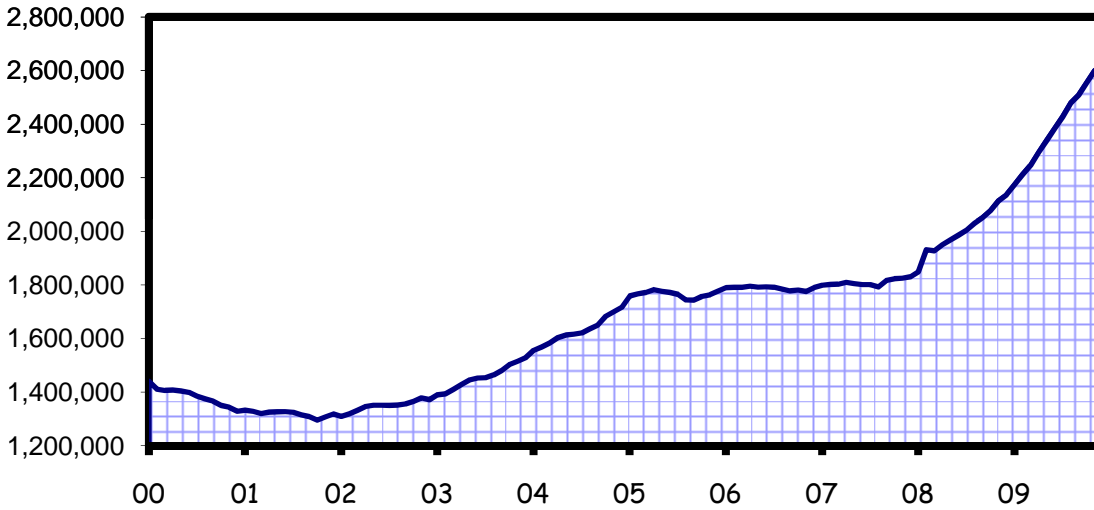

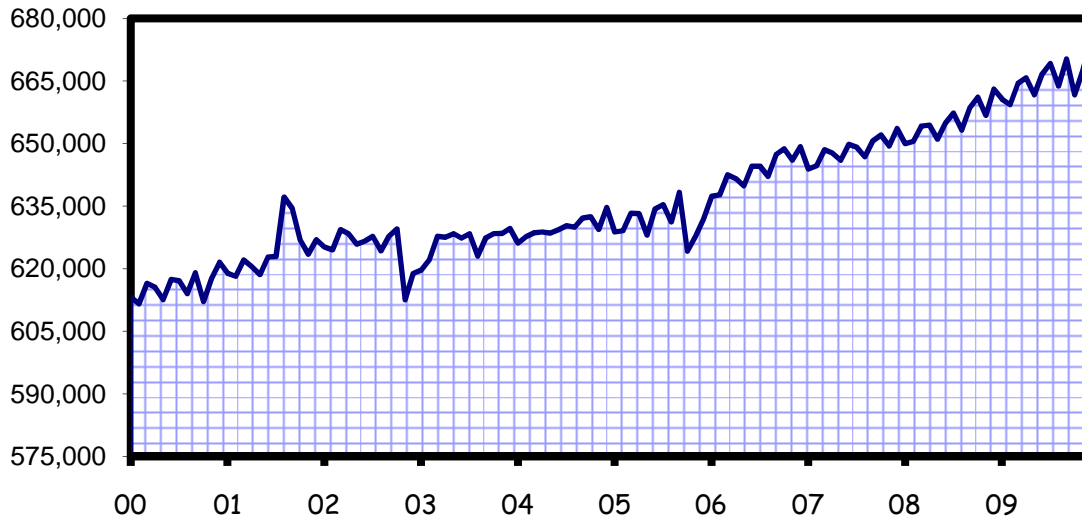
