# Temporary and Disability Assistance Statistics **DECEMBER 2009**

---

## Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 553,405 in December 2009, increasing by 9,413 (+1.7%) from the previous month. Related expenditures totaled \$180,340,849 in December 2009, increasing by approximately \$13.4 million (+8.0%) over November 2009.

## Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,673,143 in December 2009, increasing by 49,879 (+1.9%) over November 2009. Food Stamps expenditures totaled \$406,738,827 in December 2009, increasing by approximately \$7.7 million (+1.9%) over the previous month.

## Supplemental Security Income

Supplemental Security Income: For December 2009, SSI recipients (including Mental Hygiene) totaled 672,435, decreasing by 2,211 (-0.3%) from the previous month. SSI expenditures in December 2009 totaled \$381,711,174, decreasing by approximately \$2.9 million (-0.7%) from November 2009.

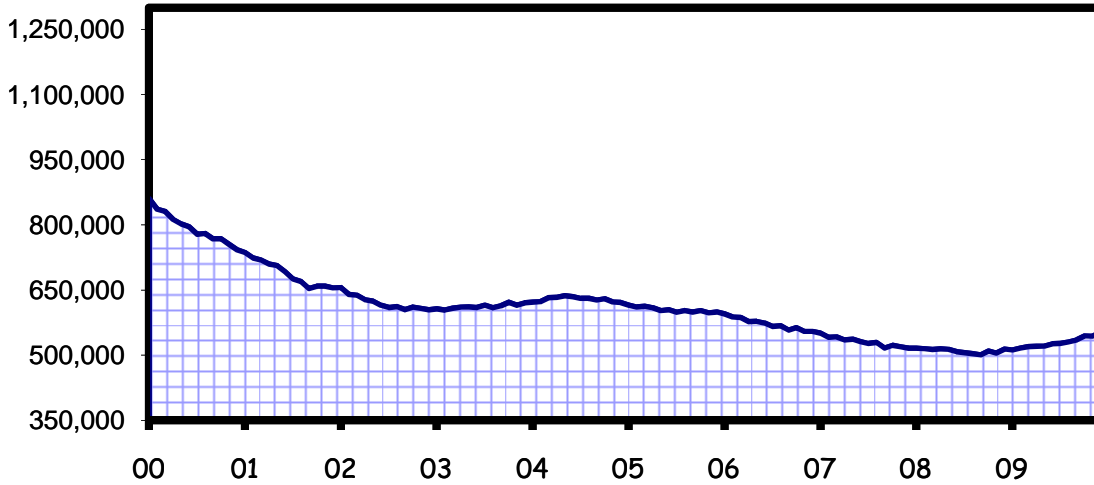

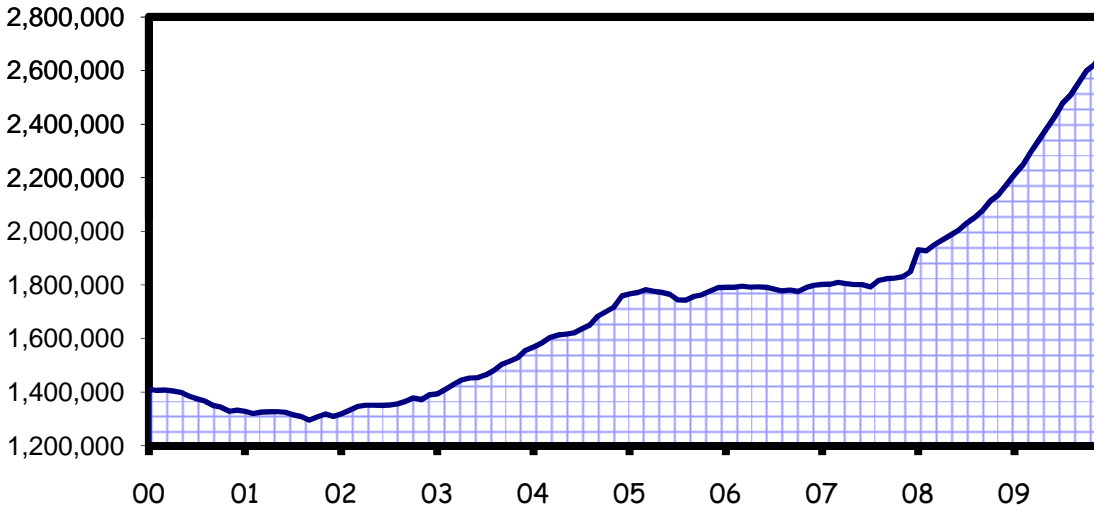

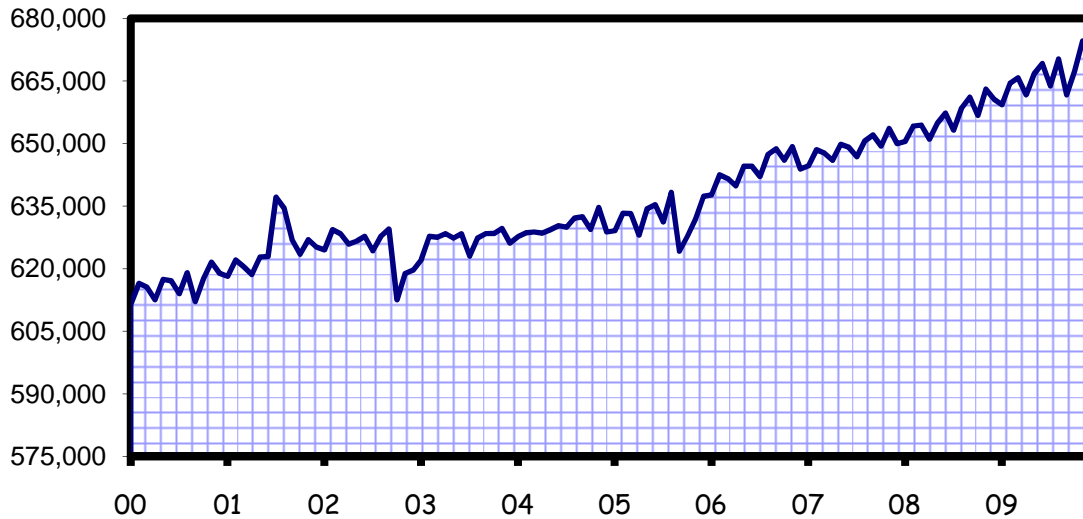
