# Temporary and Disability Assistance Statistics **JULY 2010**

---

## Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 541,275 in July 2010, decreasing by 1,728 (-0.3%) from the previous month. Related expenditures totaled \$175,507,534 in July 2010, increasing by \$594,803 (+0.3%) over June 2010.

## Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,860,394 in July 2010, increasing by 35,549 (+1.3%) over June 2010. Food Stamps expenditures totaled \$431,500,277 in July 2010, increasing by approximately \$4.0 million (+0.9%) over the previous month.

## Supplemental Security Income

Supplemental Security Income: For July 2010, SSI recipients (including Mental Hygiene) totaled 676,002 increasing by 9,282 (+1.4 %) from the previous month. SSI expenditures in July 2010 totaled \$379,079,245 increasing by approximately \$3.2 million (+0.8%) from June 2010.

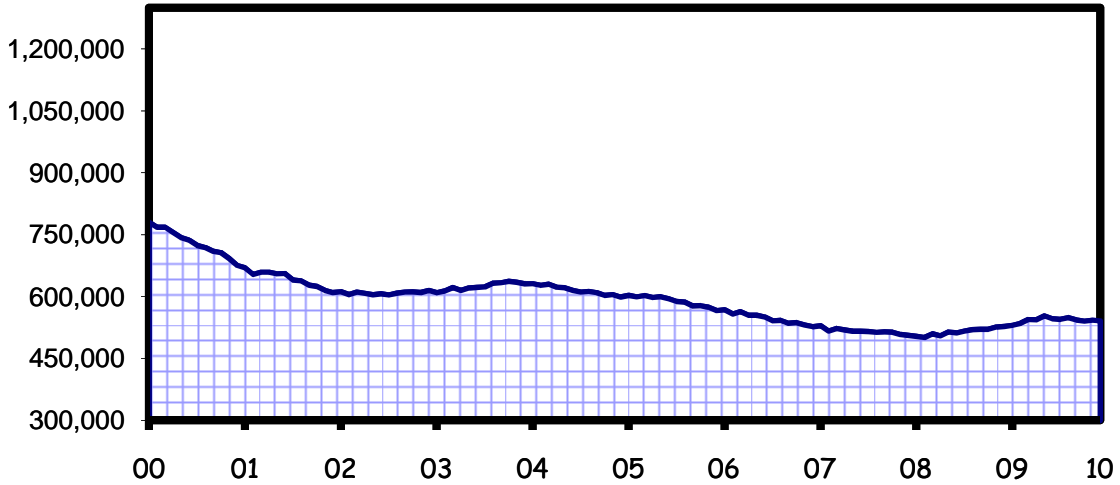

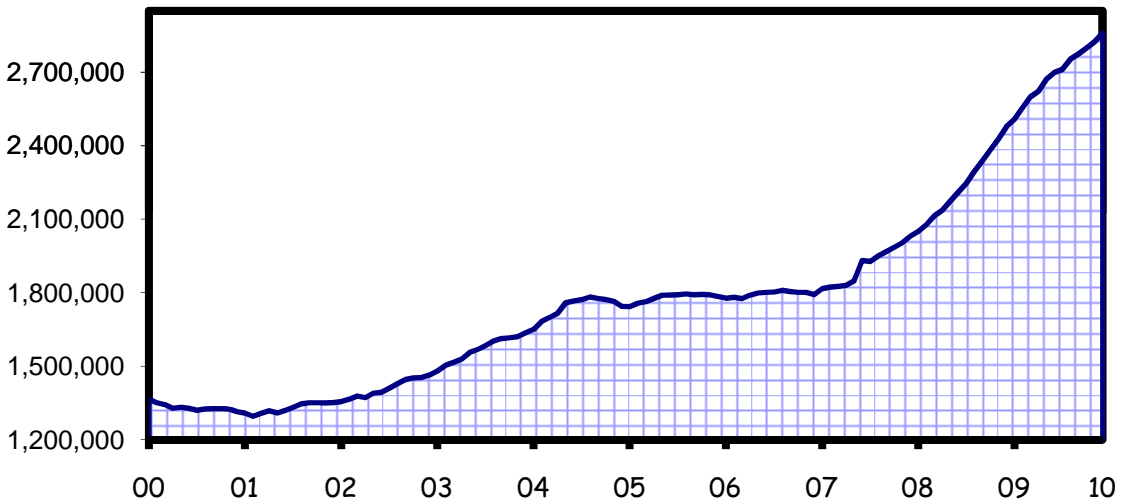

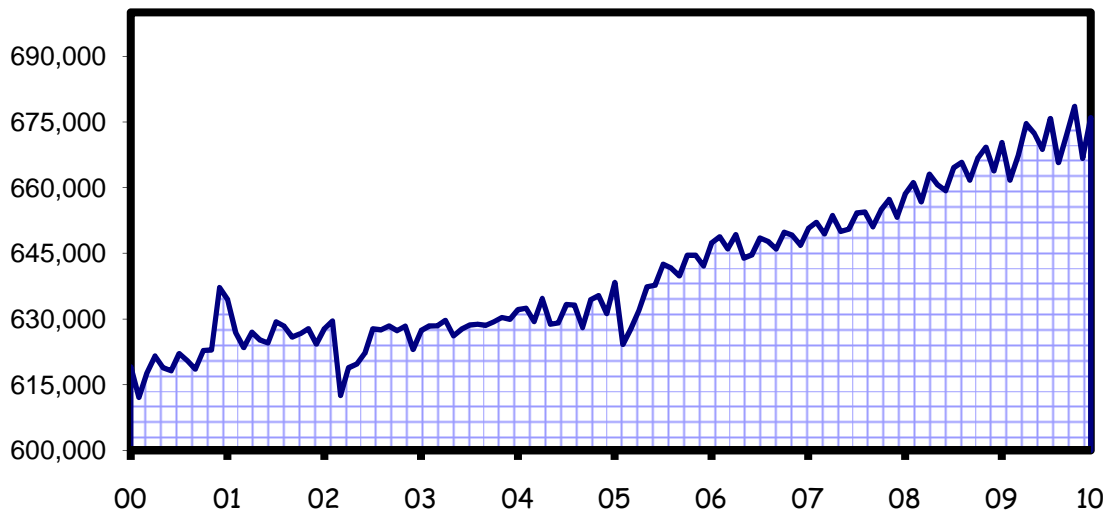
