Temporary and Disability Assistance Statistics

OCTOBER 2010

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 553,634 in October 2010, increasing by 6,042 (+1.1%) from the previous month. Related expenditures totaled \$178,156,624 in October 2010, increasing by approximately \$1.4 million (+0.8%) over September 2010.

Food Stamps

Food Stamps: Recipients of Food Stamps numbered 2,918,849 in October 2010, increasing by 22,854 (+0.8%) over September 2010. Food Stamps expenditures totaled \$441,526,830 in October 2010, increasing by approximately \$3.6 million (+0.8%) over the previous month.

Supplemental Security Income

Supplemental Security Income: For October 2010, SSI recipients (including Mental Hygiene) totaled 680,798 increasing by 5,895 (+0.9%) from the previous month. SSI expenditures in October 2010 totaled \$381,976,599 increasing by approximately \$3.1 million (+0.8%) from September 2010.

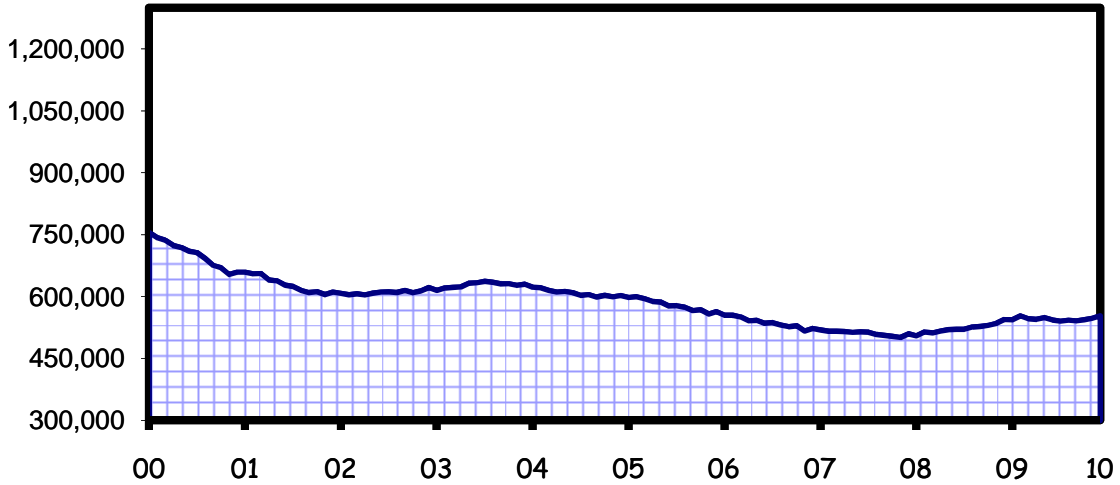

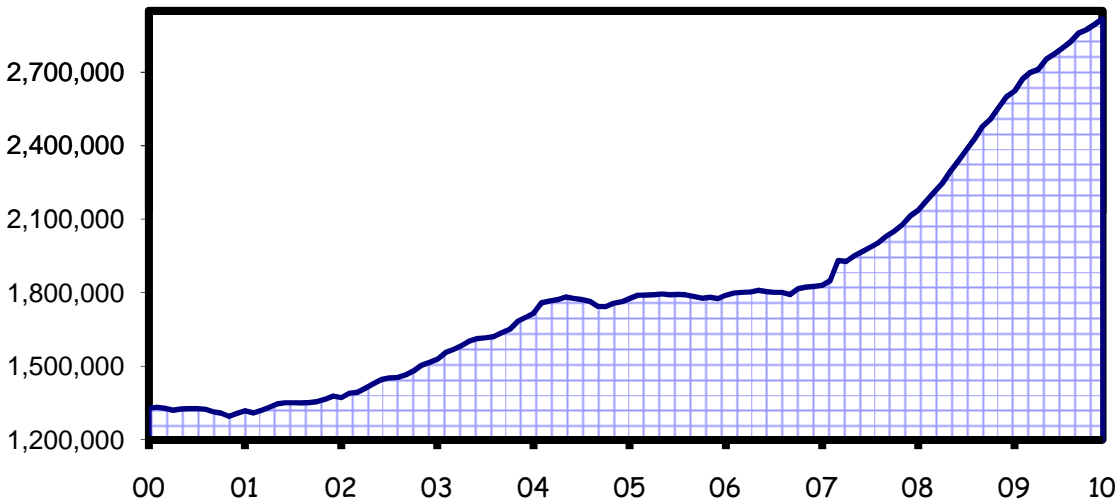

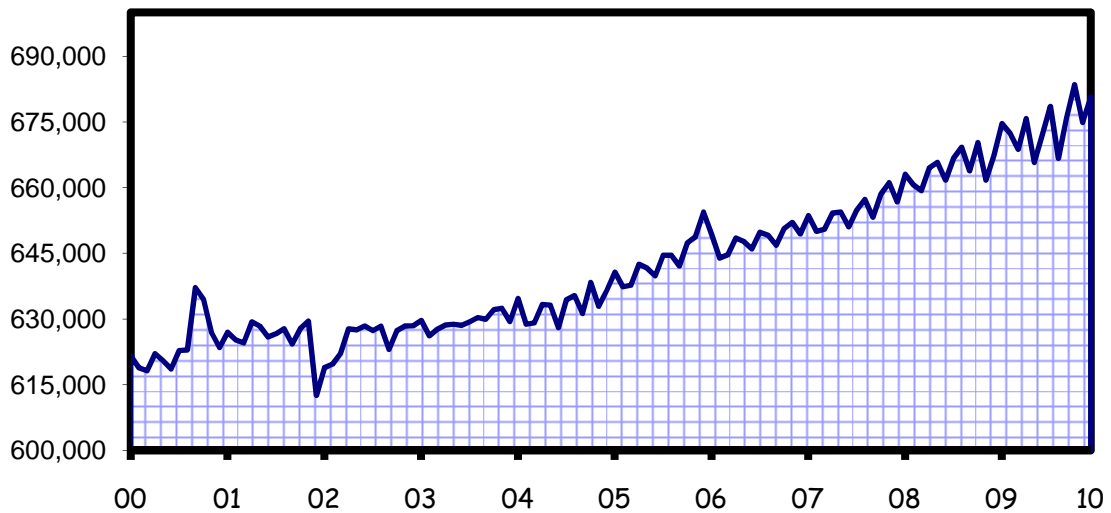
