# Temporary and Disability Assistance Statistics **DECEMBER 2010**

---

## Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 559,746 in December 2010, increasing by 2,872 (+0.5%) from the previous month. Related expenditures totaled \$177,825,511 in December 2010, increasing by approximately \$1.7 million (+0.9%) over November 2010.

## Food Stamps

Food Stamps: Food Stamps recipients totaled 2,969,868 in December 2010, increasing by 35,375 (+1.2%) over November 2010. Food Stamps expenditures totaled \$448,654,644 in December 2010, increasing by approximately \$5.3 million (+1.2%) over the previous month.

## Supplemental Security Income

Supplemental Security Income: For December 2010, SSI recipients (including Mental Hygiene) totaled 672,857 decreasing by 14,943 (-2.2%) from the previous month. SSI expenditures in December 2010 totaled \$379,348,030 decreasing by approximately \$12.5 million (-3.2%) from November 2010.

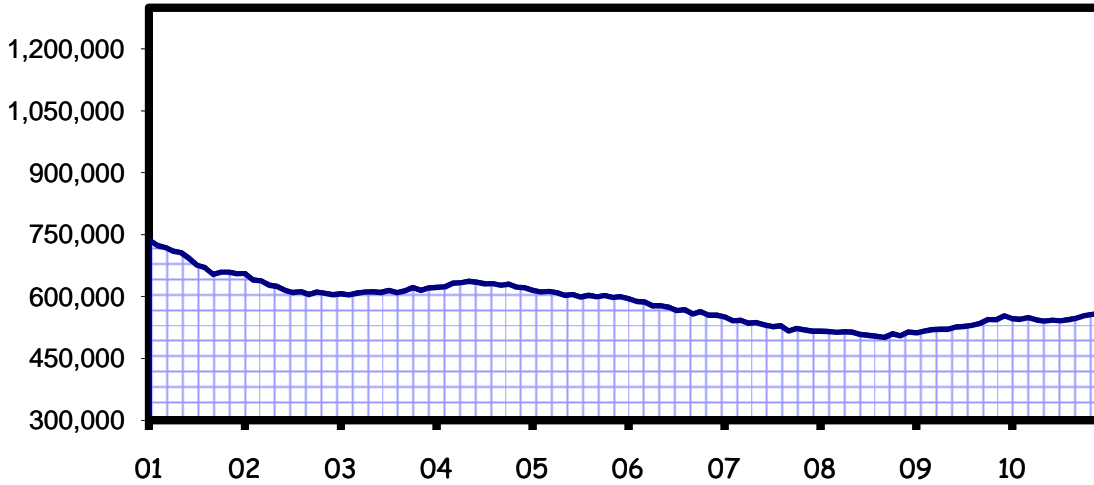

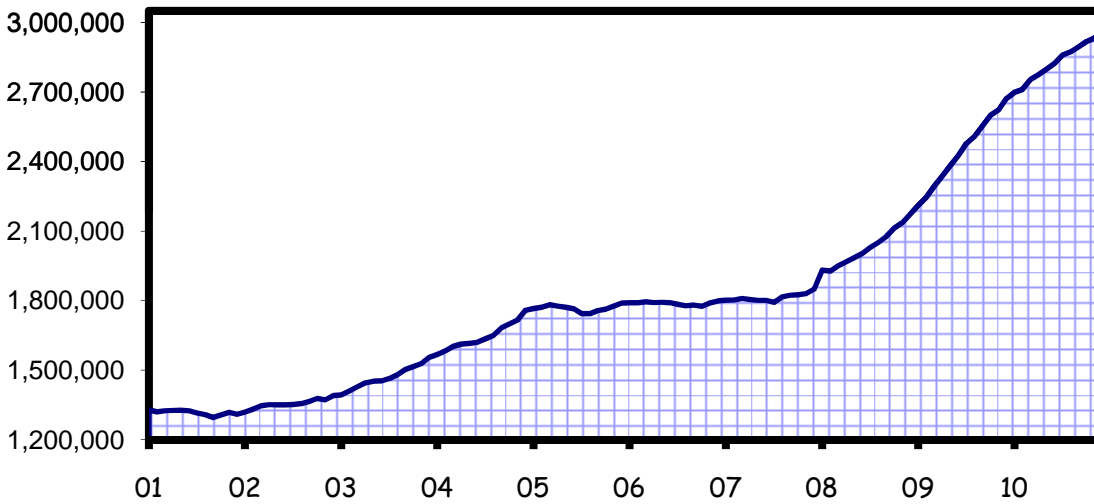

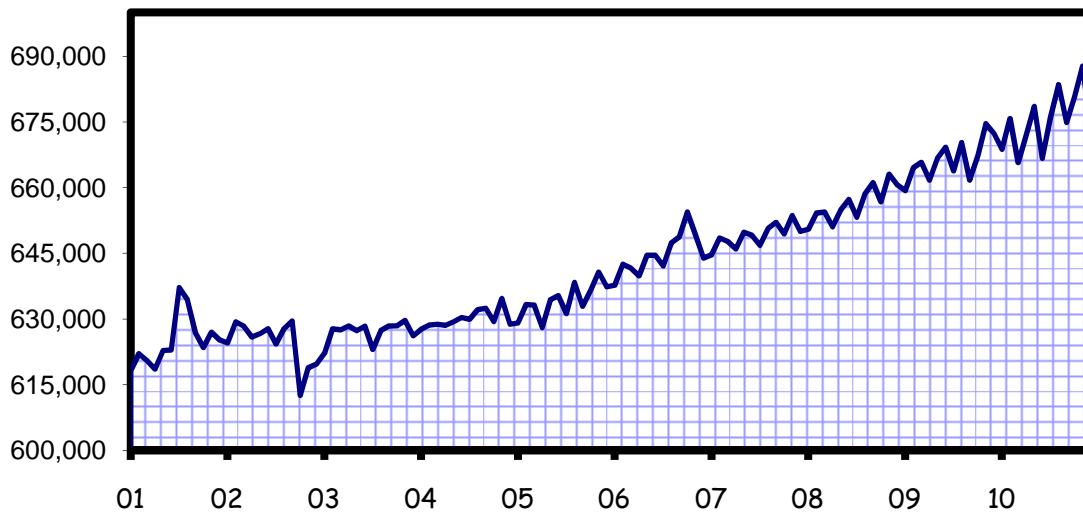

**Beginning in January 2010, New York City Family Assistance (FA) case, recipient and expenditure counts no longer include Emergency Assistance for Families (EAF), as had been previous practice. Therefore, the 2010 to 2009 comparison Tables A-1 and A-2 will underestimate year-to-year increases, and overestimate decreases, in total Temporary Assistance for New York City and thus New York State. Similar caution should be used when comparing New York City and New York State total Temporary Assistance and FA numbers in Tables A-5, A-6 and A-8 to previous years.**
