Temporary and Disability Assistance Statistics **JANUARY 2011**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 559,452 in January 2011, decreasing by 294 (-0.1%) from the previous month. Related expenditures totaled \$175,190,568 in January 2011, decreasing by approximately \$2.6 million (-1.5%) over December 2010.

Food Stamps

Food Stamps: Food Stamps recipients totaled 2,971,876 in January 2011, increasing by 2,008 (+0.1%) over December 2010. Food Stamps expenditures totaled \$446,639,407 in January 2011, decreasing by approximately \$2.0 million (-0.4%) over December 2010.

Supplemental Security Income

Supplemental Security Income: For January 2011, SSI recipients (including Mental Hygiene) totaled 683,514 increasing by 10,657 (+1.6%) from the previous month. SSI expenditures in January 2011 totaled \$382,522,322 increasing by approximately \$3.2 million (+0.8%) over December 2010.

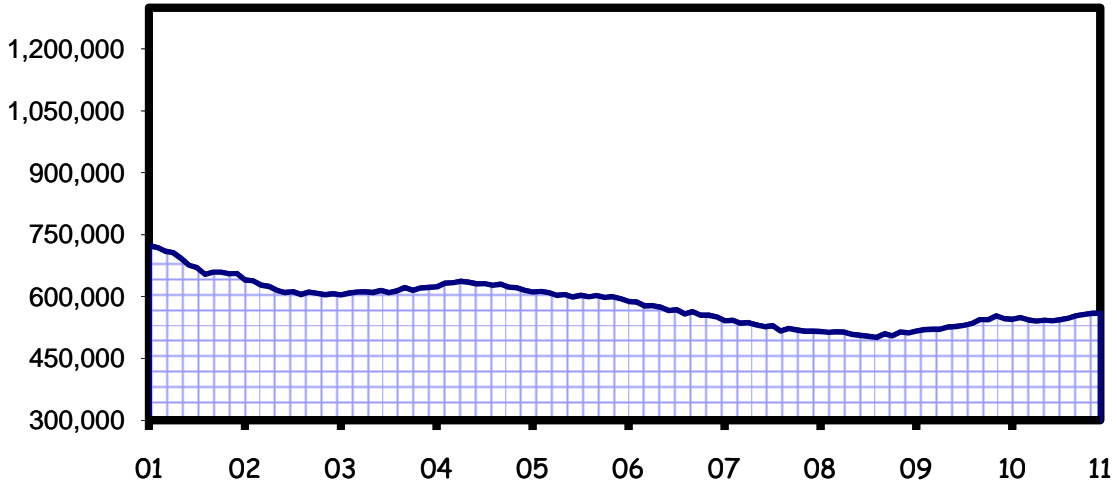

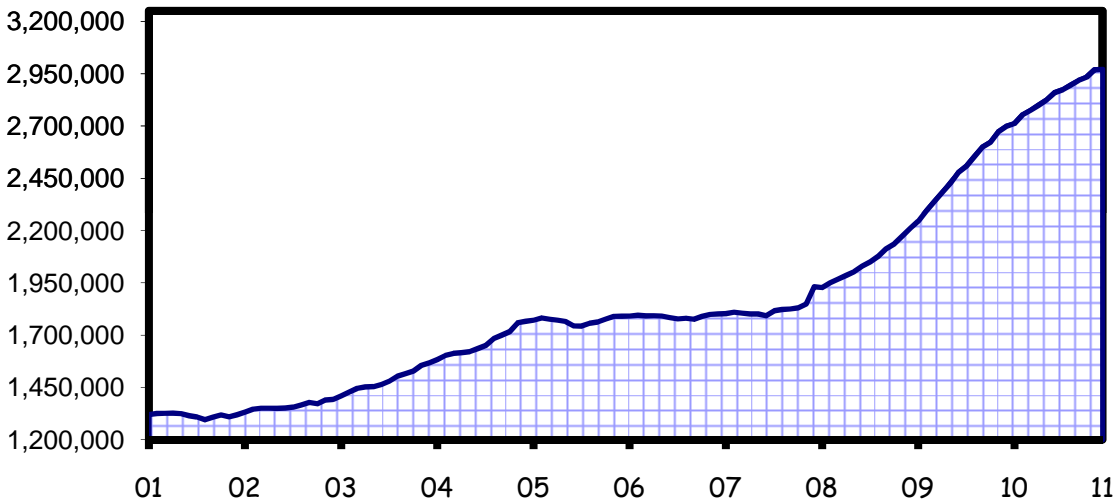

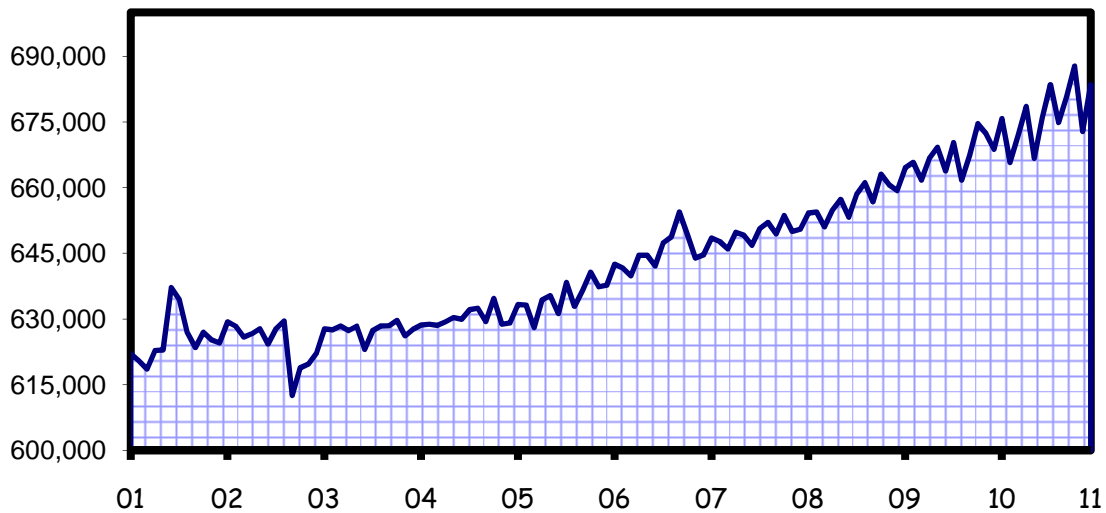


FOOD STAMPS RECIPIENTS
