JUNE 2011

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 570,249 in June 2011, increasing by 2,487 (+0.4%) from the previous month. Related expenditures totaled \$178,807,682 in June 2011, increasing by approximately \$3.3 million (+1.9%) over May 2011.

Food Stamps

Food Stamps: Food Stamp recipients totaled 3,035,825 in June 2011, increasing by 15,844 (+0.5%) from the previous month. Food Stamp expenditures totaled \$450,647,199 in June 2011, increasing by approximately \$1.8 million (+0.4%) over May 2011.

Supplemental Security Income

Supplemental Security Income: For June 2011, SSI recipients (including Mental Hygiene) totaled 692,429, increasing by 978 (+0.1%) from the previous month. SSI expenditures in June 2011 totaled \$390,044,423, decreasing by approximately \$3.2 million (-0.8%) over May 2011.

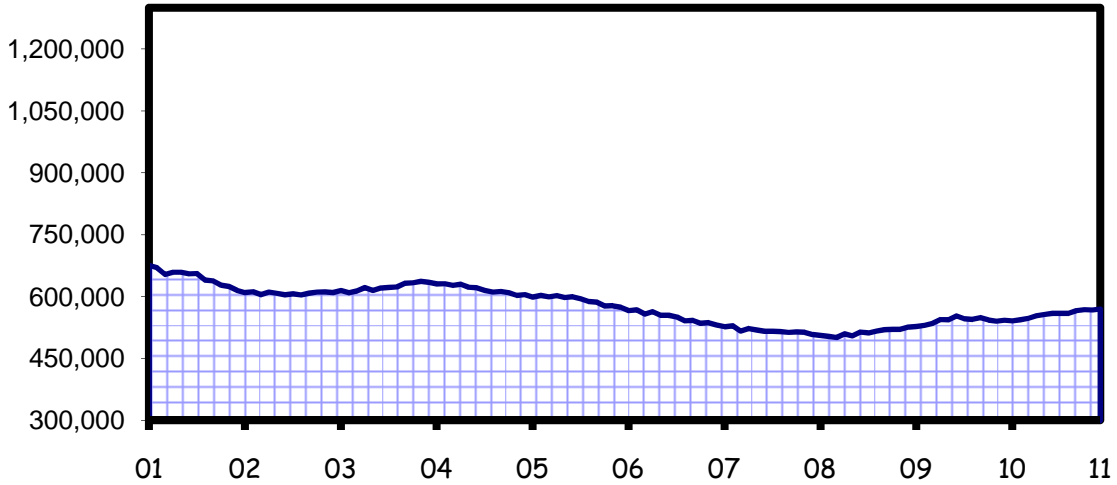

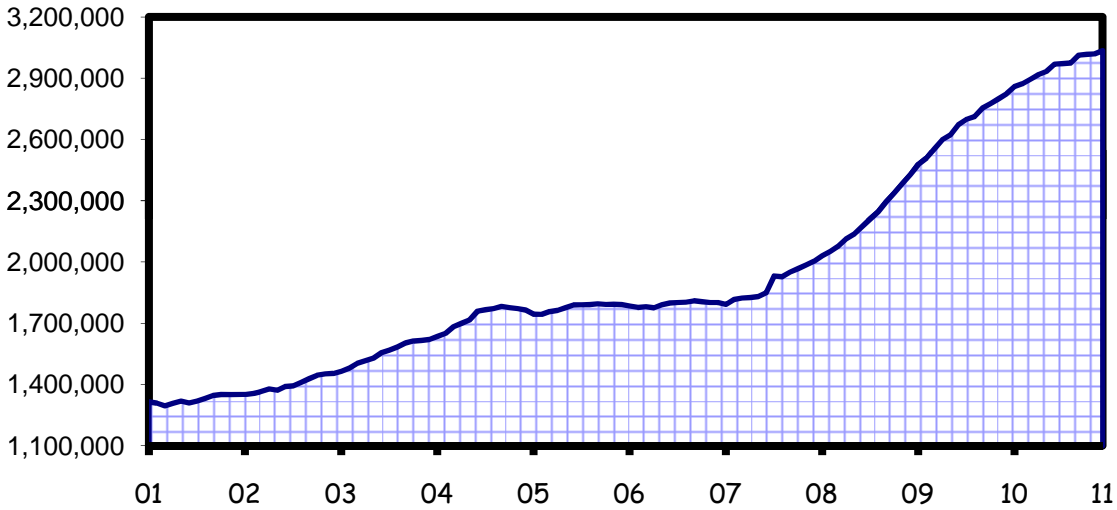

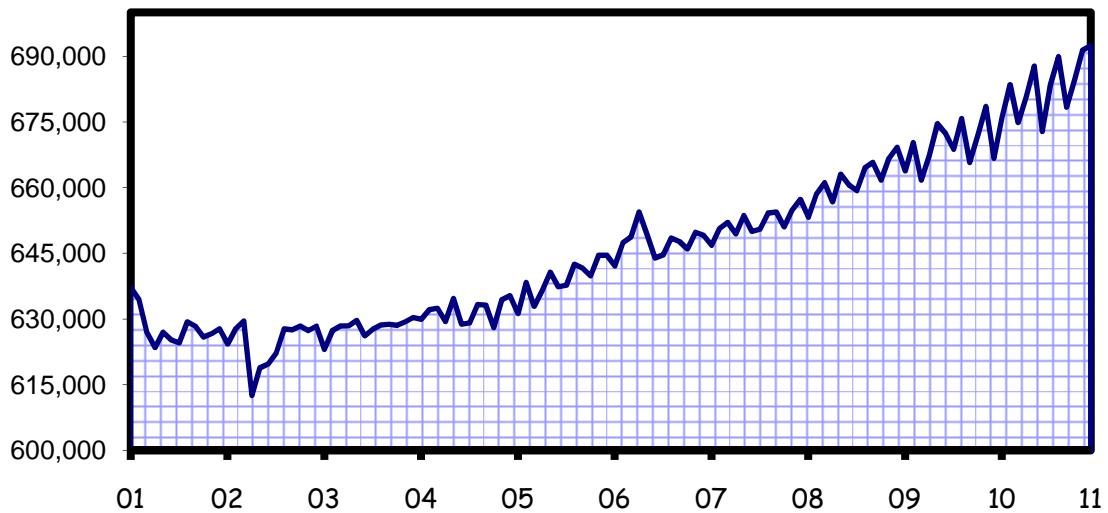
