Temporary and Disability Assistance Statistics **SEPTEMBER 2011**

Temporary Assistance

Temporary Assistance: Temporary Assistance recipients totaled 561,566 in September 2011, decreasing by 5,331 (-0.9%) from the previous month. Related expenditures totaled \$172,041,653 in September 2011, decreasing by approximately \$4.1 million (-2.3%) over August 2011.

Food Stamps

Food Stamps: Food Stamp recipients totaled 3,057,767 in September 2011, increasing by 17,083 (+0.6%) from the previous month. Food Stamp expenditures totaled \$460,091,568 in September 2011, increasing by approximately 7.4 million (+1.6%) over August 2011.

Supplemental Security Income

Supplemental Security Income: For September 2011, SSI recipients (including Mental Hygiene) totaled 685,055 decreasing by 9,107 (-1.3%) from the previous month. SSI expenditures in September 2011 totaled \$380,335,879 decreasing by approximately \$12.9 million (-3.3%) over August 2011.

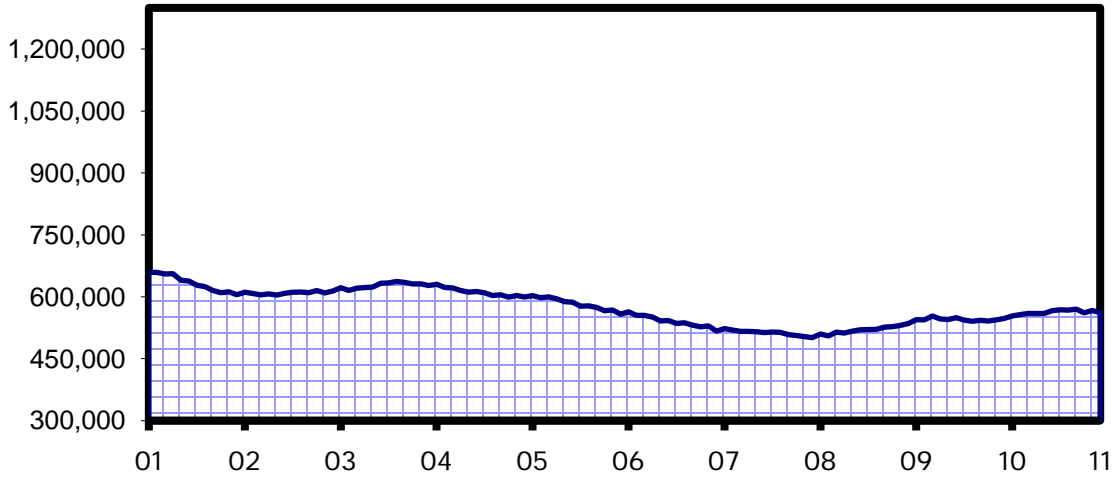

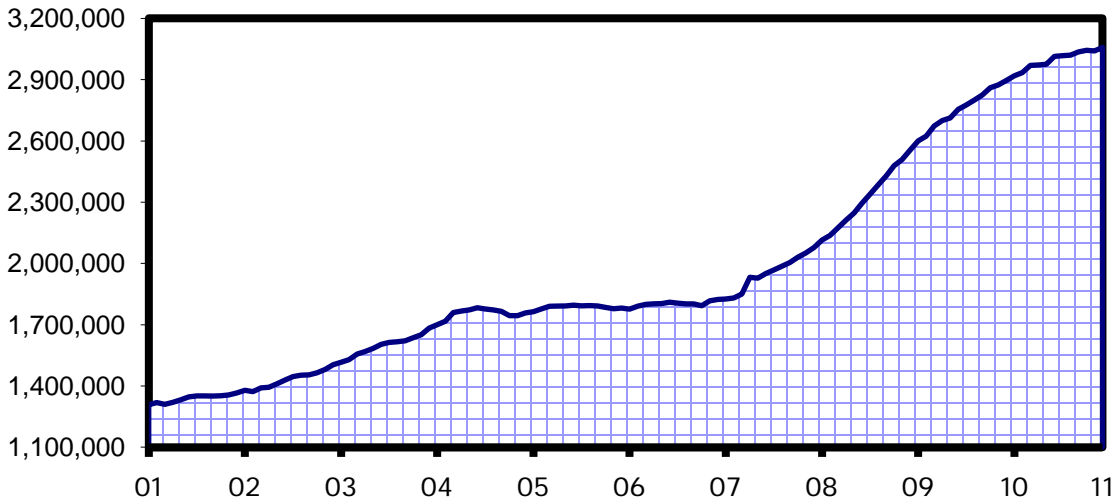

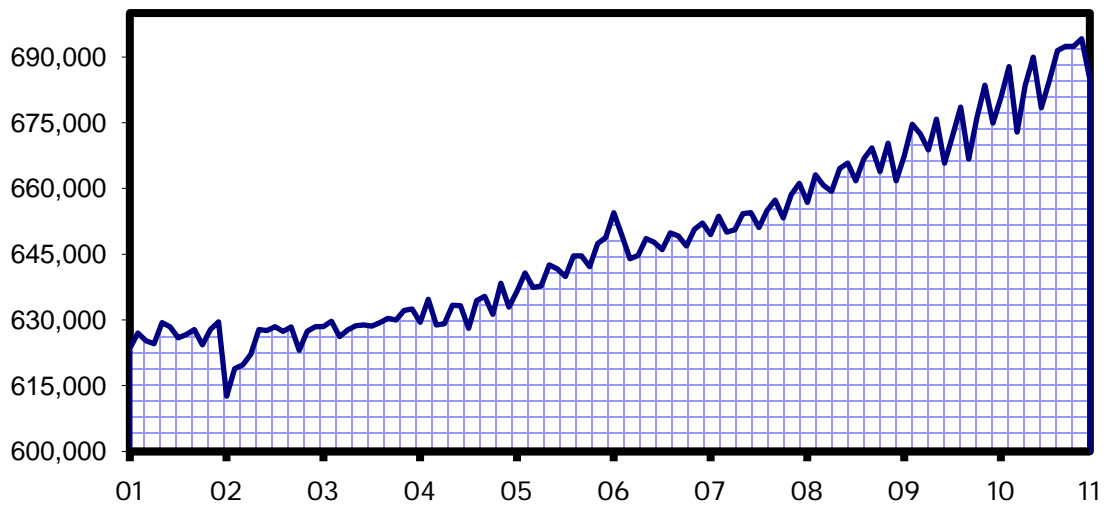
